1            AN ACT Relating to physician assistants executing certain  
2 certificates and other forms for labor and industries; adding a new  
3 section to chapter 51.28 RCW; creating a new section; providing an  
4 effective date; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6            NEW SECTION.    **Sec. 1.** A new section is added to chapter 51.28 RCW  
7 to read as follows:

8            The department shall accept the signature of a physician assistant  
9 on any certificate, card, form, or other documentation required by the  
10 department that the physician assistant's supervising physician or  
11 physicians may sign, provided that it is within the physician  
12 assistant's scope of practice, and is consistent with the terms of the  
13 physician assistant's practice arrangement plan as required by chapters  
14 18.57A and 18.71A RCW. Consistent with the terms of this section, the  
15 authority of a physician assistant to sign such certificates, cards,  
16 forms, or other documentation includes, but is not limited to, the  
17 execution of the certificate required in RCW 51.28.020. A physician  
18 assistant may not rate a worker's permanent partial disability under  
19 RCW 51.32.055.

1        NEW SECTION.   **Sec. 2.**   By December 1, 2008, the department of labor  
2 and industries shall report to the legislature on implementation of  
3 this act, including but not limited to the effects of this act on  
4 injured worker outcomes, claim costs, and disputed claims.

5        NEW SECTION.   **Sec. 3.**   This act is necessary for the immediate  
6 preservation of the public peace, health, or safety, or support of the  
7 state government and its existing public institutions, and takes effect  
8 July 1, 2007.
