## Changes to this Report

Since 1990, the Department of Health has issued an annual report, *Charity Care in Washington Hospitals*, as directed by Chapter 70.170 of the Revised Code of Washington (RCW). Since 2003, we released the charity care report up to 24 months after all hospital financial reports were due (June 30 each year).

In January of 2013, we began a quality improvement project to create a stable, efficient, and more timely data reporting process to better meet customer needs. We gained a clear understanding of what people want by surveying our customers about their needs; we surveyed data users, conducted stakeholder interviews, and reviewed the requirements for the report in RCW 70.170.060.

This report reflects the initial conclusions of the improvement project. Tables that our survey respondents told us were most useful are included in the report, and tables that were used less frequently have been moved to our website. Timeliness of reporting has been a major focus of this project. The 2011 report was released 21 months after all hospital data were due. This 2012 report is being released 11 months after all hospital data were due. We plan to post the 2013 charity care report to our website by the end of January 2015, six months after data from all hospitals are due. Data tables will be updated quarterly online.

## Background

Charity care is necessary hospital care provided to people who are indigent and unable to pay for the services. Hospitals are required to report annually the total charges for charity care and bad debt to the Department of Health within 180 days of the close of the hospital's fiscal year. These data are reported as part of the hospital's year-end financial report. Hospitals also provide an estimate of expected charity care to be provided in the upcoming fiscal year in their annual budget submittal.

## Definitions

**Adjusted Revenue:** Adjusted revenue subtracts Medicare and Medicaid charges from total patient care revenue to allow meaningful comparisons of charity care provided among hospitals. The Centers for Medicare and Medicaid Services (CMS) prohibits hospitals from billing patients for the difference between the billed charges and the Medicare or Medicaid set payment levels. Therefore patients covered by Medicare or Medicaid cannot be charity care patients. The proportion of patients covered by Medicare or Medicaid varies widely among hospitals. The use of adjusted revenue allows for a comparison of hospital charity care as a percent of privately sponsored patient revenue.

**Bad debt:** Charity care is distinct from bad debt, which is defined as uncollectible amounts, excluding contractual adjustments, arising from failure to pay by patients whose care has not been classified as charity care.

**Charity Care:** Charity care is defined in Chapter 70.170 RCW as the "necessary inpatient and outpatient hospital health care rendered to indigent persons." Chapter 70.170 RCW prohibits any Washington hospital from denying patients access to care based on inability to pay or adopting admission policies which significantly reduce charity care.

**Federal Poverty Guidelines:** The [federal poverty guidelines for all 48 contiguous states and the District of Columbia](#) go into effect on the day they are published, usually in late January.

**Indigent Persons:** A person is considered indigent according to Washington Administrative Code (WAC) 246-453-040, if their family income is at or below 200 percent of the federal poverty level.

**Operating Margin:** Operating margin is the percent of operating revenue remaining after operating expenses are subtracted. Billed charges are the sum of charges from the hospital standard price sheet and are not adjusted by insurance deductions or actual cost of the services.

**Uncompensated Care:** [Uncompensated care includes charity care and bad debt](#) and is reported by the American Hospital Association (AHA). Nationally comparable data on charity care are not available. In this report, we compare data on uncompensated care in Washington to national data on uncompensated care as reported by AHA.

## Data Available on Charity Care

This report describes data collected from licensed Washington hospitals for their fiscal years (FY) ending in 2012. Among these hospitals there are six different fiscal calendars. As a result, the data cannot be provided on the basis of the calendar year. Information contained in this report for FY 2012 includes data that pertain to the fiscal year that ended March 31, April 30, June 30, September 30, October 31, or December 31, 2012, according to each hospital's fiscal calendar. ## Limitations

**Hospital Reporting.** All charity care data for FY 2012 were due to the department by June 30, 2013. For 2012, 88 of 96 hospitals had reported charity care information in year-end financial reports by the time of this report's publication. For three hospitals, we have provided estimates based on their quarterly financial reports. For the final five hospitals, no charity care data are currently available.

**Lack of National Charity Care Data for Comparison.** There is no national community hospital charity care policy or requirement, and no nationally comparable data. The federal [Emergency Medical Treatment and Labor Act](#) ensures public access to emergency services regardless of ability to pay. Washington's charity care law is much broader than the Emergency Medical Training and Labor Act and includes non-emergency and non-labor medical care as eligible for charity care.

**Exclusions.** Group Health hospitals aren't included in this report because health care charges are prepaid through member subscriptions; therefore, uncompensated health care is generally not incurred. State-owned psychiatric hospitals, federal Veterans Affairs hospitals, and federal military hospitals are also excluded.

## **Washington State Charity Care Data**

### **Statewide Charity Care Charges**

Overall, Washington hospitals reported \$1.3 billion in charity care charges in FY 2012. These charges amounted to 2.9 percent of total hospital revenue and 6.2 percent of adjusted (non-Medicare, non-Medicaid) revenue.




*Figure 1 Notes: Adjusted revenue is the total hospital revenue minus Medicare and Medicaid charges.*

Over the past 10 years (2003-2012), statewide charity care charges have increased by 485 percent while statewide hospital total revenue has increased by 170 percent (Table 1). As a percent of total hospital revenue, charity care charges have increased from 1.3 percent to 2.9 percent during this 10-year time period (Table 1 and Figure 1).

### **Distribution of Charity Care Among Hospitals**

Charity care charges varied widely among hospitals, ranging from \$0 to \$210 million. Charges varied among hospitals in rural and urban areas and in different geographic areas of the state. These variations in charity care charges don't seem to be explained by population size; however, some of these variations may be affected by the proportion of hospital revenue coming from Medicare and Medicaid.

Differences in charity care charges among hospitals may reflect demographic differences in the hospital service areas as well as differences in charity care practices within the hospital. A high level of reported charity care, for example, may reflect greater need for charity care in the community. Likewise, a low level of charity care may reflect a relative absence of need for charity care in a hospital's service area.

### **Contribution of all Purchasers of Care to Hospital Charity Care**


Charity care charges as a percent of adjusted (non-Medicare, non-Medicaid) revenue have increased from 2.2 percent to 6.2 percent from FY 2002 through FY 2012. Throughout this time, fluctuations in statewide operating margin, which is a measure of hospital profitability, do not appear to have adversely affected the amount of charity care provided in Washington (Table 1). Because the amount of charity care as a percent of adjusted revenue has increased more than the amount of charity care as a percent of total revenue, we can infer that purchasers other than Medicare and Medicaid (commercial insurance, other governmental payers such as Veterans Affairs and Labor and Industries, and self-insured patients) are bearing an increasing proportion of the cost of providing free and discounted care.

## Uncompensated Care in Washington

Uncompensated care includes bad debt and charity care. Considering the components of uncompensated care separately, both charity care and bad-debt charges appear to have been increasing over the past 10 years. In recent years, charity care seems to be rising faster than bad debt (Figure 2). Both have more than doubled since FY 2005.

**Figure 2.** Hospital Charity Care and Bad Debt Charges in Washington, Fiscal Year 2002 - 2012




### Washington compared to the United States: Uncompensated care

No national charity care data are available with which to draw comparisons between Washington and the US. However, national data are available for uncompensated care, which includes both charity care and bad debt.

Uncompensated care as a percent of hospital expenses is lower in Washington than it is in the U.S. as a whole (Figure 3). In the U.S., uncompensated care has remained relatively steady over the past 10 years and was 6.1 percent of hospital expenses in FY 2012. By contrast, uncompensated care in Washington increased between FY 2002 and FY 2004, after which it appeared to level off, reaching 4.9 percent of hospital expenses in FY 2012 (Figure 3).
