EXPANDED COMMUNITY SERVICES PROVISIO FOURTH QUARTER – APRIL THROUGH JUNE 2010

Chapter 564, Laws of 2009, Section 205(1)(d)

August 15, 2010

The 2009-11 Biennial Budget provided funds for 60 new Expanded Community Services clients at an average daily rate of \$300. As of March 31, 2010, there have been 64 individuals added to this proviso at an average daily rate of \$281.75.

Chapter 564, Laws of 2009, Section 205(1) (d) requires the Department of Social and Health Services' Division of Developmental Disabilities (DDD) to report within 45 days following each fiscal year quarter, the number of persons served with these additional community services, where they were residing, what kinds of services they were receiving prior to placement, and the actual expenditures for all community services to support these clients. Funding will be prioritized for: 1) residents of Residential Habilitation Centers (RHCs) who are able to be adequately cared for in community settings and who choose to live in those community settings; 2) clients without residential services who are in crisis or immediate risk of needing an institutional placement; 3) children who are at risk of institutionalization or aging out of other state services; and 4) current home and community-based waiver program clients who have been assessed as having an immediate need for increased services.
