
RE: Section 603 – Fund Transfers (Engrossed Substitute House Bill 2190)

Dear Representative Clibborn, Senator Haugen, and Director Marshburn:

Section 603(1)(g) of Engrossed Substitute House Bill 2190 authorizes the department to make transfers between projects if the amount being transferred does not exceed \$250,000 or 10 percent of the total project cost. Furthermore, any transfers made are to be reported quarterly to the Director of Financial Management, and the Chairs of the Legislative Transportation Committees.
