Introduction

RCW 71.09.325(4) directs the Department of Social and Health Services (DSHS), on an annual basis, to compile information in writing on all violations of court-ordered conditions of release committed by all civilly committed sex offenders who are living in less restrictive alternative (LRA) settings. In addition, the department is required to report any penalties and actions taken by the department to remove a person from an LRA setting. The report is issued on an annual basis to the Office of Financial Management and the appropriate committees of the legislature.

This report addresses violations that occurred between September 1, 2019 and September 30, 2020. It also provides a status report on any violations that were addressed in a previous annual report but were not resolved before the report was submitted.

The Special Commitment Center (SCC) and the transition treatment teams closely monitor the treatment progress and activity of residents who have court-ordered conditional releases. When early warning signs of potential problems occur, consideration is given to take the person into custody and return them to the SCC Total Confinement Facility (TCF) for evaluation and recommended action to the court of commitment.

A resident that has been returned to custody for evaluation and recommended action still receives a final order from the court of commitment. The judge that oversees the case can remands the resident to the total confinement facility, re-release them to their original LRA, or re-release them to a differing LRA.

Definitions

For the purpose of this report, the following definitions from the SCC policies are used.

Less Restrictive Alternative (LRA). Court-ordered treatment in a setting less restrictive than total confinement that satisfies the conditions set forth in RCW 71.09.092. LRAs include private homes, secure community transition facilities (SCTF), and other court-authorized settings including contracted residential settings with twenty-four hour staffing.

Secure Community Transition Facility (SCTF). A residential facility for persons conditionally released to a less restrictive alternative, including the SCTF in Pierce County on McNeil Island, the SCTF in King County and any community-based facilities established under Chapter 71.09 RCW and operated by or under contract with DSHS.

Private Home. The conditional released resident's own home or the home of a family member or other person that the court of commitment has approved as a less restrictive alternative placement (LRA).

General Violation. Failure to comply with a condition of release set by the court of commitment, by DSHS, or by the Department of Corrections (DOC). A general violation may include a resident's failure to comply with a treatment plan requirement, posting, written instruction or verbal instruction given by an authorized person. A general violation is distinct from a serious violation.

Serious Violation. A violation by an LRA resident that includes but is not limited to the commission of any criminal offense, any unlawful use or possession of alcohol or a controlled substance, or any violation of a court-ordered conditions, which targets the individual's documented pattern of offense that increases the risk to public safety. For purposes of this SCC policy, an accumulation of failure to comply with treatment plan requirements or with rules, infractions of rules, or any behavior that, in the judgement of the SCC CEO, represents a risk to public safety may be considered a serious violation.

Current Status

During the period of September 2019 to September 2020, there have been fourteen residents revoked from LRA placement.

From September 2019 to September 2020 there were ninety-six residents in courtordered LRA settings. Eleven of the ninety-six residents that were in LRA settings unconditionally released before September 30, 2020. We also currently have ten residents that have been returned and remain at the SCC Total Confinement Facility on McNeil due to serious violations of their LRA conditions.

Sixty-two residents of the original ninety-six total residents on LRA status during this time had at least one violation.

There were 60 serious violations and 192 general violations from September 2019-September 2020. Some of the violations actually fall under more than one category of violation.

Sixteen residents have been returned to SCC during this period – many have been rereleased back onto LRA with additional restrictions and conditions imposed by the court of commitment.

Serious Violation Explanation

RCW 71.09.325 (1) any conditionally released person who commits a serious violation of conditions shall be returned to the Special Commitment Center, unless arrested by a law enforcement officer, and the court shall be notified immediately and shall initiate proceedings under RCW 71.09.098.

If an action occurs and a resident is returned to the TCF, a court hearing is requested to determine if the resident will be revoked or returned to the community.

Service Providers

During this reporting period, there were no sanctions issued to service providers.

Violations

Per RCW 71.09 (4) DSHS must document all violations, penalties and actions.

Residents may have multiple violations, which is noted by (-) in the following columns.

*NOTE: Violating court order terms does not always negate the need for SCC to continue paying stipends or for residents rent. Each resident has variations in their court order that allow or limit the Special Commitment Center from refusing to pay expenses while a resident resides on island.

We categorize our violations based on type:

- Failure to follow GPS Guidelines
- Failure to follow Directives
- Misuse of Phone
- Failure to follow Travel Itinerary and Guidelines
- Failure to follow Treatment
- Unapproved Contact
- Failure to follow Internet/Computer Guidelines
- Other these are categorized as technical violations of the court order that may be beyond a resident's control (i.e. an SOTP provider retiring suddenly or losing housing due to circumstances).

Figure 1. General Violations





Figure 2. Serious Violations
