1            AN ACT Relating to collective bargaining for employees of the  
2 Washington state bar association; amending RCW 41.56.020; and repealing  
3 1993 c 76 s 1 (uncodified).

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            **Sec. 1.** RCW 41.56.020 and 1993 c 76 s 2 are each amended to read  
6 as follows:

7            This chapter shall apply to any county or municipal corporation, or  
8 any political subdivision of the state of Washington, including  
9 district courts and superior courts, except as otherwise provided by  
10 RCW 54.04.170, 54.04.180, and chapters 41.59, 47.64, and 53.18 RCW.  
11 The Washington state patrol shall be considered a public employer of  
12 state patrol officers appointed under RCW 43.43.020. The Washington  
13 state (~~supreme court may provide by rule that the Washington state~~)  
14 bar association shall be considered a public employer of its employees.

15            NEW SECTION.    **Sec. 2.** 1993 c 76 s 1 (uncodified) is repealed.
