1 Strike everything after the enacting clause and insert the
2 following:

3 "Sec. 1. RCW 48.02.060 and 1947 c 79 s .02.06 are each amended to
4 read as follows:

5 (1) The commissioner (~~((shall have))~~) has the authority expressly
6 conferred upon him or her by or reasonably implied from the provisions
7 of this code.

8 (2) The commissioner shall execute his or her duties and shall
9 enforce the provisions of this code.

10 (3) The commissioner may:

11 (a) Make reasonable rules (~~((and regulations))~~) for effectuating any
12 provision of this code, except those relating to his or her election,
13 qualifications, or compensation. (~~((No such))~~) Rules (~~((and regulations~~
14 ~~shall be))~~) are not effective prior to their being filed for public
15 inspection in the commissioner's office.

16 (b) Conduct investigations to determine whether any person has
17 violated any provision of this code.

18 (c) Conduct examinations, investigations, hearings, in addition to
19 those specifically provided for, useful and proper for the efficient
20 administration of any provision of this code.

21 (4) When the governor proclaims a state of emergency under RCW
22 43.06.010(12), the commissioner may issue an order that addresses any
23 or all of the following matters related to insurance policies issued in
24 this state:

25 (a) Reporting requirements for claims;

26 (b) Grace periods for payment of insurance premiums and performance
27 of other duties by insureds;

28 (c) Temporary postponement of cancellations and renewals; and

29 (d) Medical coverage to ensure access to care.

1 (5) An order by the commissioner under subsection (4) of this
2 section may remain effective for not more than sixty days unless the
3 commissioner extends the termination date for the order for an
4 additional period of not more than thirty days. The commissioner may
5 extend the order if, in the commissioner's judgment, the circumstances
6 warrant an extension. An order of the commissioner under subsection
7 (4) of this section is not effective after the related state of
8 emergency is terminated by proclamation of the governor under RCW
9 43.06.210. The order must specify, by line of insurance:

10 (a) The geographic areas in which the order applies, which must be
11 within but may be less extensive than the geographic area specified in
12 the governor's proclamation of a state of emergency and must be
13 specific according to an appropriate means of delineation, such as the
14 United States postal service zip codes or other appropriate means; and

15 (b) The date on which the order becomes effective and the date on
16 which the order terminates.

17 (6) The commissioner may adopt rules that establish general
18 criteria for orders issued under subsection (4) of this section and may
19 adopt emergency rules applicable to a specific proclamation of a state
20 of emergency by the governor.

21 (7) The rule-making authority set forth in subsection (6) of this
22 section does not limit or affect the rule-making authority otherwise
23 granted to the commissioner by law."
