1 AN ACT Relating to accountability for persons driving under the
2 influence of intoxicating liquor or drugs; amending RCW 46.20.385,
3 46.20.391, 46.20.720, 46.61.5055, 46.20.410, 46.20.342, 46.20.740,
4 10.05.020, 10.05.090, and 10.05.160; adding a new section to chapter
5 46.61 RCW; prescribing penalties; and providing an effective date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 46.20.385 and 2008 c 282 s 9 are each amended to read
8 as follows:

9 (1)(a) Beginning January 1, 2009, any person licensed under this
10 chapter who is convicted of (~~any offense involving the use,~~
11 ~~consumption, or possession of alcohol while operating a motor vehicle~~
12 ~~in~~) a violation of RCW 46.61.502 or 46.61.504(, other than vehicular
13 homicide or vehicular assault) or an equivalent local or out-of-state
14 statute or ordinance, or a violation of RCW 46.61.520(1)(a) or
15 46.61.522(1)(b), or who has had or will have his or her license
16 suspended, revoked, or denied under RCW 46.20.3101, may submit to the
17 department an application for an ignition interlock driver's license.
18 The department, upon receipt of the prescribed fee and upon determining

1 that the petitioner is eligible to receive the license, may issue an
2 ignition interlock driver's license.

3 (b) A person may apply for an ignition interlock driver's license
4 anytime, including immediately after receiving the notices under RCW
5 46.20.308 or after his or her license is suspended, revoked, or denied.
6 A person receiving an ignition interlock driver's license waives his or
7 her right to a hearing or appeal under RCW 46.20.308.

8 (c) An applicant under this subsection shall provide proof to the
9 satisfaction of the department that a functioning ignition interlock
10 device has been installed on all vehicles operated by the person.

11 (i) The department shall require the person to maintain the device
12 on all vehicles operated by the person and shall restrict the person to
13 operating only vehicles equipped with the device, for the remainder of
14 the period of suspension, revocation, or denial. The installation of
15 an ignition interlock device is not necessary on vehicles owned,
16 leased, or rented by a person's employer and on those vehicles whose
17 care and/or maintenance is the temporary responsibility of the
18 employer, and driven at the direction of a person's employer as a
19 requirement of employment during working hours. The person must
20 provide the department with a declaration pursuant to RCW 9A.72.085
21 from his or her employer stating that the person's employment requires
22 the person to operate a vehicle owned by the employer or other persons
23 during working hours.

24 (ii) Subject to any periodic renewal requirements established by
25 the department under this section and subject to any applicable
26 compliance requirements under this chapter or other law, an ignition
27 interlock driver's license granted upon a suspension or revocation
28 under RCW 46.61.5055 or 46.20.3101 extends through the remaining
29 portion of any concurrent or consecutive suspension or revocation that
30 may be imposed as the result of administrative action and criminal
31 conviction arising out of the same incident.

32 (iii) The time period during which the person is licensed under
33 this section shall apply on a day-for-day basis toward satisfying the
34 period of time the ignition interlock device restriction is required
35 under RCW 46.20.720 and 46.61.5055.

36 (2) An applicant for an ignition interlock driver's license who
37 qualifies under subsection (1) of this section is eligible to receive
38 a license only if((÷

1 ~~(a) Within seven years immediately preceding the date of the~~
2 ~~offense that gave rise to the present conviction or incident, the~~
3 ~~applicant has not committed vehicular homicide under RCW 46.61.520 or~~
4 ~~vehicular assault under RCW 46.61.522; and~~

5 ~~(b))~~ the applicant files satisfactory proof of financial
6 responsibility under chapter 46.29 RCW.

7 (3) Upon receipt of evidence that a holder of an ignition interlock
8 driver's license granted under this subsection no longer has a
9 functioning ignition interlock device installed on all vehicles
10 operated by the driver, the director shall give written notice by
11 first-class mail to the driver that the ignition interlock driver's
12 license shall be canceled. ~~((The effective date of cancellation shall~~
13 ~~be fifteen days from the date of mailing the notice.))~~ If at any time
14 before the cancellation goes into effect the driver submits evidence
15 that a functioning ignition interlock device has been installed on all
16 vehicles operated by the driver, the cancellation shall be stayed. If
17 the cancellation becomes effective, the driver may obtain, at no
18 additional charge, a new ignition interlock driver's license upon
19 submittal of evidence that a functioning ignition interlock device has
20 been installed on all vehicles operated by the driver.

21 (4) A person aggrieved by the decision of the department on the
22 application for an ignition interlock driver's license may request a
23 hearing as provided by rule of the department.

24 (5) The director shall cancel an ignition interlock driver's
25 license ~~((upon receipt of))~~ after receiving notice that the holder
26 thereof has been convicted of operating a motor vehicle in violation of
27 its restrictions, no longer meets the eligibility requirements, or
28 ~~((of))~~ has been convicted of or found to have committed a separate
29 offense or any other act or omission that under this chapter would
30 warrant suspension or revocation of a regular driver's license. The
31 department must give notice of the cancellation ~~((is effective as of~~
32 ~~the date of the conviction, and continues with the same force and~~
33 ~~effect as any suspension or revocation under this title))~~ as provided
34 under RCW 46.20.245. A person whose ignition interlock driver's
35 license has been canceled under this section may reapply for a new
36 ignition interlock driver's license if he or she is otherwise qualified
37 under this section and pays the fee required under RCW 46.20.380.

1 (6)(a) Unless costs are waived by the ignition interlock company or
2 the person is indigent under RCW 10.101.010, the applicant shall pay
3 the cost of installing, removing, and leasing the ignition interlock
4 device and shall pay an additional fee of twenty dollars per month.
5 Payments shall be made directly to the ignition interlock company. The
6 company shall remit the additional twenty-dollar fee to the department.

7 (b) The department shall deposit the proceeds of the twenty-dollar
8 fee into the ignition interlock device revolving account. Expenditures
9 from the account may be used only to administer and operate the
10 ignition interlock device revolving account program. The department
11 shall adopt rules to provide monetary assistance according to greatest
12 need and when funds are available.

13 (7) The department shall adopt rules to implement ignition
14 interlock licensing. The department shall consult with the
15 administrative office of the courts, the state patrol, the Washington
16 association of sheriffs and police chiefs, ignition interlock
17 companies, and any other organization or entity the department deems
18 appropriate.

19 **Sec. 2.** RCW 46.20.391 and 2008 c 282 s 6 are each amended to read
20 as follows:

21 (1) Any person licensed under this chapter who is convicted of an
22 offense relating to motor vehicles for which suspension or revocation
23 of the driver's license is mandatory, other than vehicular homicide,
24 vehicular assault, driving while under the influence of intoxicating
25 liquor or any drug, or being in actual physical control of a motor
26 vehicle while under the influence of intoxicating liquor or any drug,
27 may submit to the department an application for a temporary restricted
28 driver's license. The department, upon receipt of the prescribed fee
29 and upon determining that the petitioner is eligible to receive the
30 license, may issue a temporary restricted driver's license and may set
31 definite restrictions as provided in RCW 46.20.394.

32 (2)(a) A person licensed under this chapter whose driver's license
33 is suspended administratively due to failure to appear or pay a traffic
34 ticket under RCW 46.20.289; a violation of the financial responsibility
35 laws under chapter 46.29 RCW; or for multiple violations within a
36 specified period of time under RCW 46.20.291, may apply to the
37 department for an occupational driver's license.

1 (b) If the suspension is for failure to respond, pay, or comply
2 with a notice of traffic infraction or conviction, the applicant must
3 enter into a payment plan with the court.

4 (c) An occupational driver's license issued to an applicant
5 described in (a) of this subsection shall be valid for the period of
6 the suspension or revocation.

7 (3) An applicant for an occupational or temporary restricted
8 driver's license who qualifies under subsection (1) or (2) of this
9 section is eligible to receive such license only if:

10 (a) Within seven years immediately preceding the date of the
11 offense that gave rise to the present conviction or incident, the
12 applicant has not committed vehicular homicide under RCW 46.61.520 or
13 vehicular assault under RCW 46.61.522; and

14 (b) The applicant demonstrates that it is necessary for him or her
15 to operate a motor vehicle because he or she:

16 (i) Is engaged in an occupation or trade that makes it essential
17 that he or she operate a motor vehicle;

18 (ii) Is undergoing continuing health care or providing continuing
19 care to another who is dependent upon the applicant;

20 (iii) Is enrolled in an educational institution and pursuing a
21 course of study leading to a diploma, degree, or other certification of
22 successful educational completion;

23 (iv) Is undergoing substance abuse treatment or is participating in
24 meetings of a twelve-step group such as Alcoholics Anonymous that
25 requires the petitioner to drive to or from the treatment or meetings;

26 (v) Is fulfilling court-ordered community service responsibilities;

27 (vi) Is in a program that assists persons who are enrolled in a
28 WorkFirst program pursuant to chapter 74.08A RCW to become gainfully
29 employed and the program requires a driver's license;

30 (vii) Is in an apprenticeship, on-the-job training, or welfare-to-
31 work program; or

32 (viii) Presents evidence that he or she has applied for a position
33 in an apprenticeship or on-the-job training program for which a
34 driver's license is required to begin the program, provided that a
35 license granted under this provision shall be in effect for no longer
36 than fourteen days; and

37 (c) The applicant files satisfactory proof of financial
38 responsibility under chapter 46.29 RCW; and

1 (d) Upon receipt of evidence that a holder of an occupational
2 driver's license granted under this subsection is no longer enrolled in
3 an apprenticeship or on-the-job training program, the director shall
4 give written notice by first-class mail to the driver that the
5 occupational driver's license shall be canceled. (~~The effective date~~
6 ~~of cancellation shall be fifteen days from the date of mailing the~~
7 ~~notice.~~) If at any time before the cancellation goes into effect the
8 driver submits evidence of continued enrollment in the program, the
9 cancellation shall be stayed. If the cancellation becomes effective,
10 the driver may obtain, at no additional charge, a new occupational
11 driver's license upon submittal of evidence of enrollment in another
12 program that meets the criteria set forth in this subsection; and

13 (e) The department shall not issue an occupational driver's license
14 under (b)(iv) of this subsection if the applicant is able to receive
15 transit services sufficient to allow for the applicant's participation
16 in the programs referenced under (b)(iv) of this subsection.

17 (4) A person aggrieved by the decision of the department on the
18 application for an occupational or temporary restricted driver's
19 license may request a hearing as provided by rule of the department.

20 (5) The director shall cancel an occupational or temporary
21 restricted driver's license (~~upon receipt of~~) after receiving notice
22 that the holder thereof has been convicted of operating a motor vehicle
23 in violation of its restrictions, no longer meets the eligibility
24 requirements, or (~~of~~) has been convicted of or found to have
25 committed a separate offense or any other act or omission that under
26 this chapter (~~46.20 RCW~~) would warrant suspension or revocation of a
27 regular driver's license. The department must give notice of the
28 cancellation (~~is effective as of the date of the conviction, and~~
29 ~~continues with the same force and effect as any suspension or~~
30 ~~revocation under this title~~) as provided under RCW 46.20.245. A
31 person whose occupational or temporary restricted driver's license has
32 been canceled under this section may reapply for a new occupational or
33 temporary restricted driver's license if he or she is otherwise
34 qualified under this section and pays the fee required under RCW
35 46.20.380.

36 **Sec. 3.** RCW 46.20.720 and 2008 c 282 s 12 are each amended to read
37 as follows:

1 (1) The court may order that after a period of suspension,
2 revocation, or denial of driving privileges, and for up to as long as
3 the court has jurisdiction, any person convicted of any offense
4 involving the use, consumption, or possession of alcohol while
5 operating a motor vehicle may drive only a motor vehicle equipped with
6 a functioning ignition interlock. The court shall establish a specific
7 calibration setting at which the interlock will prevent the vehicle
8 from being started. The court shall also establish the period of time
9 for which interlock use will be required.

10 (2) Under RCW 46.61.5055(~~(, 10.05.020, or section 18 of this act)~~)
11 and subject to the exceptions listed in that statute, the court shall
12 order any person convicted of (~~(an alcohol-related)~~) a violation of RCW
13 46.61.502 or 46.61.504 or an equivalent local ordinance (~~(or~~
14 ~~participating in a deferred prosecution program under RCW 10.05.020 or~~
15 ~~section 18 of this act for an alcohol-related violation of RCW~~
16 ~~46.61.502 or 46.61.504 or an equivalent local ordinance)~~) to apply for
17 an ignition interlock driver's license from the department under RCW
18 46.20.385 and to have a functioning ignition interlock device installed
19 on all motor vehicles operated by the person.

20 (3) The department shall require that, after any applicable period
21 of suspension, revocation, or denial of driving privileges, a person
22 may drive only a motor vehicle equipped with a functioning ignition
23 interlock device if the person is convicted of (~~(an alcohol-related)~~)
24 a violation of RCW 46.61.502 or 46.61.504 or an equivalent local or
25 out-of-state statute or ordinance.

26 The department may waive the requirement for the use of such a
27 device if it concludes that such devices are not reasonably available
28 in the local area. The installation of an ignition interlock device is
29 not necessary on vehicles owned, leased, or rented by a person's
30 employer and on those vehicles whose care and/or maintenance is the
31 temporary responsibility of the employer, and driven at the direction
32 of a person's employer as a requirement of employment during working
33 hours. The person must provide the department with a declaration
34 pursuant to RCW 9A.72.085 from his or her employer stating that the
35 person's employment requires the person to operate a vehicle owned by
36 the employer or other persons during working hours.

37 The ignition interlock device shall be calibrated to prevent the
38 motor vehicle from being started when the breath sample provided has an

1 alcohol concentration of 0.025 or more. Except as provided in
2 subsection (4) of this section, the period of time of the restriction
3 will be as follows:

4 (a) For a person who has not previously been restricted under this
5 section, a period of one year;

6 (b) For a person who has previously been restricted under (a) of
7 this subsection, a period of five years;

8 (c) For a person who has previously been restricted under (b) of
9 this subsection, a period of ten years.

10 (4) A restriction imposed under subsection (3) of this section
11 shall remain in effect until the department receives a declaration from
12 the person's ignition interlock device vendor, in a form provided or
13 approved by the department, certifying that there have been none of the
14 following incidents in the four consecutive months prior to the date of
15 release:

16 (a) An attempt to start the vehicle with a breath alcohol
17 concentration of 0.04 or more;

18 (b) Failure to take or pass any required retest; or

19 (c) Failure of the person to appear at the ignition interlock
20 device vendor when required for maintenance, repair, calibration,
21 monitoring, inspection, or replacement of the device.

22 **Sec. 4.** RCW 46.61.5055 and 2008 c 282 s 14 are each amended to
23 read as follows:

24 (1) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a
25 person who is convicted of a violation of RCW 46.61.502 or 46.61.504
26 and who has no prior offense within seven years shall be punished as
27 follows:

28 (a) In the case of a person whose alcohol concentration was less
29 than 0.15, or for whom for reasons other than the person's refusal to
30 take a test offered pursuant to RCW 46.20.308 there is no test result
31 indicating the person's alcohol concentration:

32 (i) By imprisonment for not less than one day nor more than one
33 year. Twenty-four consecutive hours of the imprisonment may not be
34 suspended or deferred unless the court finds that the imposition of
35 this mandatory minimum sentence would impose a substantial risk to the
36 offender's physical or mental well-being. Whenever the mandatory
37 minimum sentence is suspended or deferred, the court shall state in

1 writing the reason for granting the suspension or deferral and the
2 facts upon which the suspension or deferral is based. In lieu of the
3 mandatory minimum term of imprisonment required under this subsection
4 (1)(a)(i), the court may order not less than fifteen days of electronic
5 home monitoring. The offender shall pay the cost of electronic home
6 monitoring. The county or municipality in which the penalty is being
7 imposed shall determine the cost. The court may also require the
8 offender's electronic home monitoring device to include an alcohol
9 detection breathalyzer, and the court may restrict the amount of
10 alcohol the offender may consume during the time the offender is on
11 electronic home monitoring; and

12 (ii) By a fine of not less than three hundred fifty dollars nor
13 more than five thousand dollars. Three hundred fifty dollars of the
14 fine may not be suspended or deferred unless the court finds the
15 offender to be indigent; or

16 (b) In the case of a person whose alcohol concentration was at
17 least 0.15, or for whom by reason of the person's refusal to take a
18 test offered pursuant to RCW 46.20.308 there is no test result
19 indicating the person's alcohol concentration:

20 (i) By imprisonment for not less than two days nor more than one
21 year. Two consecutive days of the imprisonment may not be suspended or
22 deferred unless the court finds that the imposition of this mandatory
23 minimum sentence would impose a substantial risk to the offender's
24 physical or mental well-being. Whenever the mandatory minimum sentence
25 is suspended or deferred, the court shall state in writing the reason
26 for granting the suspension or deferral and the facts upon which the
27 suspension or deferral is based. In lieu of the mandatory minimum term
28 of imprisonment required under this subsection (1)(b)(i), the court may
29 order not less than thirty days of electronic home monitoring. The
30 offender shall pay the cost of electronic home monitoring. The county
31 or municipality in which the penalty is being imposed shall determine
32 the cost. The court may also require the offender's electronic home
33 monitoring device to include an alcohol detection breathalyzer, and the
34 court may restrict the amount of alcohol the offender may consume
35 during the time the offender is on electronic home monitoring; and

36 (ii) By a fine of not less than five hundred dollars nor more than
37 five thousand dollars. Five hundred dollars of the fine may not be

1 suspended or deferred unless the court finds the offender to be
2 indigent.

3 (2) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a
4 person who is convicted of a violation of RCW 46.61.502 or 46.61.504
5 and who has one prior offense within seven years shall be punished as
6 follows:

7 (a) In the case of a person whose alcohol concentration was less
8 than 0.15, or for whom for reasons other than the person's refusal to
9 take a test offered pursuant to RCW 46.20.308 there is no test result
10 indicating the person's alcohol concentration:

11 (i) By imprisonment for not less than thirty days nor more than one
12 year and sixty days of electronic home monitoring. The offender shall
13 pay for the cost of the electronic monitoring. The county or
14 municipality where the penalty is being imposed shall determine the
15 cost. The court may also require the offender's electronic home
16 monitoring device include an alcohol detection breathalyzer, and may
17 restrict the amount of alcohol the offender may consume during the time
18 the offender is on electronic home monitoring. Thirty days of
19 imprisonment and sixty days of electronic home monitoring may not be
20 suspended or deferred unless the court finds that the imposition of
21 this mandatory minimum sentence would impose a substantial risk to the
22 offender's physical or mental well-being. Whenever the mandatory
23 minimum sentence is suspended or deferred, the court shall state in
24 writing the reason for granting the suspension or deferral and the
25 facts upon which the suspension or deferral is based; and

26 (ii) By a fine of not less than five hundred dollars nor more than
27 five thousand dollars. Five hundred dollars of the fine may not be
28 suspended or deferred unless the court finds the offender to be
29 indigent; or

30 (b) In the case of a person whose alcohol concentration was at
31 least 0.15, or for whom by reason of the person's refusal to take a
32 test offered pursuant to RCW 46.20.308 there is no test result
33 indicating the person's alcohol concentration:

34 (i) By imprisonment for not less than forty-five days nor more than
35 one year and ninety days of electronic home monitoring. The offender
36 shall pay for the cost of the electronic monitoring. The county or
37 municipality where the penalty is being imposed shall determine the
38 cost. The court may also require the offender's electronic home

1 monitoring device include an alcohol detection breathalyzer, and may
2 restrict the amount of alcohol the offender may consume during the time
3 the offender is on electronic home monitoring. Forty-five days of
4 imprisonment and ninety days of electronic home monitoring may not be
5 suspended or deferred unless the court finds that the imposition of
6 this mandatory minimum sentence would impose a substantial risk to the
7 offender's physical or mental well-being. Whenever the mandatory
8 minimum sentence is suspended or deferred, the court shall state in
9 writing the reason for granting the suspension or deferral and the
10 facts upon which the suspension or deferral is based; and

11 (ii) By a fine of not less than seven hundred fifty dollars nor
12 more than five thousand dollars. Seven hundred fifty dollars of the
13 fine may not be suspended or deferred unless the court finds the
14 offender to be indigent.

15 (3) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a
16 person who is convicted of a violation of RCW 46.61.502 or 46.61.504
17 and who has two or three prior offenses within seven years shall be
18 punished as follows:

19 (a) In the case of a person whose alcohol concentration was less
20 than 0.15, or for whom for reasons other than the person's refusal to
21 take a test offered pursuant to RCW 46.20.308 there is no test result
22 indicating the person's alcohol concentration:

23 (i) By imprisonment for not less than ninety days nor more than one
24 year and one hundred twenty days of electronic home monitoring. The
25 offender shall pay for the cost of the electronic monitoring. The
26 county or municipality where the penalty is being imposed shall
27 determine the cost. The court may also require the offender's
28 electronic home monitoring device include an alcohol detection
29 breathalyzer, and may restrict the amount of alcohol the offender may
30 consume during the time the offender is on electronic home monitoring.
31 Ninety days of imprisonment and one hundred twenty days of electronic
32 home monitoring may not be suspended or deferred unless the court finds
33 that the imposition of this mandatory minimum sentence would impose a
34 substantial risk to the offender's physical or mental well-being.
35 Whenever the mandatory minimum sentence is suspended or deferred, the
36 court shall state in writing the reason for granting the suspension or
37 deferral and the facts upon which the suspension or deferral is based;
38 and

1 (ii) By a fine of not less than one thousand dollars nor more than
2 five thousand dollars. One thousand dollars of the fine may not be
3 suspended or deferred unless the court finds the offender to be
4 indigent; or

5 (b) In the case of a person whose alcohol concentration was at
6 least 0.15, or for whom by reason of the person's refusal to take a
7 test offered pursuant to RCW 46.20.308 there is no test result
8 indicating the person's alcohol concentration:

9 (i) By imprisonment for not less than one hundred twenty days nor
10 more than one year and one hundred fifty days of electronic home
11 monitoring. The offender shall pay for the cost of the electronic
12 monitoring. The county or municipality where the penalty is being
13 imposed shall determine the cost. The court may also require the
14 offender's electronic home monitoring device include an alcohol
15 detection breathalyzer, and may restrict the amount of alcohol the
16 offender may consume during the time the offender is on electronic home
17 monitoring. One hundred twenty days of imprisonment and one hundred
18 fifty days of electronic home monitoring may not be suspended or
19 deferred unless the court finds that the imposition of this mandatory
20 minimum sentence would impose a substantial risk to the offender's
21 physical or mental well-being. Whenever the mandatory minimum sentence
22 is suspended or deferred, the court shall state in writing the reason
23 for granting the suspension or deferral and the facts upon which the
24 suspension or deferral is based; and

25 (ii) By a fine of not less than one thousand five hundred dollars
26 nor more than five thousand dollars. One thousand five hundred dollars
27 of the fine may not be suspended or deferred unless the court finds the
28 offender to be indigent.

29 (4) A person who is convicted of a violation of RCW 46.61.502 or
30 46.61.504 shall be punished under chapter 9.94A RCW if: (a) The person
31 has four or more prior offenses within ten years; or (b) the person has
32 ever previously been convicted of: (i) A violation of RCW 46.61.520
33 committed while under the influence of intoxicating liquor or any drug;
34 (ii) a violation of RCW 46.61.522 committed while under the influence
35 of intoxicating liquor or any drug; or (iii) an out-of-state offense
36 comparable to the offense specified in (b)(i) or (ii) of this
37 subsection.

1 (5)(a) The court shall require any person convicted of (~~an~~
2 ~~alcohol-related~~) a violation of RCW 46.61.502 or 46.61.504 or an
3 equivalent local ordinance to apply for an ignition interlock driver's
4 license from the department (~~under RCW 46.20.385~~) and to have a
5 functioning ignition interlock device installed on all motor vehicles
6 operated by the person.

7 (b) The installation of an ignition interlock device is not
8 necessary on vehicles owned, leased, or rented by a person's employer
9 and on those vehicles whose care and/or maintenance is the temporary
10 responsibility of the employer, and driven at the direction of a
11 person's employer as a requirement of employment during working hours.
12 The person must provide the department with a declaration pursuant to

22 court makes a specific finding in writing that:

23 (i) The person lives out-of-state and the devices are not

4 functioning ignition interlock device is waived by the court)), and the
5 person states that he or she does not operate a motor vehicle or the
6 person is ineligible to obtain an ignition interlock driver's license,
7 the court shall order the person to submit to alcohol monitoring
8 through an alcohol detection breathalyzer device, transdermal sensor
9 device, or other technology designed to detect alcohol in a person's

21 (6) If a person who is convicted of a violation of RCW 46.61.502 or

23 sixteen was in the vehicle, the court shall:

24 (a) In any case in which the installation and use of an interlock
25 or other device is not mandatory under RCW 46.20.720 or other law,
26 order the use of such a device for not less than sixty days following

28 sentence, to install an ignition interlock device on all motor vehicles

31 probation or supervision department must verify the initial

21 evidence shall be taken of the petitioner's alleged failure to comply
22 with the treatment plan or device installation and the petitioner shall
23 have the right to present evidence on his or her own behalf. The court
24 shall either order that the petitioner continue on the treatment plan
