- ACT Relating to disclosure of public records containing 1 2
- information used to locate or identify employees of criminal justice
- 3 agencies; and amending RCW 42.56.250.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 Sec. 1. RCW 42.56.250 and 2006 c 209 s 6 are each amended to read as follows: 6
- 7 The following employment and licensing information is exempt from 8 public inspection and copying under this chapter:
- (1) Test questions, scoring keys, and other examination data used 9 to administer a license, employment, or academic examination; 10
- 11 (2) All applications for public employment, including the names of 12 applicants, resumes, and other related materials submitted with respect to an applicant; 13
- 14 (3) The residential addresses, residential telephone numbers, wireless telephone numbers, 15 personal electronic addresses, social security numbers, and emergency contact information 16 of employees or volunteers of a public agency, and the names, dates of 17 birth, residential addresses, residential telephone numbers, personal 18 19 wireless telephone numbers, personal electronic mail addresses, social

- security numbers, and emergency contact information of dependents of employees or volunteers of a public agency that are held by any public agency in personnel records, public employment related records, or volunteer rosters, or are included in any mailing list of employees or volunteers of any public agency. For purposes of this subsection, "employees" includes independent provider home care workers as defined in RCW 74.39A.240;
  - (4) Information that identifies a person who, while an agency employee: (a) Seeks advice, under an informal process established by the employing agency, in order to ascertain his or her rights in connection with a possible unfair practice under chapter 49.60 RCW against the person; and (b) requests his or her identity or any identifying information not be disclosed;
  - (5) Investigative records compiled by an employing agency conducting a current investigation of a possible unfair practice under chapter 49.60 RCW or of a possible violation of other federal, state, or local laws prohibiting discrimination in employment; ((and))
  - (6) Except as provided in RCW 47.64.220, salary and employee benefit information collected under RCW 47.64.220(1) and described in RCW 47.64.220(2); and
- 21 (7) Photographs and month and year of birth in the personnel files 22 of employees and workers of criminal justice agencies as defined in RCW 23 10.97.030. The news media, as defined in RCW 5.68.010(5), shall have 24 access to the photographs and year of birth.
