1 AN ACT Relating to the economic stimulus capital budget; amending  
2 2007 c 520 ss 2062, 2076, 2057, 3177, 5042, 5050, 5071, 5092, 5115,  
3 5201, 5243, 5268, 5267, 5266, and 5270 (uncodified); creating new  
4 sections; making appropriations; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** (1) It is the intent of the governor and the  
7 legislature to stimulate Washington's lagging economy and to reduce the  
8 state's unemployment rate by quickly putting people to work on  
9 infrastructure projects. These investments will include improving  
10 higher education campuses, cleaning up Puget Sound, replacing aging  
11 local infrastructure, and creating green jobs. Such projects must be  
12 started quickly after funding is received and generate a significant  
13 number of jobs in order to strengthen the economy and assist those  
14 seeking work. To that end, more than four hundred forty-six million  
15 dollars will be advanced and go to advertisement no later than April  
16 30, 2009.

17 (2) This economic stimulus capital budget is hereby adopted and,  
18 subject to the provisions set forth, the amounts specified, or as much

1 thereof as may be necessary to accomplish the purposes designated are  
2 hereby appropriated.

3 (3) The definitions in this subsection apply throughout this act  
4 unless the context clearly requires otherwise.

5 (a) "Fiscal year 2010" or "FY 2010" means the fiscal year ending  
6 June 30, 2010.

7 (b) "Fiscal year 2011" or "FY 2011" means the fiscal year ending  
8 June 30, 2011.

9 (c) "Lapse" or "revert" means the amount shall return to an  
10 unappropriated status.

11 (d) "Provided solely" means the specified amount may be spent only  
12 for the specified purpose.

13 Unless otherwise specifically authorized in this act, any portion  
14 of an amount provided solely for a specified purpose that is not  
15 expended subject to the specified conditions and limitations to fulfill  
16 the specified purpose shall lapse.

2 **MISCELLANEOUS AND SUPPLEMENTAL PROVISIONS**

3 NEW SECTION. **Sec. 301.** (1) Allotments for appropriations in this  
4 act shall be provided in accordance with the capital project review  
5 requirements adopted by the office of financial management and in  
6 compliance with RCW 43.88.110. Projects that will be employing  
7 alternative public works construction procedures under chapter 39.10  
8 RCW are subject to the allotment procedures defined in this section and  
9 RCW 43.88.110.

10 (2) Each project is defined as proposed in the legislative budget  
11 notes or in the governor's budget document.

12 NEW SECTION. **Sec. 302.** (1) To ensure minor works appropriations  
13 are carried out in accordance with legislative intent, funds  
14 appropriated in this act shall not be allotted until project lists are  
15 on file at the office of financial management, the house of  
16 representatives capital budget committee, and the senate ways and means  
17 committee. All projects must meet the criteria included in subsection  
18 (2)(a) of this section. Revisions to the lists must be filed with the  
19 office of financial management, the house of representatives capital  
20 budget committee, and the senate ways and means committee and include  
21 an explanation of variances from the prior lists before funds may be  
22 expended on the revisions.

23 (2)(a) Minor works projects are single line appropriations that  
24 include multiple projects of a similar nature and that are valued  
25 between \$25,000 and \$1,000,000 each, with the exception of higher  
26 education minor works projects that may be valued up to \$2,000,000.  
27 These projects can generally be completed within two years of the  
28 appropriation with the funding provided. Agencies are prohibited from  
29 including projects on their minor works lists that are a phase of a  
30 larger project, and that if combined over a continuous period of time,  
31 would exceed \$1,000,000, or \$2,000,000 for higher education minor works  
32 projects. Improvements for accessibility in compliance with the  
33 Americans with disabilities act may be included in any of the above  
34 minor works categories.

35 (b) Minor works appropriations shall not be used for, among other  
36 things: Studies, except for technical or engineering reviews or

1 designs that lead directly to and support a project on the same minor  
2 works list; planning; design outside the scope of work on a minor works  
3 list; moveable, temporary, and traditionally funded operating equipment  
4 not in compliance with the equipment criteria established by the office  
5 of financial management; software not dedicated to control of a  
6 specialized system; moving expenses; land or facility acquisition; or  
7 to supplement funding for projects with funding shortfalls unless  
8 expressly authorized elsewhere in this act. The office of financial  
9 management may make an exception to the limitations described in this  
10 subsection (2)(b) for exigent circumstances after notifying the  
11 legislative fiscal committees and waiting ten days for comments by the  
12 legislature regarding the proposed exception.

13 (3) It is generally not the intent of the legislature to make  
14 future appropriations for capital expenditures or for maintenance and  
15 operating expenses for an acquisition project or a significant  
16 expansion project that is initiated through the minor works process and  
17 therefore does not receive a policy and fiscal analysis by the  
18 legislature. Minor works projects are intended to be one-time  
19 expenditures that do not require future state resources to complete.

20 NEW SECTION. **Sec. 303.** (1) The office of financial management may  
21 authorize a transfer of appropriation authority provided for a capital  
22 project that is in excess of the amount required for the completion of  
23 such project to another capital project for which the appropriation is  
24 insufficient. No such transfer may be used to expand the capacity of  
25 any facility beyond that intended in making the appropriation. Such  
26 transfers may be effected only between capital appropriations to a  
27 specific department, commission, agency, or institution of higher  
28 education and only between capital projects that are funded from the  
29 same fund or account. No transfers may occur between projects to local  
30 government agencies except where the grants are provided within a  
31 single omnibus appropriation and where such transfers are specifically  
32 authorized by the implementing statutes that govern the grants.

33 (2) The office of financial management may find that an amount is  
34 in excess of the amount required for the completion of a project only  
35 if: (a) The project as defined in the notes to the budget document is  
36 substantially complete and there are funds remaining; or (b) bids have  
37 been let on a project and it appears to a substantial certainty that



1 the project as defined in the notes to the budget document can be  
2 completed within the biennium for less than the amount appropriated in  
3 this act.

4 (3) For the purposes of this section, the intent is that each  
5 project be defined as proposed to the legislature in the governor's  
6 budget document, unless it clearly appears from the legislative history  
7 that the legislature intended to define the scope of a project in a  
8 different way.

9 (4) Transfers of funds to an agency's infrastructure savings  
10 appropriation are subject to review and approval by the office of  
11 financial management. Expenditures from an infrastructure savings  
12 appropriation are limited to projects that have a primary purpose to  
13 correct infrastructure deficiencies or conditions that: (a) Adversely  
14 affect the ability to utilize the infrastructure for its current  
15 programmatic use; (b) reduce the life expectancy of the infrastructure;  
16 or (c) increase the operating costs of the infrastructure for its  
17 current programmatic use. Eligible infrastructure projects may include  
18 structures and surface improvements, site amenities, utility systems  
19 outside building footprints and natural environmental changes or  
20 requirements as part of an environmental regulation, a declaration of  
21 emergency for an infrastructure issue in conformance with RCW  
22 43.88.250, or infrastructure planning as part of a facility master  
23 plan.

24 (5) A report of any transfer effected under this section, except  
25 emergency projects or any transfer under \$250,000, shall be filed with  
26 the legislative fiscal committees of the senate and house of  
27 representatives by the office of financial management at least thirty  
28 days before the date the transfer is effected. The office of financial  
29 management shall report all emergency or smaller transfers within  
30 thirty days from the date of transfer.

31 NEW SECTION. **Sec. 304.** State agencies, including institutions of  
32 higher education, shall allot and report full-time equivalent staff for  
33 capital projects in a manner comparable to staff reporting for  
34 operating expenditures.

35 NEW SECTION. **Sec. 305.** Executive Order No. 05-05, archaeological

1 and cultural resources, was issued effective November 10, 2005.  
2 Agencies and higher education institutions shall comply with the  
3 requirements set forth in this executive order.

4 NEW SECTION. **Sec. 306.** ACQUISITION OF PROPERTIES AND FACILITIES  
5 THROUGH FINANCIAL CONTRACTS. The following agencies may enter into  
6 financial contracts, paid from any funds of an agency, appropriated or  
7 nonappropriated, for the purposes indicated and in not more than the  
8 principal amounts indicated, plus financing expenses and required  
9 reserves pursuant to chapter 39.94 RCW. When securing properties under  
10 this section, agencies shall use the most economical financial contract  
11 option available, including long-term leases, lease-purchase  
12 agreements, lease-development with option to purchase agreements or  
13 financial contracts using certificates of participation. Expenditures  
14 made by an agency for one of the indicated purposes before the issue  
15 date of the authorized financial contract and any certificates of  
16 participation therein are intended to be reimbursed from proceeds of  
17 the financial contract and any certificates of participation therein to  
18 the extent provided in the agency's financing plan approved by the  
19 state finance committee.

20 State agencies may enter into agreements with the department of  
21 general administration and the state treasurer's office to develop  
22 requests to the legislature for acquisition of properties and  
23 facilities through financial contracts. The agreements may include  
24 charges for services rendered.

25 Those noninstructional facilities of higher education institutions  
26 authorized in this section to enter into financial contracts are not  
27 eligible for state funded maintenance and operations. Instructional  
28 space that is available for regularly scheduled classes for academic  
29 transfer, basic skills, and workforce training programs may be eligible  
30 for state funded maintenance and operations.

31 (1) Department of general administration: Enter into a financing  
32 contract for up to \$685,000 plus financing expenses and required  
33 reserves pursuant to chapter 39.94 RCW for the preservation of the  
34 transportation building.

35 (2) Department of corrections: Enter into a financing contract for  
36 up to \$17,958,000 plus financing expenses and required reserves  
37 pursuant to chapter 39.94 RCW to provide additional work release beds.

1 (3) Parks and recreation commission: Enter into a financing  
2 contract in an amount not to exceed \$2,000,000 plus financing expenses  
3 and required reserves pursuant to chapter 39.94 RCW to develop Cama

5 (4) University of Washington: Enter into a financing contract for  
6 up to \$86,526,000 plus financing expenses and required reserves  
7 pursuant to chapter 39.94 RCW for campus projects.

8 (5) Washington State University: Enter into a financing contract  
9 for up to \$15,750,000 plus financing expenses and required reserves  
10 pursuant to chapter 39.94 RCW for campus projects. If funds in this  
11 subsection are used to finance the wastewater reclamation project, all  
12 treated effluent may be used only for the domestic water requirements  
13 of the Pullman energy plant and chilled water facilities and irrigating

15 (6) Central Washington University: Enter into a financing contract

18 (7) Eastern Washington University: Enter into a financing contract  
19 for up to \$5,500,000 plus financing expenses and required reserves  
20 pursuant to chapter 39.94 RCW for campus projects.

21 (8) Community and technical colleges: Enter into a financing  
22 contract for up to \$109,804,000 plus financing expenses and required  
23 reserves pursuant to chapter 39.94 RCW for various campus projects.

24 NEW SECTION. **Sec. 307.** FOR THE ARTS COMMISSION--ART WORK  
25 ALLOWANCE POOLING. (1) One-half of one percent of moneys appropriated  
26 in this act for original construction of school plant facilities is  
27 provided solely for the purposes of RCW 28A.335.210. The Washington  
28 state arts commission may combine the proceeds from individual projects  
29 in order to fund larger works of art or mobile art displays in  
30 consultation with the superintendent of public instruction and  
31 representatives of school district boards.

32 (2) One-half of one percent of moneys appropriated in this act for  
33 original construction or any major renovation or remodel work exceeding  
34 two hundred thousand dollars by colleges or universities is provided  
35 solely for the purposes of RCW 28B.10.027. The Washington state arts  
36 commission may combine the proceeds from individual projects in order

1 to fund larger works of art or mobile art displays in consultation with  
2 the board of regents or trustees.

3 (3) One-half of one percent of moneys appropriated in this act for  
4 original construction of any public building by a state agency as  
5 defined in RCW 43.17.020 is provided solely for the purposes of RCW  
6 43.17.200. The Washington state arts commission may combine the  
7 proceeds from individual projects in order to fund larger works of art  
8 or mobile art displays in consultation with the state agency.

9 (4) At least eighty-five percent of the moneys spent by the  
10 Washington state arts commission during the 2009-2011 biennium for the  
11 purposes of RCW 28A.335.210, 28B.10.027, and 43.17.200 must be expended  
12 solely for direct acquisition of works of art. The commission may use  
13 up to \$100,000 of this amount to conserve or maintain existing pieces  
14 in the state art collection pursuant to chapter 36, Laws of 2005.

15 NEW SECTION. **Sec. 308.** The amounts shown under the headings  
16 "Prior Biennia," "Future Biennia," and "Total" in this act are for  
17 informational purposes only and do not constitute legislative approval  
18 of these amounts. "Prior biennia" typically refers to the immediate  
19 prior biennium for reappropriations, but may refer to multiple biennia  
20 in the case of specific projects. A "future biennia" amount is an  
21 estimate of what may be appropriated for the project or program in the  
22 2011-2013 biennium and the following three biennia; an amount of zero  
23 does not necessarily constitute legislative intent to not provide  
24 funding for the project or program in the future.

25 NEW SECTION. **Sec. 309.** "Reappropriations" in this act are  
26 appropriations and, unless the context clearly provides otherwise, are  
27 subject to the relevant conditions and limitations applicable to  
28 appropriations. Reappropriations shall be limited to the unexpended  
29 balances remaining on June 30, 2009, from the 2007-2009 biennial  
30 appropriations for each project.

31 NEW SECTION. **Sec. 310.** To carry out the provisions of this act,  
32 the governor may assign responsibility for predesign, design,  
33 construction, and other related activities to any appropriate agency.



1        NEW SECTION.    **Sec. 314.**    The office of financial management, in  
2        consultation with the fiscal committees of the legislature, may select  
3        capital projects that have completed predesign to undergo a budget  
4        evaluation study.    The budget evaluation study team approach using  
5        value engineering techniques must be utilized by the office of  
6        financial management in conducting the studies.    The office of  
7        financial management shall select the budget evaluation team members,  
8        contract for the study, and report the results to the legislature and  
9        agencies in a timely manner following the study.    Funds from the  
10       project appropriation must be used by the office of financial

14       of the law.

15       NEW SECTION.    **Sec. 316.**    If any provision of this act or its  
16       application to any person or circumstance is held invalid, the  
17       remainder of the act or the application of the provision to other  
18       persons or circumstances is not affected.

19       NEW SECTION.    **Sec. 317.**    This act is necessary for the immediate  
20       preservation of the public peace, health, or safety, or support of the  
21       state government and its existing public institutions, and takes effect  
22       immediately.
