1       AN ACT Relating to coordinating workforce and economic development;  
2 amending RCW 43.330.090, 50.38.050, 28B.50.030, 28C.18.010, 28C.18.060,  
3 28C.18.080, 43.162.020, and 43.330.080; adding a new section to chapter  
4 28B.50 RCW; and adding a new section to chapter 28C.18 RCW.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6       **Sec. 1.** RCW 43.330.090 and 2007 c 228 s 201 are each amended to  
7 read as follows:

8       (1) The department shall work with private sector organizations,  
9 industry and (~~eluster~~) sector associations, federal agencies, state  
10 agencies that use a (~~eluster-based~~) sector-based approach to service  
11 delivery, local governments, local associate development organizations,  
12 and higher education and training institutions in the development of  
13 industry (~~eluster-based~~) sector-based strategies to diversify the  
14 economy, facilitate technology transfer and diffusion, and increase  
15 value-added production. The industry (~~elusters~~) sectors targeted by  
16 the department may include, but are not limited to, aerospace,  
17 agriculture, food processing, forest products, marine services, health  
18 and biomedical, software, digital and interactive media, transportation  
19 and distribution, and microelectronics. The department shall, on a

1 continuing basis, evaluate the potential return to the state from  
2 devoting additional resources to an industry (~~cluster-based~~) sector-  
3 based approach to economic development and identifying and assisting  
4 additional (~~clusters~~) sectors. (~~The department shall use~~  
5 ~~information gathered in each service delivery region in formulating its~~  
6 ~~industry cluster-based strategies and shall assist local communities in~~  
7 ~~identifying regional industry clusters and developing industry cluster-~~  
8 ~~based strategies.~~)

9 (2) The department's sector-based strategies shall include, but not  
10 be limited to, cluster-based strategies that focus on assisting  
11 regional industry sectors and related firms and institutions that meet  
12 the definition of an industry cluster in this section and based on  
13 criteria identified by the working group established in this chapter.

14 (3)(a) The department shall promote, market, and encourage growth  
15 in the production of films and videos, as well as television  
16 commercials within the state; to this end the department is directed to  
17 assist in the location of a film and video production studio within the  
18 state.

19 (b) The department may, in carrying out its efforts to encourage  
20 film and video production in the state, solicit and receive gifts,  
21 grants, funds, fees, and endowments, in trust or otherwise, from  
22 tribal, local, or other governmental entities, as well as private  
23 sources, and may expend the same or any income therefrom for the  
24 encouragement of film and video production. All revenue received for  
25 such purposes shall be deposited into the film and video promotion  
26 account created in RCW 43.330.092.

27 (~~(+3)~~) (4) In assisting in the development of regional and  
28 statewide industry cluster-based strategies, the department's  
29 activities shall include, but are not limited to:

30 (a) Facilitating regional focus group discussions and conducting  
31 studies to identify industry clusters, appraise the current information  
32 linkages within a cluster, and identify issues of common concern within  
33 a cluster;

34 (b) Supporting industry and cluster associations, publications of  
35 association and cluster directories, and related efforts to create or  
36 expand the activities of industry and cluster associations;

37 (c) Administering a competitive grant program to fund economic  
38 development activities designed to further regional cluster growth. In

1 administering the program, the department shall work with an industry  
2 cluster advisory committee with equal representation from the economic  
3 development commission, the workforce training and education  
4 coordinating board, the state board for community and technical  
5 colleges, the employment security department, business, and labor.

6 (i) The industry cluster advisory committee shall recommend  
7 criteria for evaluating applications for grant funds and recommend  
8 applicants for receipt of grant funds. Criteria shall include not  
9 duplicating the purpose or efforts of industry skill panels.

10 (ii) Applicants must include organizations from at least two  
11 counties and participants from the local business community. Eligible  
12 organizations include, but are not limited to, local governments,  
13 economic development councils, chambers of commerce, federally  
14 recognized Indian tribes, workforce development councils, and  
15 educational institutions.

16 (iii) Applications must evidence financial participation of the  
17 partner organizations.

18 (iv) Eligible activities include the formation of cluster economic  
19 development partnerships, research and analysis of economic development  
20 needs of the cluster, the development of a plan to meet the economic  
21 development needs of the cluster, and activities to implement the plan.

22 (v) Priority shall be given to applicants (~~(which)~~) that complement  
23 industry skill panels and will use the grant funds to build linkages  
24 and joint projects(~~(, to develop common resources and common training,~~  
25 ~~and to develop common research and development projects or~~  
26 ~~facilities))~~).

27 (~~(+v)~~) (vi) The maximum amount of a grant is one hundred thousand  
28 dollars.

29 (~~(+vi)~~) (vii) A maximum of one hundred thousand dollars total can  
30 go to King, Pierce, Kitsap, and Snohomish counties combined.

31 (~~(+vii)~~) (viii) No more than ten percent of funds received for the  
32 grant program may be used by the department for administrative costs.

33 (~~(+4)~~) (5) As used in (~~(subsection (3) of this section)~~) this  
34 chapter, "industry cluster" means a geographic concentration of  
35 (~~(interdependent competitive firms that do business with each other.~~  
36 ~~"Industry cluster" also includes firms that sell inside and outside of~~  
37 ~~the geographic region as well as support firms that supply raw~~  
38 ~~materials, components, and business services)) interconnected companies~~

1 in a single industry, related businesses in other industries, including  
2 suppliers and customers, and associated institutions, including  
3 government and education.

4 **Sec. 2.** RCW 50.38.050 and 1993 c 62 s 5 are each amended to read  
5 as follows:

6 The department shall have the following duties:

7 (1) Oversight and management of a statewide comprehensive labor  
8 market and occupational supply and demand information system, including  
9 development of a five-year employment forecast for state and labor  
10 market areas;

11 (2) Produce local labor market information packages for the state's  
12 counties, including special studies and job impact analyses in support  
13 of state and local employment, training, education, and job creation  
14 programs, especially activities that prevent job loss, reduce  
15 unemployment, and create jobs;

16 (3) Coordinate with the office of financial management and the  
17 office of the forecast council to improve employment estimates by  
18 enhancing data on corporate officers, improving business establishment  
19 listings, expanding sample for employment estimates, and developing  
20 business entry/exit analysis relevant to the generation of occupational  
21 and economic forecasts; (~~and~~)

22 (4) In cooperation with the office of financial management, produce  
23 long-term industry and occupational employment forecasts. These  
24 forecasts shall be consistent with the official economic and revenue  
25 forecast council biennial economic and revenue forecasts; and

26 (5) Analyze labor market and economic data, including the use of  
27 input-output models, for the purpose of identifying industry clusters  
28 and strategic industry clusters that meet the criteria identified by  
29 the working group convened by the economic development commission and  
30 the workforce training and education coordinating board under chapter  
31 43.330 RCW.

32 **Sec. 3.** RCW 28B.50.030 and 2007 c 277 s 301 are each amended to  
33 read as follows:

34 As used in this chapter, unless the context requires otherwise, the  
35 term:

1 (1) "System" shall mean the state system of community and technical  
2 colleges, which shall be a system of higher education.

3 (2) "Board" shall mean the workforce training and education  
4 coordinating board.

5 (3) "College board" shall mean the state board for community and  
6 technical colleges created by this chapter.

7 (4) "Director" shall mean the administrative director for the state  
8 system of community and technical colleges.

9 (5) "District" shall mean any one of the community and technical  
10 college districts created by this chapter.

11 (6) "Board of trustees" shall mean the local community and  
12 technical college board of trustees established for each college  
13 district within the state.

14 (7) "Occupational education" shall mean that education or training  
15 that will prepare a student for employment that does not require a  
16 baccalaureate degree, and education and training leading to an applied  
17 baccalaureate degree.

18 (8) "K-12 system" shall mean the public school program including  
19 kindergarten through the twelfth grade.

20 (9) "Common school board" shall mean a public school district board  
21 of directors.

22 (10) "Community college" shall include those higher education  
23 institutions that conduct education programs under RCW 28B.50.020.

24 (11) "Technical college" shall include those higher education  
25 institutions with the sole mission of conducting occupational  
26 education, basic skills, literacy programs, and offering on short  
27 notice, when appropriate, programs that meet specific industry needs.  
28 The programs of technical colleges shall include, but not be limited  
29 to, continuous enrollment, competency-based instruction, industry-  
30 experienced faculty, curriculum integrating vocational and basic skills  
31 education, and curriculum approved by representatives of employers and  
32 labor. For purposes of this chapter, technical colleges shall include  
33 Lake Washington Vocational-Technical Institute, Renton Vocational-  
34 Technical Institute, Bates Vocational-Technical Institute, Clover Park  
35 Vocational Institute, and Bellingham Vocational-Technical Institute.

36 (12) "Adult education" shall mean all education or instruction,  
37 including academic, vocational education or training, basic skills and  
38 literacy training, and "occupational education" provided by public

1 educational institutions, including common school districts for persons  
2 who are eighteen years of age and over or who hold a high school  
3 diploma or certificate. However, "adult education" shall not include  
4 academic education or instruction for persons under twenty-one years of  
5 age who do not hold a high school degree or diploma and who are  
6 attending a public high school for the sole purpose of obtaining a high  
7 school diploma or certificate, nor shall "adult education" include  
8 education or instruction provided by any four year public institution  
9 of higher education.

10 (13) "Dislocated forest product worker" shall mean a forest  
11 products worker who: (a)(i) Has been terminated or received notice of  
12 termination from employment and is unlikely to return to employment in  
13 the individual's principal occupation or previous industry because of  
14 a diminishing demand for his or her skills in that occupation or  
15 industry; or (ii) is self-employed and has been displaced from his or  
16 her business because of the diminishing demand for the business'  
17 services or goods; and (b) at the time of last separation from  
18 employment, resided in or was employed in a rural natural resources  
19 impact area.

20 (14) "Forest products worker" shall mean a worker in the forest  
21 products industries affected by the reduction of forest fiber  
22 enhancement, transportation, or production. The workers included  
23 within this definition shall be determined by the employment security  
24 department, but shall include workers employed in the industries  
25 assigned the major group standard industrial classification codes "24"  
26 and "26" and the industries involved in the harvesting and management  
27 of logs, transportation of logs and wood products, processing of wood  
28 products, and the manufacturing and distribution of wood processing and  
29 logging equipment. The commissioner may adopt rules further  
30 interpreting these definitions. For the purposes of this subsection,  
31 "standard industrial classification code" means the code identified in  
32 RCW 50.29.025(3).

33 (15) "Dislocated salmon fishing worker" means a finfish products  
34 worker who: (a)(i) Has been terminated or received notice of  
35 termination from employment and is unlikely to return to employment in  
36 the individual's principal occupation or previous industry because of  
37 a diminishing demand for his or her skills in that occupation or  
38 industry; or (ii) is self-employed and has been displaced from his or

1 her business because of the diminishing demand for the business's  
2 services or goods; and (b) at the time of last separation from  
3 employment, resided in or was employed in a rural natural resources  
4 impact area.

5 (16) "Salmon fishing worker" means a worker in the finfish industry  
6 affected by 1994 or future salmon disasters. The workers included  
7 within this definition shall be determined by the employment security  
8 department, but shall include workers employed in the industries  
9 involved in the commercial and recreational harvesting of finfish  
10 including buying and processing finfish. The commissioner may adopt  
11 rules further interpreting these definitions.

12 (17) "Rural natural resources impact area" means:

13 (a) A nonmetropolitan county, as defined by the 1990 decennial  
14 census, that meets three of the five criteria set forth in subsection  
15 (18) of this section;

16 (b) A nonmetropolitan county with a population of less than forty  
17 thousand in the 1990 decennial census, that meets two of the five  
18 criteria as set forth in subsection (18) of this section; or

19 (c) A nonurbanized area, as defined by the 1990 decennial census,  
20 that is located in a metropolitan county that meets three of the five  
21 criteria set forth in subsection (18) of this section.

22 (18) For the purposes of designating rural natural resources impact  
23 areas, the following criteria shall be considered:

24 (a) A lumber and wood products employment location quotient at or  
25 above the state average;

26 (b) A commercial salmon fishing employment location quotient at or  
27 above the state average;

28 (c) Projected or actual direct lumber and wood products job losses  
29 of one hundred positions or more;

30 (d) Projected or actual direct commercial salmon fishing job losses  
31 of one hundred positions or more; and

32 (e) An unemployment rate twenty percent or more above the state  
33 average. The counties that meet these criteria shall be determined by  
34 the employment security department for the most recent year for which  
35 data is available. For the purposes of administration of programs  
36 under this chapter, the United States post office five-digit zip code  
37 delivery areas will be used to determine residence status for  
38 eligibility purposes. For the purpose of this definition, a zip code

1 delivery area of which any part is ten miles or more from an urbanized  
2 area is considered nonurbanized. A zip code totally surrounded by zip  
3 codes qualifying as nonurbanized under this definition is also  
4 considered nonurbanized. The office of financial management shall make  
5 available a zip code listing of the areas to all agencies and  
6 organizations providing services under this chapter.

7 (19) "Applied baccalaureate degree" means a baccalaureate degree  
8 awarded by a college under RCW 28B.50.810 for successful completion of  
9 a program of study that is:

10 (a) Specifically designed for individuals who hold an associate of  
11 applied science degree, or its equivalent, in order to maximize  
12 application of their technical course credits toward the baccalaureate  
13 degree; and

14 (b) Based on a curriculum that incorporates both theoretical and  
15 applied knowledge and skills in a specific technical field.

16 (20) "Qualified institutions of higher education" means:

17 (a) Washington public community and technical colleges;

18 (b) Private career schools that are members of an accrediting  
19 association recognized by rule of the higher education coordinating  
20 board for the purposes of chapter 28B.92 RCW; and

21 (c) Washington state apprenticeship and training council-approved  
22 apprenticeship programs.

23 (21) "Center of excellence" means a community or technical college  
24 designated by the college board as a statewide leader in  
25 industry-specific, community and technical college workforce education  
26 and training.

27 NEW SECTION. Sec. 4. A new section is added to chapter 28B.50 RCW  
28 to read as follows:

29 The college board, in consultation with business, industry, labor,  
30 the workforce training and education coordinating board, the department  
31 of community, trade, and economic development, the employment security  
32 department, and community and technical colleges, shall designate  
33 centers of excellence and allocate funds to existing and new centers of  
34 excellence based on a competitive basis.

35 Eligible applicants for the program established under this section  
36 include community and technical colleges. Priority shall be given to

1 applicants that have an established education and training program  
2 serving the targeted industry and that have in their home district or  
3 region an industry cluster with the same targeted industry at its core.

4 It is the role of centers of excellence to employ strategies to:  
5 Create educational efficiencies; build a diverse, competitive workforce  
6 for strategic industries; maintain an institutional reputation for  
7 innovation and responsiveness; develop innovative curriculum and means  
8 of delivering education and training; act as brokers of information and  
9 resources related to community and technical college education and  
10 training for a targeted industry; and serve as partners with workforce  
11 development councils, associate development organizations, and other  
12 workforce and economic development organizations.

13 Examples of strategies include but are not limited to: Sharing  
14 curriculum and other instructional resources, to ensure cost savings to  
15 the system; delivering collaborative certificate and degree programs;  
16 and holding statewide summits, seminars, conferences, and workshops on  
17 industry trends and best practices in community and technical college  
18 education and training.

19 **Sec. 5.** RCW 28C.18.010 and 2008 c 103 s 2 are each amended to read  
20 as follows:

21 Unless the context clearly requires otherwise, the definitions in  
22 this section apply throughout this title.

23 (1) "Board" means the workforce training and education coordinating  
24 board.

25 (2) "Director" means the director of the workforce training and  
26 education coordinating board.

27 (3) "Training system" means programs and courses of secondary  
28 vocational education, technical college programs and courses, community  
29 college vocational programs and courses, private career school and  
30 college programs and courses, employer-sponsored training, adult basic  
31 education programs and courses, programs and courses funded by the  
32 federal workforce investment act, programs and courses funded by the  
33 federal vocational act, programs and courses funded under the federal  
34 adult education act, publicly funded programs and courses for adult  
35 literacy education, and apprenticeships, and programs and courses  
36 offered by private and public nonprofit organizations that are

1 representative of communities or significant segments of communities  
2 and provide job training or adult literacy services.

3 (4) "Workforce skills" means skills developed through applied  
4 learning that strengthen and reinforce an individual's academic  
5 knowledge, critical thinking, problem solving, and work ethic and,  
6 thereby, develop the employability, occupational skills, and management  
7 of home and work responsibilities necessary for economic independence.

8 (5) "Vocational education" means organized educational programs  
9 offering a sequence of courses which are directly related to the  
10 preparation or retraining of individuals in paid or unpaid employment  
11 in current or emerging occupations requiring other than a baccalaureate  
12 or advanced degree. Such programs shall include competency-based  
13 applied learning which contributes to an individual's academic  
14 knowledge, higher-order reasoning, and problem-solving skills, work  
15 attitudes, general employability skills, and the occupational-specific  
16 skills necessary for economic independence as a productive and  
17 contributing member of society. Such term also includes applied  
18 technology education.

19 (6) "Adult basic education" means instruction designed to achieve  
20 mastery of skills in reading, writing, oral communication, and  
21 computation at a level sufficient to allow the individual to function  
22 effectively as a parent, worker, and citizen in the United States,  
23 commensurate with that individual's actual ability level, and includes  
24 English as a second language and preparation and testing service for  
25 the general education development exam.

26 (7) "Industry skill panel" means a regional partnership of  
27 business, labor, and education leaders that identifies skill gaps in a  
28 key economic cluster and enables the industry and public partners to  
29 respond to and be proactive in addressing workforce skill needs.

30 (8) "Workforce development council" means a local workforce  
31 investment board as established in P.L. 105-220 Sec. 117.

32 **Sec. 6.** RCW 28C.18.060 and 2008 c 212 s 2 are each amended to read  
33 as follows:

34 The board, in cooperation with the operating agencies of the state  
35 training system and private career schools and colleges, shall:

36 (1) Concentrate its major efforts on planning, coordination

1 evaluation, policy analysis, and recommending improvements to the  
2 state's training system;

3 (2) Advocate for the state training system and for meeting the  
4 needs of employers and the workforce for workforce education and  
5 training;

6 (3) Establish and maintain an inventory of the programs of the  
7 state training system, and related state programs, and perform a  
8 biennial assessment of the vocational education, training, and adult  
9 basic education and literacy needs of the state; identify ongoing and  
10 strategic education needs; and assess the extent to which employment,  
11 training, vocational and basic education, rehabilitation services, and  
12 public assistance services represent a consistent, integrated approach  
13 to meet such needs;

14 (4) Develop and maintain a state comprehensive plan for workforce  
15 training and education, including but not limited to, goals,  
16 objectives, and priorities for the state training system, and review  
17 the state training system for consistency with the state comprehensive  
18 plan. In developing the state comprehensive plan for workforce  
19 training and education, the board shall use, but shall not be limited  
20 to: Economic, labor market, and populations trends reports in office  
21 of financial management forecasts; joint office of financial management  
22 and employment security department labor force, industry employment,  
23 and occupational forecasts; the results of scientifically based  
24 outcome, net-impact and cost-benefit evaluations; the needs of  
25 employers as evidenced in formal employer surveys and other employer  
26 input; and the needs of program participants and workers as evidenced  
27 in formal surveys and other input from program participants and the  
28 labor community;

29 (5) In consultation with the higher education coordinating board,  
30 review and make recommendations to the office of financial management  
31 and the legislature on operating and capital facilities budget requests  
32 for operating agencies of the state training system for purposes of  
33 consistency with the state comprehensive plan for workforce training  
34 and education;

35 (6) Provide for coordination among the different operating agencies  
36 and components of the state training system at the state level and at  
37 the regional level;

1 (7) Develop a consistent and reliable database on vocational  
2 education enrollments, costs, program activities, and job placements  
3 from publicly funded vocational education programs in this state;

4 (8)(a) Establish standards for data collection and maintenance for  
5 the operating agencies of the state training system in a format that is  
6 accessible to use by the board. The board shall require a minimum of  
7 common core data to be collected by each operating agency of the state  
8 training system;

9 (b) Develop requirements for minimum common core data in  
10 consultation with the office of financial management and the operating  
11 agencies of the training system;

12 (9) Establish minimum standards for program evaluation for the  
13 operating agencies of the state training system, including, but not  
14 limited to, the use of common survey instruments and procedures for  
15 measuring perceptions of program participants and employers of program  
16 participants, and monitor such program evaluation;

17 (10) Every two years administer scientifically based outcome  
18 evaluations of the state training system, including, but not limited  
19 to, surveys of program participants, surveys of employers of program  
20 participants, and matches with employment security department payroll  
21 and wage files. Every five years administer scientifically based net-  
22 impact and cost-benefit evaluations of the state training system;

23 (11) In cooperation with the employment security department,  
24 provide for the improvement and maintenance of quality and utility in  
25 occupational information and forecasts for use in training system  
26 planning and evaluation. Improvements shall include, but not be  
27 limited to, development of state-based occupational change factors  
28 involving input by employers and employees, and delineation of skill  
29 and training requirements by education level associated with current  
30 and forecasted occupations;

31 (12) Provide for the development of common course description  
32 formats, common reporting requirements, and common definitions for  
33 operating agencies of the training system;

34 (13) Provide for effectiveness and efficiency reviews of the state  
35 training system;

36 (14) In cooperation with the higher education coordinating board,  
37 facilitate transfer of credit policies and agreements between

1 institutions of the state training system, and encourage articulation  
2 agreements for programs encompassing two years of secondary workforce  
3 education and two years of postsecondary workforce education;

4 (15) In cooperation with the higher education coordinating board,  
5 facilitate transfer of credit policies and agreements between private  
6 training institutions and institutions of the state training system;

7 (16) Develop policy objectives for the workforce investment act,  
8 P.L. 105-220, or its successor; develop coordination criteria for  
9 activities under the act with related programs and services provided by  
10 state and local education and training agencies; and ensure that  
11 entrepreneurial training opportunities are available through programs  
12 of each local workforce investment board in the state;

13 (17) Make recommendations to the commission of student assessment,  
14 the state board of education, and the superintendent of public  
15 instruction, concerning basic skill competencies and essential core  
16 competencies for K-12 education. Basic skills for this purpose shall  
17 be reading, writing, computation, speaking, and critical thinking,  
18 essential core competencies for this purpose shall be English, math,  
19 science/technology, history, geography, and critical thinking. The  
20 board shall monitor the development of and provide advice concerning  
21 secondary curriculum which integrates vocational and academic  
22 education;

23 (18) Establish and administer programs for marketing and outreach  
24 to businesses and potential program participants;

25 (19) Facilitate the location of support services, including but not  
26 limited to, child care, financial aid, career counseling, and job  
27 placement services, for students and trainees at institutions in the  
28 state training system, and advocate for support services for trainees  
29 and students in the state training system;

30 (20) Facilitate private sector assistance for the state training  
31 system, including but not limited to: Financial assistance, rotation  
32 of private and public personnel, and vocational counseling;

33 (21) Facilitate the development of programs for school-to-work  
34 transition that combine classroom education and on-the-job training,  
35 including entrepreneurial education and training, in industries and  
36 occupations without a significant number of apprenticeship programs;

37 (22) Include in the planning requirements for local workforce  
38 investment boards a requirement that the local workforce investment

1 boards specify how entrepreneurial training is to be offered through  
2 the one-stop system required under the workforce investment act, P.L.  
3 105-220, or its successor;

4 (23) Encourage and assess progress for the equitable representation  
5 of racial and ethnic minorities, women, and people with disabilities  
6 among the students, teachers, and administrators of the state training  
7 system. Equitable, for this purpose, shall mean substantially  
8 proportional to their percentage of the state population in the  
9 geographic area served. This function of the board shall in no way  
10 lessen more stringent state or federal requirements for representation  
11 of racial and ethnic minorities, women, and people with disabilities;

12 (24) Participate in the planning and policy development of governor  
13 set-aside grants under P.L. 97-300, as amended;

14 (25) Administer veterans' programs, licensure of private vocational  
15 schools, the job skills program, and the Washington award for  
16 vocational excellence;

17 (26) Allocate funding from the state job training trust fund;

18 (27) Work with the director of community, trade, and economic  
19 development and the economic development commission to ensure  
20 coordination (~~((between))~~) among workforce training priorities, the long-  
21 term economic development strategy of the economic development

8 (1) The state comprehensive plan for workforce training and  
9 education shall be updated every two years and presented to the  
10 governor and the appropriate legislative policy committees. Following  
11 public hearings, the legislature shall, by concurrent resolution,  
12 approve or recommend changes to the initial plan and the updates. The  
13 plan shall then become the state's workforce training policy unless

1 (e) Collaboration with associate development organizations in  
2 regional planning efforts involving combined strategies around  
3 workforce development and economic development policies and programs.  
4 Combined planning efforts shall include, but not be limited to,  
5 assistance to industry clusters in the area.

6 (3) The board shall work with workforce development councils to  
7 develop implementation and funding strategies for purposes of this  
8 section.

9 **Sec. 9.** RCW 43.162.020 and 2007 c 232 s 4 are each amended to read  
10 as follows:

11 The Washington state economic development commission shall:

12 (1) Concentrate its major efforts on planning, coordination,  
13 evaluation, policy analysis, and recommending improvements to the  
14 state's economic development system using, but not limited to, the  
15 "Next Washington" plan and the global competitiveness council  
16 recommendations;

17 (2) Develop and maintain on a biennial basis a state comprehensive  
18 plan for economic development, including but not limited to goals,

20 development organizations to increase the support for and coordination

23 regional area shall be broadly representative of community and economic  
24 interests. The organization shall be capable of identifying key  
25 economic and community development problems, developing appropriate  
26 solutions, and mobilizing broad support for recommended initiatives.  
27 The contracting organization shall work with and include local  
28 governments, local chambers of commerce, workforce development

12 (c) Marketing Washington and local areas as excellent locations to

18 (e) Providing business retention and expansion services, including

4 commission in the establishment of such uniform data as is needed to

6 development programs and expenditures. In cooperation with other  
7 local, regional, and state planning efforts, contracting organizations  
8 may provide insight into the needs of target industry clusters,  
9 business expansion plans, early detection of potential relocations or  
10 layoffs, training needs, and other appropriate economic information;
