1 AN ACT Relating to performance-based contracts for the provision of
2 child welfare services; amending RCW 74.13.020, 74.15.010, 74.15.020,

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** A new section is added to chapter 74.13 RCW
9 to read as follows:

10 The legislature declares that the safety and well-being of children
11 and families is essential to the social and economic health of
12 Washington. It is the duty of the state to provide children at risk of
13 out-of-home placement and their families with reasonable opportunities
14 to access supportive services that enhance their safety and well-being.
15 The legislature intends the new programmatic and administrative changes
16 required in this act to be accomplished in conformance with this
17 foregoing principle.

18 The legislature finds that research in the area of child safety and
19 well-being supports the conclusion that a restructuring of the
20 administration and delivery of child welfare services through the use
21 of performance-based contracts can enhance safety and well-being, when
22 done so in a careful, well-planned and collaborative manner.

23 The legislature intends that the execution of performance-based
24 contracts which transfer the delivery of child welfare services to
25 entities other than the department be done without restricting who may
26 seek to participate in the procurement process of the contracts. The
27 legislature intends that the department shall retain those positions
28 necessary to provide child protective and investigative services and to
29 administer performance-based contracts.

30 The legislature, in creating the committee in section 7 of this
31 act, is establishing the mechanism to design, in collaboration with the
32 department, the transition to performance-based contracts in the
33 delivery of out-of-home care and case management services.

34 **Sec. 2.** RCW 74.13.020 and 1999 c 267 s 7 are each amended to read
35 as follows:

1 (~~As used in Title 74 RCW, child welfare services shall be defined~~
2 ~~as public social services including adoption services which strengthen,~~

19 ~~The department's duty to provide services to homeless families with~~
20 ~~children is set forth in RCW 43.20A.790 and in appropriations provided~~

22 For purposes of this chapter:

23 (1) "Case management" means those services, including permanency
24 services, to a child for whom the department has legal custody,
25 including caseworker-child visits, family visits, the convening of
26 family group conferences, the development and revision of the case
27 plan, the coordination and monitoring of services needed by the child
28 and family, and the assumption of court-related duties, including
29 preparing court reports, attending judicial hearings and permanency
30 hearings, and ensuring that the child is progressing toward permanency
31 within state and federal mandates, including the Indian child welfare
32 act.

33 (2) "Child" means a person less than eighteen years of age.

34 (3) "Child protective services" has the same meaning as in RCW
35 26.44.020.

36 (4) "Child welfare services" means social services including out-
37 of-home care, case management, and adoption services which strengthen,

1 supplement, or substitute for, parental care and supervision for the
2 purpose of:

3 (a) Preventing or remedying, or assisting in the solution of
4 problems which may result in families in conflict, or the neglect,
5 abuse, exploitation, or criminal behavior of children;

6 (b) Protecting and caring for dependent or neglected children;

7 (c) Assisting children who are in conflict with their parents, and
8 assisting parents who are in conflict with their children, with
9 services designed to resolve such conflicts;

10 (d) Protecting and promoting the welfare of children, including the
11 strengthening of their own homes where possible, or, where needed;

12 (e) Providing adequate care of children away from their homes in
13 foster family homes or day care or other child care agencies or
14 facilities.

15 "Child welfare services" does not include child protection
16 services.

17 (5) "Committee" means the child welfare transformation design
18 committee.

19 (6) "Department" means the department of social and health
20 services.

21 (7) "Outcomes" means a statistically significant change in the
22 service or services a supervising agency is assigned in a performance-
23 based contract, in time periods established in the contract.

24 (8) "Out-of-home care services" means services provided after the
25 shelter care hearing to or for children in out-of-home care, as that
26 term is defined in RCW 13.34.030, and their families, including the
27 recruitment, training, and management of foster parents, the
28 recruitment of adoptive families, and the facilitation of the adoption
29 process, family reunification, independent living, emergency shelter,
30 residential group care, and foster care, including relative placement.

31 (9) "Performance-based contracting" means the structuring of all
32 aspects of the procurement of services around the purpose of the work
33 to be performed and the desired results with the contract requirements
34 set forth in clear, specific, and objective terms with measurable
35 outcomes. Contracts shall also include provisions that link the
36 performance of the contractor to the level and timing of reimbursement.

37 (10) "Permanency services" means long-term services provided to

1 secure a child's safety, permanency, and well-being, including foster
2 care services, family reunification services, adoption services, and
3 preparation for independent living services.

4 (11) "Supervising agency" means an agency licensed by the state
5 under RCW 74.15.090, or an Indian tribe under RCW 74.15.190, that has
6 entered into a performance-based contract with the department to
7 provide child welfare services. "Supervising agency" also includes the
8 department under section 3(4) of this act.

9 NEW SECTION. Sec. 3. A new section is added to chapter 74.13 RCW
10 to read as follows:

11 (1) On and after December 1, 2010, the department shall begin to
12 convert its current contracts with child-placing agencies into
13 performance-based contracts to provide child welfare services in this
14 state.

15 (2) On and after July 1, 2014:

16 (a) All child welfare services for children for whom the department
17 has legal custody shall be provided by supervising agencies with whom
18 the department has entered into performance-based contracts; and

19 (b) Except as provided in subsection (4) of this section, and
20 notwithstanding any law to the contrary, the department may not
21 directly provide child welfare services.

22 (3) On and after July 1, 2014, the department is responsible for
23 only the following:

24 (a) Monitoring the quality of services for which the department
25 contracts under this chapter; and

26 (b) Ensuring that the services are provided in accordance with
27 federal law and the laws of this state, including the Indian child
28 welfare act.

29 (4) On and after July 1, 2014, the department may provide child
30 welfare services only in an emergency or as a provider of last resort.
31 The department shall adopt rules describing the circumstances under
32 which the department may provide those services. For purposes of this
33 section, "provider of last resort" means the department is unable to
34 contract with a private agency to provide child welfare services in a
35 particular geographic area or, after entering into a contract with a
36 private agency, either the contractor or the department precipitously
37 terminates the contract.

1 (5) For purposes of this chapter, on and after July 1, 2010,
2 performance-based contracts shall be structured to hold the supervising
3 agencies accountable for achieving the following goals in order of
4 importance: Child safety; reunification of the child with the child's
5 parents; child permanency; and child well-being.

6 NEW SECTION. **Sec. 4.** A new section is added to chapter 74.13 RCW
7 to read as follows:

8 Except for Indian tribes, performance-based contracts with private
9 nonprofit entities who otherwise meet the definition of supervising
10 agency shall be preferred.

11 NEW SECTION. **Sec. 5.** A new section is added to chapter 43.10 RCW
12 to read as follows:

13 The office of the attorney general shall provide, or cause to be
14 provided, legal services in only dependency or termination of parental
15 rights matters to supervising agencies with whom the department of
16 social and health services has entered into performance-based contracts
17 to provide child welfare services as soon as the contracts become
18 effective.

19 NEW SECTION. **Sec. 6.** A new section is added to chapter 74.13 RCW
20 to read as follows:

21 As the number of persons employed as child welfare services
22 caseworkers and staff in the children's administration declines as a
23 result of voluntary employee departure, those positions referenced in
24 this section shall not be filled by the children's administration,
25 except in extreme emergent situations, and the department shall
26 increase its referrals to supervising agencies on a pro rata or greater
27 basis.

28 NEW SECTION. **Sec. 7.** A new section is added to chapter 74.13 RCW
29 to read as follows:

30 (1)(a) The child welfare transformation design committee is
31 established, with members as provided in this subsection.

32 (i) Four private agencies that, as of the effective date of this
33 section, provide child welfare services to children and families
34 referred to them by the department. Two agencies must be headquartered

1 in western Washington and two must be headquartered in eastern
2 Washington. Two agencies must have an annual budget of at least one
3 million state-contracted dollars and two must have an annual budget of
4 less than one million state-contracted dollars;

5 (ii) The assistant secretary of the children's administration in
6 the department;

7 (iii) Two regional administrators in the children's administration
8 selected by the assistant secretary, one from one of the department's
9 administrative regions one or two, and one from one of the department's
10 administrative regions three, four, five, or six;

11 (iv) The administrator for the division of licensed resources in
12 the children's administration;

13 (v) Two nationally recognized experts in performance-based
14 contracts;

15 (vi) The attorney general or his or her designee;

16 (vii) A representative of the collective bargaining unit that
17 represents the largest number of employees in the children's
18 administration;

19 (viii) A representative from the office of the family and
20 children's ombudsman;

21 (ix) Four representatives from federally recognized Indian tribes,
22 two of which operate child welfare programs;

23 (x) Two present or former superior court judges with significant
24 experience in dependency matters, selected by the superior court
25 judge's association; and

26 (xi) One representative from partners for our children affiliated
27 with the University of Washington school of social work.

28 (b) The president of the senate and the speaker of the house of
29 representatives shall jointly appoint the members under (a)(i) and (v)
30 of this subsection.

31 (c) The representatives from partners for our children shall
32 convene the initial meeting of the committee no later than June 15,
33 2009.

34 (d) The chair or cochairs of the committee shall be selected from
35 among its membership by a majority vote of those present at the initial
36 meeting.

37 (2) The committee shall establish a transition plan containing

1 recommendations to the legislature consistent with this section for the
2 provision of child welfare services by child-placing agencies pursuant
3 to section 3 of this act.

4 (3) The plan shall include the following:

5 (a) A model or framework for performance-based contracts to be used
6 by the department that clearly defines:

7 (i) The target population;

8 (ii) The contract referral and exit criteria;

9 (iii) The child welfare services including the use of evidence-
10 based services and practices to be provided by the contractor;

11 (iv) The roles and responsibilities of public and private agency
12 workers in key case decisions;

13 (v) Contract performance and outcomes;

14 (vi) How to measure whether each contractor has met the goals
15 listed in section 3(5) of this act; and

16 (vii) Incentives to meet program goals;

17 (b) A method by which the department will substantially reduce its
18 current number of contracts for child welfare services;

19 (c) A method or methods by which clients will access community-
20 based services, how private supervising agencies will engage other
21 services or form local service networks, develop subcontracts, and
22 share information and supervision of children;

23 (d) Contract monitoring and evaluation procedures that will ensure
24 that children and families are receiving timely and quality services
25 and that contract terms are being implemented;

26 (e) A method or methods by which to ensure that the children's
27 administration has sufficiently trained and experienced staff to
28 monitor and manage performance-based contracts;

29 (f) A process by which to expand the capacity of supervising and
30 other private agencies to meet the service needs of children and
31 families in a performance-based contractual arrangement;

32 (g) A method or methods by which supervising and other private
33 agencies can expand services in underserved areas of the state;

34 (h) The appropriate amounts and procedures for the reimbursement of
35 supervising agencies given the proposed services restructuring;

36 (i) A method by which to access and enhance existing data systems
37 to include contract performance information;

38 (j) A financing arrangement for the contracts that examines:

1 (i) The use of case rates or performance-based fee-for-service
2 contracts that include incentive payments or payment schedules that
3 link reimbursement to results; and

4 (ii) Ways to reduce a contractor's financial risk that could
5 jeopardize the solvency of the contractor, including the use of a risk-
6 reward corridor that limits risk of loss and potential profits or the
7 establishment of a statewide risk pool;

8 (k) A description of how the transition will impact the state's
9 ability to obtain federal funding and examine options to further
10 maximize federal funding opportunities and increased flexibility;

11 (l) A description of the costs of the transition, the initial
12 start-up costs and the mechanisms to periodically assess the overall
13 adequacy of funds and the fiscal impact of the changes; and

14 (m) Identification of any statutory and regulatory revisions
15 necessary to accomplish the transition.

16 (4) The committee shall also prepare as part of the plan a
17 recommendation as to how to implement the changes in this chapter
18 across the state in three stages so that the full implementation of
19 this chapter is achieved no later than July 1, 2014.

20 (5) The committee shall report quarterly on its progress, beginning
21 on June 30, 2009, to the legislative children's oversight committee
22 established in RCW 44.04.220. The committee shall report on its
23 progress in meeting its duties under subsections (2) and (3) of this
24 section and on any other matters the committee or the legislative
25 children's oversight committee deems appropriate. The portion of the
26 plan required in subsection (4) of this section shall be due to the
27 legislative children's oversight committee on or before June 1, 2010.
28 The reports shall be in written form.

29 (6) The committee, by majority vote, may establish advisory
30 committees as it deems necessary.

31 (7) All state executive branch agencies shall cooperate with the
32 committee and provide timely information as the chair or cochairs may
33 request. Cooperation by the children's administration must include
34 developing and scheduling training for supervising agencies to access
35 data and information necessary to implement and monitor the contracts.

36 (8) It is expected that the administrative costs for the committee
37 will be supported through private funds.

1 (9) Staff support for the committee shall be provided jointly by
2 partners for our children and legislative staff.

3 (10) The committee is subject to chapters 42.30 (open public
4 meetings act) and 42.52 (ethics in public service) RCW.

5 (11) This section expires July 1, 2013.

6 **Sec. 8.** RCW 74.15.010 and 1995 c 302 s 2 are each amended to read
7 as follows:

8 The purpose of chapter 74.15 RCW and RCW 74.13.031 is:

9 (1) To safeguard the health, safety, and well-being of children,
10 expectant mothers and developmentally disabled persons receiving care
11 away from their own homes, which is paramount over the right of any
12 person to provide care;

13 (2) To strengthen and encourage family unity and to sustain
14 parental rights and responsibilities to the end that foster care is
15 provided only when a child's family, through the use of all available
16 resources, is unable to provide necessary care;

17 (3) To promote the development of a sufficient number and variety
18 of adequate ((child-care)) foster family homes and maternity-care
19 facilities, both public and private, through the cooperative efforts of
20 public and ((voluntary)) supervising agencies and related groups;

21 (4) To provide consultation to agencies caring for children,
22 expectant mothers or developmentally disabled persons in order to help
23 them to improve their methods of and facilities for care;

24 (5) To license agencies as defined in RCW 74.15.020 and to assure
25 the users of such agencies, their parents, the community at large and
26 the agencies themselves that adequate minimum standards are maintained
27 by all agencies caring for children, expectant mothers and
28 developmentally disabled persons.

29 **Sec. 9.** RCW 74.15.020 and 2007 c 412 s 1 are each amended to read
30 as follows:

31 For the purpose of this chapter and RCW 74.13.031, and unless
32 otherwise clearly indicated by the context thereof, the following terms
33 shall mean:

34 (1) "Agency" means any person, firm, partnership, association,
35 corporation, or facility which receives children, expectant mothers, or
36 persons with developmental disabilities for control, care, or

1 maintenance outside their own homes, or which places, arranges the
2 placement of, or assists in the placement of children, expectant
3 mothers, or persons with developmental disabilities for foster care or
4 placement of children for adoption, and shall include the following
5 irrespective of whether there is compensation to the agency or to the
6 children, expectant mothers or persons with developmental disabilities
7 for services rendered:

8 (a) "Child-placing agency" means an agency which places a child or
9 children for temporary care, continued care, or for adoption;

10 (b) "Community facility" means a group care facility operated for
11 the care of juveniles committed to the department under RCW 13.40.185.
12 A county detention facility that houses juveniles committed to the
13 department under RCW 13.40.185 pursuant to a contract with the
14 department is not a community facility;

15 (c) "Crisis residential center" means an agency which is a
16 temporary protective residential facility operated to perform the
17 duties specified in chapter 13.32A RCW, in the manner provided in RCW
18 74.13.032 through 74.13.036;

19 (d) "Emergency respite center" is an agency that may be commonly
20 known as a crisis nursery, that provides emergency and crisis care for
21 up to seventy-two hours to children who have been admitted by their
22 parents or guardians to prevent abuse or neglect. Emergency respite
23 centers may operate for up to twenty-four hours a day, and for up to
24 seven days a week. Emergency respite centers may provide care for
25 children ages birth through seventeen, and for persons eighteen through
26 twenty with developmental disabilities who are admitted with a sibling
27 or siblings through age seventeen. Emergency respite centers may not
28 substitute for crisis residential centers or HOPE centers, or any other
29 services defined under this section, and may not substitute for
30 services which are required under chapter 13.32A or 13.34 RCW;

31 (e) "Foster-family home" means an agency which regularly provides
32 care on a twenty-four hour basis to one or more children, expectant
33 mothers, or persons with developmental disabilities in the family abode
34 of the person or persons under whose direct care and supervision the
35 child, expectant mother, or person with a developmental disability is
36 placed;

37 (f) "Group-care facility" means an agency, other than a foster-

1 family home, which is maintained and operated for the care of a group
2 of children on a twenty-four hour basis;

3 (g) "HOPE center" means an agency licensed by the secretary to
4 provide temporary residential placement and other services to street
5 youth. A street youth may remain in a HOPE center for thirty days
6 while services are arranged and permanent placement is coordinated. No
7 street youth may stay longer than thirty days unless approved by the
8 department and any additional days approved by the department must be
9 based on the unavailability of a long-term placement option. A street
10 youth whose parent wants him or her returned to home may remain in a
11 HOPE center until his or her parent arranges return of the youth, not
12 longer. All other street youth must have court approval under chapter
13 13.34 or 13.32A RCW to remain in a HOPE center up to thirty days;

14 (h) "Maternity service" means an agency which provides or arranges
15 for care or services to expectant mothers, before or during
16 confinement, or which provides care as needed to mothers and their
17 infants after confinement;

18 (i) "Responsible living skills program" means an agency licensed by
19 the secretary that provides residential and transitional living
20 services to persons ages sixteen to eighteen who are dependent under
21 chapter 13.34 RCW and who have been unable to live in his or her
22 legally authorized residence and, as a result, the minor lived outdoors
23 or in another unsafe location not intended for occupancy by the minor.
24 Dependent minors ages fourteen and fifteen may be eligible if no other
25 placement alternative is available and the department approves the
26 placement;

27 (j) "Service provider" means the entity that operates a community
28 facility.

29 (2) "Agency" shall not include the following:

30 (a) Persons related to the child, expectant mother, or person with
31 developmental disability in the following ways:

32 (i) Any blood relative, including those of half-blood, and
33 including first cousins, second cousins, nephews or nieces, and persons
34 of preceding generations as denoted by prefixes of grand, great, or
35 great-great;

36 (ii) Stepfather, stepmother, stepbrother, and stepsister;

37 (iii) A person who legally adopts a child or the child's parent as

1 well as the natural and other legally adopted children of such persons,
2 and other relatives of the adoptive parents in accordance with state
3 law;

4 (iv) Spouses of any persons named in (i), (ii), or (iii) of this
5 subsection (2)(a), even after the marriage is terminated;

6 (v) Relatives, as named in (i), (ii), (iii), or (iv) of this
7 subsection (2)(a), of any half sibling of the child; or

8 (vi) Extended family members, as defined by the law or custom of
9 the Indian child's tribe or, in the absence of such law or custom, a
10 person who has reached the age of eighteen and who is the Indian
11 child's grandparent, aunt or uncle, brother or sister, brother-in-law
12 or sister-in-law, niece or nephew, first or second cousin, or
13 stepparent who provides care in the family abode on a twenty-four-hour
14 basis to an Indian child as defined in 25 U.S.C. Sec. 1903(4);

15 (b) Persons who are legal guardians of the child, expectant mother,
16 or persons with developmental disabilities;

17 (c) Persons who care for a neighbor's or friend's child or
18 children, with or without compensation, where the parent and person
19 providing care on a twenty-four-hour basis have agreed to the placement
20 in writing and the state is not providing any payment for the care;

21 (d) A person, partnership, corporation, or other entity that
22 provides placement or similar services to exchange students or
23 international student exchange visitors or persons who have the care of
24 an exchange student in their home;

25 (e) A person, partnership, corporation, or other entity that
26 provides placement or similar services to international children who
27 have entered the country by obtaining visas that meet the criteria for
28 medical care as established by the United States citizenship and
29 immigration (~~(and naturalization)~~) services, or persons who have the
30 care of such an international child in their home;

31 (f) Schools, including boarding schools, which are engaged
32 primarily in education, operate on a definite school year schedule,
33 follow a stated academic curriculum, accept only school-age children
34 and do not accept custody of children;

35 (g) Hospitals licensed pursuant to chapter 70.41 RCW when
36 performing functions defined in chapter 70.41 RCW, nursing homes
37 licensed under chapter 18.51 RCW and boarding homes licensed under
38 chapter 18.20 RCW;

1 (h) Licensed physicians or lawyers;

2 (i) Facilities approved and certified under chapter 71A.22 RCW;

3 (j) Any agency having been in operation in this state ten years
4 prior to June 8, 1967, and not seeking or accepting moneys or
5 assistance from any state or federal agency, and is supported in part
6 by an endowment or trust fund;

7 (k) Persons who have a child in their home for purposes of
8 adoption, if the child was placed in such home by a licensed child-
9 placing agency, an authorized public or tribal agency or court or if a
10 replacement report has been filed under chapter 26.33 RCW and the
11 placement has been approved by the court;

15 (17) "Supervising agency" means an agency licensed by the state
16 under RCW 74.15.090 or an Indian tribe under RCW 74.15.190 with whom
17 the department has entered into a performance-based contract to provide
18 child welfare services as defined in RCW 74.13.020. "Supervising
19 agency" also includes the department under section 3(4) of this act.

22 (1)(a) When a child is taken into custody, the court shall hold a
23 shelter care hearing within seventy-two hours, excluding Saturdays,
24 Sundays, and holidays. The primary purpose of the shelter care hearing
25 is to determine whether the child can be immediately and safely
26 returned home while the adjudication of the dependency is pending.

27 (b) Any parent, guardian, or legal custodian who for good cause is
28 unable to attend the shelter care hearing may request that a subsequent

16 agency the least disruptive and most family-like setting that meets the
17 needs of the child;

18 (f) Whether it is in the best interest of the child to remain
19 enrolled in the school, developmental program, or child care the child
20 was in prior to placement and what efforts have been made to maintain
21 the child in the school, program, or child care if it would be in the
22 best interest of the child to remain in the same school, program, or
23 child care;

24 (g) Appointment of a guardian ad litem or attorney;

25 (h) Whether the child is or may be an Indian child as defined in 25
26 U.S.C. Sec. 1903, whether the provisions of the Indian child welfare
27 act apply, and whether there is compliance with the Indian child
28 welfare act, including notice to the child's tribe;

29 (i) Whether, as provided in RCW 26.44.063, restraining orders, or
30 orders expelling an allegedly abusive household member from the home of
31 a nonabusive parent, guardian, or legal custodian, will allow the child
32 to safely remain in the home;

33 (j) Whether any orders for examinations, evaluations, or immediate
34 services are needed. The court may not order a parent to undergo
35 examinations, evaluation, or services at the shelter care hearing
36 unless the parent agrees to the examination, evaluation, or service;

8 continues until a permanency planning goal is achieved or dependency is

9 recommendation to the court regarding visitation between parent and
10 child pending a fact-finding hearing on the termination petition. The
11 supervising agency shall not be required to develop a plan of services
12 for the parents or provide services to the parents if the court orders
13 a termination petition be filed. However, reasonable efforts to ensure
14 visitation and contact between siblings shall be made unless there is
15 reasonable cause to believe the best interests of the child or siblings
16 would be jeopardized.

17 (3) Permanency planning goals should be achieved at the earliest
18 possible date. If the child has been in out-of-home care for fifteen
19 of the most recent twenty-two months, the court shall require the
20 ((department)) supervising agency to file a petition seeking
21 termination of parental rights in accordance with RCW
22 13.34.145(3)(b)(vi). In cases where parental rights have been
23 terminated, the child is legally free for adoption, and adoption has
24 been identified as the primary permanency planning goal, it shall be a
25 goal to complete the adoption within six months following entry of the
26 termination order.

27 (4) If the court determines that the continuation of reasonable
28 efforts to prevent or eliminate the need to remove the child from his
29 or her home or to safely return the child home should not be part of
30 the permanency plan of care for the child, reasonable efforts shall be
31 made to place the child in a timely manner and to complete whatever
32 steps are necessary to finalize the permanent placement of the child.

33 (5) The identified outcomes and goals of the permanency plan may
34 change over time based upon the circumstances of the particular case.

35 (6) The court shall consider the child's relationships with the
36 child's siblings in accordance with RCW 13.34.130(3).

37 (7) For purposes related to permanency planning:

1 (a) "Guardianship" means a dependency guardianship or a legal
2 guardianship pursuant to chapter 11.88 RCW or equivalent laws of
3 another state or a federally recognized Indian tribe.

4 (b) "Permanent custody order" means a custody order entered
5 pursuant to chapter 26.10 RCW.

6 (c) "Permanent legal custody" means legal custody pursuant to
7 chapter 26.10 RCW or equivalent laws of another state or a federally
8 recognized Indian tribe.

9 **Sec. 26.** RCW 13.34.138 and 2007 c 413 s 8 and 2007 c 410 s 1 are
10 each reenacted and amended to read as follows:

11 (1) Except for children whose cases are reviewed by a citizen
12 review board under chapter 13.70 RCW, the status of all children found
13 to be dependent shall be reviewed by the court at least every six
14 months from the beginning date of the placement episode or the date
15 dependency is established, whichever is first. The purpose of the
16 hearing shall be to review the progress of the parties and determine
17 whether court supervision should continue.

18 (a) The initial review hearing shall be an in-court review and
19 shall be set six months from the beginning date of the placement
20 episode or no more than ninety days from the entry of the disposition
21 order, whichever comes first. The requirements for the initial review
22 hearing, including the in-court review requirement, shall be

26 grant party status to any individual not already a party to the
27 dependency proceeding, create an entitlement to services or a duty on
28 the part of the ((department—~~or~~)) supervising agency to provide
29 services, or create judicial authority to order the provision of
30 services to any person other than for the express purposes of this
31 section or RCW 13.34.025 or if the services are unavailable or
32 unsuitable or the person is not eligible for such services.

33 (c) If the child is not returned home, the court shall establish in
34 writing:

35 (i) Whether the supervising agency is making reasonable efforts to
36 provide services to the family and eliminate the need for placement of
37 the child. If additional services, including housing assistance, are

1 needed to facilitate the return of the child to the child's parents,
2 the court shall order that reasonable services be offered specifying
3 such services;

4 (ii) Whether there has been compliance with the case plan by the
5 child, the child's parents, and the supervising agency supervising the

14 adequately meets all physical, emotional, and educational needs;

15 (vii) Whether preference has been given to placement with the
16 child's relatives;

17 (viii) Whether both in-state and, where appropriate, out-of-state
18 placements have been considered;

19 (ix) Whether the parents have visited the child and any reasons why
20 visitation has not occurred or has been infrequent;

21 (x) Whether terms of visitation need to be modified;

22 (xi) Whether the court-approved long-term permanent plan for the
23 child remains the best plan for the child;

24 (xii) Whether any additional court orders need to be made to move
25 the case toward permanency; and

26 (xiii) The projected date by which the child will be returned home
27 or other permanent plan of care will be implemented.

28 (d) The court at the review hearing may order that a petition
29 seeking termination of the parent and child relationship be filed.

30 (3)(a) In any case in which the court orders that a dependent child
31 may be returned to or remain in the child's home, the in-home placement
32 shall be contingent upon the following:

33 (i) The compliance of the parents with court orders related to the
34 care and supervision of the child, including compliance with (~~an~~) the
35 supervising agency's case plan; and

36 (ii) The continued participation of the parents, if applicable, in

19 should be changed, a termination petition should be filed, or other
20 action is warranted. The best interests of the child shall be the
21 court's primary consideration in the review hearing.

22 (4) The court's ability to order housing assistance under RCW
23 13.34.130 and this section is: (a) Limited to cases in which
24 homelessness or the lack of adequate and safe housing is the primary
25 reason for an out-of-home placement; and (b) subject to the
26 availability of funds appropriated for this specific purpose.

27 (5) The court shall consider the child's relationship with siblings
28 in accordance with RCW 13.34.130(3).

30 as follows:

31 (1) The purpose of a permanency planning hearing is to review the
32 permanency plan for the child, inquire into the welfare of the child
33 and progress of the case, and reach decisions regarding the permanent
34 placement of the child.

35 (a) A permanency planning hearing shall be held in all cases where
36 the child has remained in out-of-home care for at least nine months and
37 an adoption decree, guardianship order, or permanent custody order has

1 not previously been entered. The hearing shall take place no later
2 than twelve months following commencement of the current placement
3 episode.

4 (b) Whenever a child is removed from the home of a dependency
5 guardian or long-term relative or foster care provider, and the child

19 permanency plan, whether reasonable efforts were made by the
20 supervising agency to achieve the goal of the permanency plan, and the
21 circumstances which prevent the child from any of the following:

3 (1) The provisions of this section shall apply when a court orders
4 a party to undergo an alcohol or substance abuse diagnostic

6 (2) The facility conducting the investigation and evaluation shall
7 make a written report to the court stating its findings and
8 recommendations including family-based services or treatment when
9 appropriate. If its findings and recommendations support treatment, it
10 shall also recommend a treatment plan setting out:

- 11 (a) Type of treatment;
- 12 (b) Nature of treatment;
- 13 (c) Length of treatment;
- 14 (d) A treatment time schedule; and
- 15 (e) Approximate cost of the treatment.

26 legal custodian with the petition and shall be in substantially the

29 A petition for termination of parental rights has been filed
30 against you. You have important legal rights and you must take
31 steps to protect your interests. This petition could result in
32 permanent loss of your parental rights.

33 1. You have the right to a fact-finding hearing before
34 a judge.

35 2. You have the right to have a lawyer represent you at
36 the hearing. A lawyer can look at the files in your case, talk
37 to the (~~department of social and health services~~) supervising

1 agency and other agencies, tell you about the law, help you
2 understand your rights, and help you at hearings. If you
3 cannot afford a lawyer, the court will appoint one to represent
4 you. To get a court-appointed lawyer you must contact:

6 3. At the hearing, you have the right to speak on your
7 own behalf, to introduce evidence, to examine witnesses, and to
8 receive a decision based solely on the evidence presented to
9 the judge.

10 You should be present at this hearing.

11 You may call (insert agency) for more information
12 about your child. The agency's name and telephone number are
13 (insert name and telephone number)."

14 **Sec. 32.** RCW 13.34.210 and 2003 c 227 s 8 are each amended to read
15 as follows:

16 If, upon entering an order terminating the parental rights of a
17 parent, there remains no parent having parental rights, the court shall
18 commit the child to the custody of ~~((the department or to))~~ a
19 ~~((licensed child placing))~~ supervising agency willing to accept custody
20 for the purpose of placing the child for adoption. If an adoptive home
21 has not been identified, the ~~((department or))~~ supervising agency shall
22 place the child in a licensed foster home, or take other suitable
23 measures for the care and welfare of the child. The custodian shall
24 have authority to consent to the adoption of the child consistent with
25 chapter 26.33 RCW, the marriage of the child, the enlistment of the

29 exists. This section does not create a cause of action against the
30 state, the department, the supervising agency, or its employees
31 concerning the original termination.

35 agency, may file a petition in juvenile court requesting that

35 history of the person.

36 (4) If the report contains a recommendation, opinion, or assertion
37 by the ((department)) supervising agency relating to injuries to a
38 child, the ((department)) supervising agency shall attach a summary of

1 the physician's report, prepared by the physician or the physician's
2 designee, relating to the recommendation, opinion, or assertion by the
3 department.

4 (5) If the report contains a recommendation, opinion, or assertion
5 by the ((department)) supervising agency relating to a home study,
6 licensing action, or background check information, the ((department))
7 supervising agency shall attach the document or documents upon which
8 that recommendation, opinion, or assertion is based.
