1 AN ACT Relating to facilitating voting for service and overseas
2 voters; amending RCW 29A.04.255, 29A.04.311, 29A.04.321, 29A.16.040,
3 29A.24.040, 29A.24.050, 29A.24.131, 29A.24.141, 29A.24.171, 29A.24.181,
4 29A.24.191, 29A.24.311, 29A.28.041, 29A.40.070, 29A.40.091, 29A.40.110,
5 29A.56.030, 29A.60.190, 29A.60.190, 29A.60.240, 29A.64.011, 29A.64.030,
6 29A.68.011, 29A.76.010, and 42.12.070; reenacting and amending RCW
7 29A.04.330, 29A.36.010, and 42.12.040; repealing RCW 29A.04.310,
8 29A.24.151, 29A.24.161, 29A.24.210, 29A.24.211, 29A.36.011, and
9 29A.40.150; prescribing penalties; providing effective dates; and
10 providing an expiration date.

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

12 **Sec. 1.** RCW 29A.04.255 and 2004 c 266 s 5 are each amended to read
13 as follows:

14 The secretary of state or a county auditor shall accept and file in
15 his or her office electronic ((~~faesimile~~)) transmissions of the
16 following documents:

- 17 (1) Declarations of candidacy;
- 18 (2) County canvass reports;
- 19 (3) Voters' pamphlet statements;

1 (4) Arguments for and against ballot measures that will appear in
2 a voters' pamphlet;

3 (5) Requests for recounts;

4 (6) Certification of candidates and measures by the secretary of
5 state;

6 (7) Direction by the secretary of state for the conduct of a
7 ((~~mandatory~~)) recount;

8 (8) Requests for ((~~absentee~~)) ballots;

9 (9) Any other election related document authorized by rule adopted
10 by the secretary of state under RCW ((~~29A.04.610~~)) 29A.04.611.

11 The acceptance by the secretary of state or the county auditor is
12 conditional upon the document being filed in a timely manner, being
13 legible, and otherwise satisfying the requirements of state law or
14 rules with respect to form and content.

15 ((~~If the original copy of a document must be signed and a copy of
16 the document is filed by facsimile transmission under this section, the
17 original copy must be subsequently filed with the official with whom
18 the facsimile was filed. The original copy must be filed by a deadline
19 established by the secretary by rule.~~)) The secretary may by rule
20 require that the original of any document, a copy of which is filed by
21 ((~~facsimile~~)) electronic transmission under this section, also be filed
22 by a deadline established by the secretary by rule.

23 **Sec. 2.** RCW 29A.04.311 and 2006 c 344 s 1 are each amended to read
24 as follows:

25 ((~~Nominating~~)) Primaries for general elections to be held in
26 November, and the election of precinct committee officers, must be held
27 on the ((~~third~~)) first Tuesday of the preceding August.

28 **Sec. 3.** RCW 29A.04.321 and 2009 c 413 s 2 are each amended to read
29 as follows:

30 (1) All state, county, city, town, and district general elections
31 for the election of federal, state, legislative, judicial, county,
32 city, town, and district officers, and for the submission to the voters
33 of the state, county, city, town, or district of any measure for their
34 adoption and approval or rejection, shall be held on the first Tuesday
35 after the first Monday of November, in the year in which they may be
36 called. A statewide general election shall be held on the first

1 Tuesday after the first Monday of November of each year. However, the
2 statewide general election held in odd-numbered years shall be limited
3 to (a) city, town, and district general elections as provided for in
4 RCW 29A.04.330, or as otherwise provided by law; (b) the election of
5 federal officers for the remainder of any unexpired terms in the
6 membership of either branch of the Congress of the United States; (c)
7 the election of state and county officers for the remainder of any
8 unexpired terms of offices created by or whose duties are described in
9 Article II, section 15, Article III, sections 16, 17, 19, 20, 21, 22,
10 and 23, and Article IV, sections 3 and 5 of the state Constitution and
11 RCW 2.06.080; (d) the election of county officers in any county
12 governed by a charter containing provisions calling for general county
13 elections at this time; and (e) the approval or rejection of state
14 measures, including proposed constitutional amendments, matters
15 pertaining to any proposed constitutional convention, initiative
16 measures and referendum measures proposed by the electorate, referendum
17 bills, and any other matter provided by the legislature for submission
18 to the electorate.

19 (2) A county legislative authority may call a special county
20 election by presenting a resolution to the county auditor prior to the
21 proposed election date. A special election called by the county
22 legislative authority shall be held on one of the following dates as
23 decided by such governing body:

- 24 (a) The second Tuesday in February;
25 (b) The fourth Tuesday in April;
26 (c) The day of the primary as specified by RCW 29A.04.311; or
27 (d) The first Tuesday after the first Monday in November.

28 (3) A resolution calling for a special election on a date set forth
29 in subsection (2)(a) and (b) of this section must be presented to the
30 county auditor at least ~~((forty-five))~~ forty-six days prior to the
31 election date. A resolution calling for a special election on a date
32 set forth in subsection (2)(c) ~~((or (d)))~~ of this section must be
33 presented to the county auditor ~~((at least eighty-four days prior to
34 the election date))~~ no later than the Friday immediately before the
35 first day of regular candidate filing. A resolution calling for a
36 special election on a date set forth in subsection (2)(d) of this
37 section must be presented to the county auditor no later than the day
38 of the primary.

1 (4) In addition to the dates set forth in subsection (2)(a) through
2 (d) of this section, a special election to validate an excess levy or
3 bond issue may be called at any time to meet the needs resulting from
4 fire, flood, earthquake, or other act of God. Such county special
5 election shall be noticed and conducted in the manner provided by law.

6 (5) This section shall supersede the provisions of any and all
7 other statutes, whether general or special in nature, having different
8 dates for such city, town, and district elections, the purpose of this
9 section being to establish mandatory dates for holding elections
10 (~~except for those elections held pursuant to a home rule charter~~
11 ~~adopted under Article XI, section 4 of the state Constitution~~). This
12 section shall not be construed as fixing the time for holding primary
13 elections, or elections for the recall of any elective public officer.

14 **Sec. 4.** RCW 29A.04.330 and 2009 c 413 s 4, 2009 c 144 s 3, and
15 2009 c 413 s 3 are each reenacted and amended to read as follows:

16 (1) All city, town, and district general elections shall be held
17 throughout the state of Washington on the first Tuesday following the
18 first Monday in November in the odd-numbered years.

19 This section shall not apply to:

20 (a) Elections for the recall of any elective public officer;

21 (b) Public utility districts, conservation districts, or district
22 elections at which the ownership of property within those districts is
23 a prerequisite to voting, all of which elections shall be held at the
24 times prescribed in the laws specifically applicable thereto;

25 (c) Consolidation proposals as provided for in RCW 28A.315.235 and
26 nonhigh capital fund aid proposals as provided for in chapter 28A.540
27 RCW; and

28 (d) Special flood control districts consisting of three or more
29 counties.

30 (2) The county auditor, as ex officio supervisor of elections, upon
31 request in the form of a resolution of the governing body of a city,
32 town, or district, presented to the auditor prior to the proposed
33 election date, may call a special election in such city, town, or
34 district, and for the purpose of such special election he or she may
35 combine, unite, or divide precincts. Such a special election shall be
36 held on one of the following dates as decided by the governing body:

37 (a) The second Tuesday in February;

1 (b) The fourth Tuesday in April;

2 (c) The day of the primary election as specified by RCW 29A.04.311;

3 or

4 (d) The first Tuesday after the first Monday in November.

5 (3) A resolution calling for a special election on a date set forth
6 in subsection (2)(a) and (b) of this section must be presented to the
7 county auditor at least (~~forty-five~~) forty-six days prior to the
8 election date. A resolution calling for a special election on a date
9 set forth in subsection (2)(c) (~~or (d)~~) of this section must be
10 presented to the county auditor (~~at least eighty-four days prior to~~
11 ~~the election date~~) no later than the Friday immediately before the
12 first day of regular candidate filing. A resolution calling for a
13 special election on a date set forth in subsection (2)(d) of this
14 section must be presented to the county auditor no later than the day
15 of the primary.

16 (4) In addition to subsection (2)(a) through (d) of this section,
17 a special election to validate an excess levy or bond issue may be
18 called at any time to meet the needs resulting from fire, flood,
19 earthquake, or other act of God, except that no special election may be
20 held between the first day for candidates to file for public office and
21 the last day to certify the returns of the general election other than
22 as provided in subsection (2)(c) and (d) of this section. Such special
23 election shall be conducted and notice thereof given in the manner
24 provided by law.

25 (5) This section shall supersede the provisions of any and all
26 other statutes, whether general or special in nature, having different
27 dates for such city, town, and district elections, the purpose of this
28 section being to establish mandatory dates for holding elections.

29 **Sec. 5.** RCW 29A.16.040 and 2004 c 266 s 10 are each amended to
30 read as follows:

31 The county legislative authority of each county in the state
32 hereafter formed shall, at their first session, divide their respective
33 counties into election precincts and establish the boundaries of the
34 precincts. The county auditor shall thereupon designate the voting
35 place for each such precinct or whether the precinct is a vote by mail
36 precinct.

1 (1) Precinct boundaries may be altered at any time as long as
2 sufficient time exists prior to a given election for the necessary
3 procedural steps to be honored. Except as permitted under subsection
4 (5) of this section, no precinct (~~boundaries~~) changes may be
5 (~~changed~~) made during the period starting (~~on the thirtieth~~)
6 fourteen days prior to the first day for candidates to file for the
7 primary election and ending with the day of the general election.

8 (2) The county legislative authority may establish by ordinance a
9 limitation on the maximum number of active registered voters in each
10 precinct within its jurisdiction. The limitation may be different for
11 precincts based upon the method of voting used for such precincts and
12 the number may be less than the number established by law, but in no
13 case may the number exceed that authorized by law.

14 (3) Precincts in which voting machines or electronic voting devices
15 are used may contain as many as nine hundred active registered voters.
16 The number of poll-site ballot counting devices at each polling place
17 is at the discretion of the auditor. The number of devices must be
18 adequate to meet the expected voter turnout.

19 (4) On petition of twenty-five or more voters resident more than
20 ten miles from any polling site, the county legislative authority shall
21 establish a separate voting precinct therefor.

22 (5) The county auditor shall temporarily adjust precinct boundaries
23 when a city or town annexes unincorporated territory to the city or
24 town, or whenever unincorporated territory is incorporated as a city or
25 town. The adjustment must be made as soon as possible after the
26 approval of the annexation or incorporation. The temporary adjustment
27 must be limited to the minimum changes necessary to accommodate the
28 addition of the territory to the city or town, or to establish the
29 eligible voters within the boundaries of the new city or town, and
30 remains in effect only until precinct boundary modifications reflecting
31 the annexation or incorporation are adopted by the county legislative
32 authority.

33 (6) In determining the number of active registered voters for the
34 purposes of this section, persons who are ongoing absentee voters under
35 RCW 29A.40.040 shall not be counted. Nothing in this subsection may be
36 construed as altering the vote tallying requirements of RCW 29A.60.230.

1 **Sec. 6.** RCW 29A.24.040 and 2006 c 344 s 5 are each amended to read
2 as follows:

3 A candidate may file his or her declaration of candidacy for an
4 office by electronic means on a system specifically designed and
5 authorized by a filing officer to accept filings.

6 (1) Filings that are received electronically must capture all
7 information specified in RCW 29A.24.031 (1) through (4).

8 (2) Electronic filing may begin at 9:00 a.m. the first (~~Monday in~~
9 ~~June~~) day of the filing period and continue through 4:00 p.m. the
10 (~~following Friday~~) last day of the filing period.

11 (~~(3) In case of special filing periods established in this~~
12 ~~chapter, electronic filings may be accepted beginning at 9:00 a.m. on~~
13 ~~the first day of the special filing period through 4:00 p.m. the last~~
14 ~~day of the special filing period.))~~

15 **Sec. 7.** RCW 29A.24.050 and 2006 c 344 s 6 are each amended to read
16 as follows:

17 Except where otherwise provided by this title, declarations of
18 candidacy for the following offices shall be filed during regular
19 business hours with the filing officer (~~no earlier than the first~~
20 ~~Monday in June~~) beginning the Monday two weeks before Memorial day and
21 (~~no later than~~) ending the following Friday in the year in which the
22 office is scheduled to be voted upon:

23 (1) Offices that are scheduled to be voted upon for full terms or
24 both full terms and short terms at, or in conjunction with, a state
25 general election; and

26 (2) Offices where a vacancy, other than a short term, exists that
27 has not been filled by election and for which an election to fill the
28 vacancy is required in conjunction with the next state general
29 election.

30 This section supersedes all other statutes that provide for a
31 different filing period for these offices.

32 **Sec. 8.** RCW 29A.24.131 and 2004 c 271 s 115 are each amended to
33 read as follows:

34 A candidate may withdraw his or her declaration of candidacy at any
35 time before the close of business on the (~~Thursday~~) Monday following
36 the last day for candidates to file under RCW 29A.24.050 by filing,

1 with the officer with whom the declaration of candidacy was filed, a
2 signed request that his or her name not be printed on the ballot.
3 There shall be no withdrawal period for declarations of candidacy filed
4 during special filing periods held under this title. ~~((The filing
5 officer may permit the withdrawal of a filing for the office of
6 precinct committee officer at the request of the candidate at any time
7 if no absentee ballots have been issued for that office and the ballots
8 for that precinct have not been printed. The filing officer may permit
9 the withdrawal of a filing for any elected office of a city, town, or
10 special district at the request of the candidate at any time before a
11 primary if the primary ballots for that city, town, or special district
12 have not been ordered.))~~ No filing fee may be refunded to any
13 candidate who withdraws under this section. Notice of the deadline for
14 withdrawal of candidacy and that the filing fee is not refundable shall
15 be given to each candidate at the time he or she files.

16 **Sec. 9.** RCW 29A.24.141 and 2004 c 271 s 162 are each amended to
17 read as follows:

18 A void in candidacy ~~((for a nonpartisan office))~~ occurs when an
19 election ~~((for such office, except for the short term,))~~ has been
20 scheduled and no valid declaration of candidacy has been filed for the
21 position or all persons filing such valid declarations of candidacy
22 have died or been disqualified.

23 **Sec. 10.** RCW 29A.24.171 and 2006 c 344 s 7 are each amended to
24 read as follows:

25 ~~((Filings for a nonpartisan office shall be reopened for a period
26 of three normal business days, such three-day period to be fixed by the
27 election officer with whom such declarations of candidacy are filed and
28 notice thereof given by notifying press, radio, and television in the
29 county and by such other means as may now or hereafter be provided by
30 law whenever before the eleventh Tuesday prior to a primary:~~

31 ~~(1) A void in candidacy occurs;~~

32 ~~(2) A vacancy occurs in any nonpartisan office leaving an unexpired
33 term to be filled by an election for which filings have not been held;~~

19 ~~of the primary, any of the following occur, filings shall be reopened~~
20 ~~for a period of three normal business days, such three-day period to be~~

6 The position shall appear on the general election ballots unless a
7 candidate for superior court judge is entitled to a certificate of
8 election pursuant to Article 4, section 29 of the state Constitution.

9 The candidate receiving a plurality of the votes cast for that
10 office in the general election shall be deemed elected. This section
11 does not apply to voids in candidacy in the office of precinct
12 committee officer, which are filled by appointment pursuant to RCW
13 29A.28.071.

14 **Sec. 12.** RCW 29A.24.191 and 2006 c 344 s 9 are each amended to
15 read as follows:

16 A scheduled election shall be lapsed, the office deemed stricken
17 from the ballot, no purported write-in votes counted, and no candidate
18 certified as elected, when((+

19 ~~(1) In an election for judge of the supreme court or superintendent~~
20 ~~of public instruction, a void in candidacy occurs on or after the~~

32 **Sec. 13.** RCW 29A.24.311 and 2004 c 271 s 117 are each amended to
33 read as follows:

34 Any person who desires to be a write-in candidate and have such
35 votes counted at a primary or election may file a declaration of
36 candidacy with the officer designated in RCW 29A.24.070 not later than

1 the day (~~before the primary or election~~) ballots must be mailed
2 according to RCW 29A.40.070. Declarations of candidacy for write-in
3 candidates must be accompanied by a filing fee in the same manner as
4 required of other candidates filing for the office as provided in RCW
5 29A.24.091.

6 Votes cast for write-in candidates who have filed such declarations
7 of candidacy and write-in votes for persons appointed by major
8 political parties pursuant to RCW 29A.28.021 need only specify the name
9 of the candidate in the appropriate location on the ballot in order to
10 be counted. Write-in votes cast for any other candidate, in order to
11 be counted, must designate the office sought and position number or
12 political party, if the manner in which the write-in is done does not
13 make the office or position clear.

14 No person may file as a write-in candidate where:

15 (1) At a general election, the person attempting to file either
16 filed as a write-in candidate for the same office at the preceding
17 primary or the person's name appeared on the ballot for the same office
18 at the preceding primary;

19 (2) The person attempting to file as a write-in candidate has
20 already filed a valid write-in declaration for that primary or
21 election, unless one or the other of the two filings is for the office
22 of precinct committeeperson;

23 (3) The name of the person attempting to file already appears on
24 the ballot as a candidate for another office, unless one of the two
25 offices for which he or she is a candidate is precinct committeeperson.

26 The declaration of candidacy shall be similar to that required by
27 RCW 29A.24.031. No write-in candidate filing under this section may be
28 included in any voter's pamphlet produced under chapter 29A.32 RCW
29 unless that candidate qualifies to have his or her name printed on the
30 general election ballot. The legislative authority of any jurisdiction
31 producing a local voter's pamphlet under chapter 29A.32 RCW may
32 provide, by ordinance, for the inclusion of write-in candidates in such
33 pamphlets.

34 **Sec. 14.** RCW 29A.28.041 and 2006 c 344 s 12 are each amended to
35 read as follows:

36 (1) Whenever a vacancy occurs in the United States house of
37 representatives or the United States senate from this state, the

1 governor shall order a special election to fill the vacancy. Minor
2 political party candidates and independent candidates may be nominated
3 through the convention procedures provided in chapter 29A.20 RCW.

4 (2) Within ten days of such vacancy occurring, he or she shall
5 issue a writ of election fixing a date for the (~~(special vacancy~~

19 primary, special vacancy election, and minor party and independent
20 candidate nominating conventions must be held in concert with the state
21 primary and state general election in that year.

22 (4) If the vacancy occurs on or after the first day for filing
23 under RCW 29A.24.050 and on or before the (~~(second Friday following~~
24 ~~the))~~ close of the filing period, a special filing period of three
25 normal business days shall be fixed by the governor and notice thereof
26 given to all media, including press, radio, and television within the
27 area in which the vacancy election is to be held, to the end that,
28 insofar as possible, all interested persons will be aware of such

31 A primary shall be held to (~~nominate~~) qualify candidates if
32 sufficient time exists to hold a primary and more than two candidates
33 file for the vacant office. Otherwise, a primary shall not be held and
34 the person receiving the greatest number of votes shall be elected.
35 The person elected shall take office immediately and serve the
36 remainder of the unexpired term.

37 If an election for the position that became vacant would otherwise
38 have been held at this general election date, only one election to fill

1 the position shall be held and the person elected to fill the
2 succeeding term for that position shall take office immediately when
3 qualified as defined in RCW ((~~29.01.135~~)) 29A.04.133 and shall service
4 both the remainder of the unexpired term and the succeeding term.
