Adopting the investments of insurers model act.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Adopts the investments of insurers model act.

Protects and furthers the interests of insureds, creditors, and the general public by providing, with minimum interference with management initiative and judgment, prudent standards for the development and administration of insurer investment programs.

(2) Review the projects recently constructed or currently being designed and prepare a letter to the legislature on their general consistency as well as identify improvements that remain unfunded.
