### House Bills

**HB 1094-S** by House Committee on Local Government (originally sponsored by Representatives Kretz, Blake, Taylor, Shea, Short, Haler, and McCune)

Providing a process for county legislative authorities to withdraw from voluntary planning under the growth management act.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes certain counties to adopt a resolution removing the county, and the cities located within the county, from the requirements to adopt land use plans and development regulations under certain conditions.

Prohibits counties who adopt the resolution from re-electing to plan under the growth management act for at least ten years from the date of the adoption.

**HB 1104-S** by House Committee on Judiciary (originally sponsored by Representatives Moeller, Walsh, Billig, Kenney, Maxwell, and Dammeier; by request of Department of Social and Health Services)

Concerning the protection of vulnerable adults.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Expands the definitions of "vulnerable adult" and "financial exploitation" in chapter 74.34 RCW (abuse of vulnerable adults).

Authorizes the department of social and health services' adult protective services division to enter into agreements with federally recognized tribes to investigate reports of abandonment, abuse, neglect, financial exploitation, or self-neglect of vulnerable adults on property over which a federally recognized tribe has exclusive jurisdiction.

Requires the department of social and health services, when it opens an investigation of a report of abuse, neglect, exploitation, or abandonment of a vulnerable adult, to provide a written statement of the rights afforded and other applicable law to alleged victims or legal guardians.

Requires court reporters and court reporting firms to be licensed by the department of licensing.

Regulating insurance rates.

Requires rate filings for individual and small group health benefit plans to be open to public inspection on the effective date set forth in the filing.

Revises scope of practice provisions for naturopathic physicians.

Concerning crimes against animals belonging to another person.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses the crime of killing or causing substantial bodily harm to livestock belonging to another person.

Regarding the institute of forest resources.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Finds that: (1) There are many challenges facing the forest sector; and

(2) These forest issues transcend the expertise and mission of the University of Washington school of forest resources and the associated centers and cooperatives.

Directs the institute of forest resources to provide the structure and continuity needed by drawing contributions from the associated centers and cooperatives into a process that is responsive to the critical issues confronting the forest sector.

Revises body art, body piercing, and tattooing provisions relating to license cancellation; license suspension for nonpayment or default on certain educational loans and scholarships; individual operator and location licenses; and completion of internship program.

Authorizes electronic transmission for notification of a homeowners' association meeting.

**HB 1311-S** by House Committee on Health Care & Wellness (originally sponsored by Representatives Cody, Jinkins, Bailey, Green, Clibborn, Appleton, Moeller, Frockt, Seaquist, and Dickerson)

Improving health care in the state using evidence-based care.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the state health care authority to convene a collaborative, to be known as the Robert Bree collaborative, to identify health care services for which there are substantial variations in practice patterns or high utilization trends in the state that are indicators of poor quality and potential waste in the health care system.

Requires all state-purchased health care programs to implement certain evidence-based best practice guidelines or protocols and strategies required under section 3 of the act.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes certain nursing homes to employ physicians for the provision of professional services to its residents under certain circumstances.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Clarifies that: (1) A person who has a substantial nexus in the state in any tax year is deemed to have a substantial nexus with the state the following year; and

(2) A seller is not obligated to collect use tax if the state is prohibited from requiring the person to collect the tax.

Requires the department of revenue to update the list of reduction in revenues from tax exemptions only for tax exemptions impacting state revenue.

Expands DNA databases to include DNA from felony arrestees.
