House Bills

HB 1028 by Representatives Schmick, Takko, Fagan, Springer, Kretz, Shea, Blake, and McCune

Using state correctional facility populations to determine population thresholds for certain local government purposes.

(AS OF HOUSE 2ND READING 2/22/11)

Authorizes certain cities to include or exclude the population of a state correctional facility located within the city when determining population.

HB 1183-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Johnson, Cody, Ross, Kenney, Warnick, Maxwell, Schmick, Taylor, Hope, Haler, Goodman, Hinkle, Dickerson, McCune, Rodne, Armstrong, Ryu, Seaquist, Pedersen, Liias, Eddy, Appleton, Klippert, Kretz,

Hasegawa, Fagan, Asay, Chandler, Angel, Ahern, and Stanford)

Regarding institutions of higher education prohibiting hospitals or physicians from entering into agreements to provide clinical rotations or residencies to certain medical students. (REVISED FOR ENGROSSED: Regarding certain osteopathic or allopathic medical schools prohibiting hospitals or physicians from entering into agreements to provide clinical rotations to qualified osteopathic or allopathic medical students.)

(AS OF HOUSE 2ND READING 2/22/11)

Prohibits an osteopathic or allopathic medical school, receiving state funds or authorized by the higher education coordinating board, from prohibiting a hospital or physician from entering into an agreement to provide student clinical rotations to qualified osteopathic or allopathic medical students.

HB 1332-S by House Committee on Local Government (originally sponsored by Representatives

Eddy, Anderson, Goodman, Takko, Liias, Springer, Rodne, Hurst, and Tharinger)

Providing for the joint provision and management of municipal water, wastewater, storm and flood water, and related utility services.

(AS OF HOUSE 2ND READING 2/22/11)

Establishes the joint municipal utility services act to: (1) Improve the ability of local government utilities to plan, finance, construct, acquire, maintain, operate, and provide facilities and utility services to the public; and

(2) Reduce costs and improve the benefits, efficiency, and quality of utility services.

HB 2002 by Representatives Sells, Ryu, Ormsby, and Kenney

Concerning industrial insurance employer wage subsidies and reimbursements for light duty or transitional work.

Modifies temporary total disability provisions relating to employers providing light duty or transitional work.

Expires July 1, 2016.

Senate Bills

SB 5855 by Senator Roach

Notifying the secretary of state when a person summoned for jury service does not meet the qualifications of a juror.

Requires a court to create and maintain a list of names of certain prospective jurors who have been disqualified.

SB 5857 by Senators Kohl-Welles, Murray, Keiser, Kline, Prentice, Rockefeller, Chase, Ranker, White, Nelson, Conway, Harper, and Shin

Concerning tax expenditure reform to provide transparency and accountability in fiscal matters.

Addresses tax expenditure reform to provide transparency and accountability in fiscal matters by: (1) Eliminating sales and use tax exemptions;

(2) Eliminating business and occupation tax exemptions, credits, deductions, and preferential tax rates;

(3) Incorporating state tax expenditures into the state budget process; and

(4) Modifying the tax preference review by the joint legislative audit and review committee.
