1            AN ACT Relating to vehicle license plate and registration fraud;  
2 reenacting and amending RCW 46.63.020; adding a new section to chapter  
3 46.37 RCW; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            NEW SECTION.    **Sec. 1.** A new section is added to chapter 46.37 RCW  
6 to read as follows:

7            (1)(a) It is unlawful for a person to display a license plate on a  
8 vehicle that does not match or correspond with the registration of the  
9 vehicle unless the vehicle is inventory for a properly licensed vehicle  
10 dealer.

11           (b) It is unlawful for a person to have an installed license plate  
12 flipping device on a vehicle, use technology to flip a license plate on  
13 a vehicle, or use technology to change the appearance of a license  
14 plate on a vehicle.

15           (c) It is unlawful for a person or entity to sell a license plate  
16 flipping device or sell technology that will change the appearance of  
17 a license plate in the state of Washington.

18           (d) For purposes of this section, "license plate flipping device"  
19 means a device that enables a license plate on a vehicle to be changed

1 to another license plate either manually or electronically. "License  
2 plate flipping device" includes technology that is capable of changing  
3 the appearance of a license plate to appear as a different license  
4 plate.

5 (2) A person who switches or flips license plates on a vehicle  
6 physically, utilizes technology to flip or change the appearance of a  
7 license plate on a vehicle, sells a license plate flipping device or  
8 technology that will change the appearance of a license plate, or  
9 falsifies a vehicle registration in violation of this section, in  
10 addition to any traffic infraction, is guilty of a gross misdemeanor  
11 punishable by confinement of up to three hundred sixty-four days in the  
12 county jail and a fine of one thousand dollars for the first offense,  
13 two thousand five hundred dollars for a second offense, and five  
14 thousand dollars for any subsequent offense, which may not be  
15 suspended, deferred, or reduced.

16 (3) A vehicle that is found with an installed license plate  
17 flipping device or technology to change the appearance of a license  
18 plate may be impounded by a law enforcement officer as evidence.

19 (4) Citizens are encouraged to notify law enforcement immediately  
20 if they observe a vehicle with a license plate flipping device.

21 **Sec. 2.** RCW 46.63.020 and 2010 c 252 s 3, 2010 c 161 s 1125, and  
22 2010 c 8 s 9077 are each reenacted and amended to read as follows:

23 Failure to perform any act required or the performance of any act  
24 prohibited by this title or an equivalent administrative regulation or  
25 local law, ordinance, regulation, or resolution relating to traffic  
26 including parking, standing, stopping, and pedestrian offenses, is  
27 designated as a traffic infraction and may not be classified as a  
28 criminal offense, except for an offense contained in the following  
29 provisions of this title or a violation of an equivalent administrative  
30 regulation or local law, ordinance, regulation, or resolution:

3 registration certificates, and markings indicating that a vehicle has  
4 been destroyed or declared a total loss;

6 taxes and fees by failure to register a vehicle and falsifying  
7 residency when registering a motor vehicle;

30 (17) RCW 46.20.750 relating to circumventing an ignition interlock  
31 device;  
32 (18) RCW 46.25.170 relating to commercial driver's licenses;  
33 (19) Chapter 46.29 RCW relating to financial responsibility;  
34 (20) RCW 46.30.040 relating to providing false evidence of  
35 financial responsibility;  
36 (21) RCW 46.35.030 relating to recording device information;  
37 (22) RCW 46.37.435 relating to wrongful installation of  
38 sunscreening material;

1 (23) RCW 46.37.650 relating to the sale, resale, distribution, or  
2 installation of a previously deployed air bag;

3 (24) RCW 46.37.671 through 46.37.675 relating to signal preemption  
4 devices;

5 (25) Section 1 of this act relating to switching or flipping  
6 license plates, utilizing technology to flip or change the appearance  
7 of a license plate, selling a license plate flipping device or  
8 technology used to change the appearance of a license plate, or  
9 falsifying a vehicle registration;
