- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 19.02.050 and 2011 c 298 s 6 are each amended to read
- 6 as follows:

- 8 following agencies)) Each of the following agencies must develop with
- 9 the department of revenue a timetable to, by 2015, fully participate in
- 10 the implementation of this chapter:
- 11 (1) Department of agriculture;

- 13 (3) Department of social and health services;
- 14 (4) Department of revenue;
- 15 (5) Department of fish and wildlife;
- 16 (6) Employment security department;
- 17 (7) Department of labor and industries;
- 18 (8) ((Department of commerce;
- 19 $\frac{(9)}{(9)}$) Liquor control board;

- NEW SECTION. Sec. 2. A new section is added to chapter 19.02 RCW to read as follows:
- 20 (1) Each agency required to fully participate in the implementation 21 of this chapter under RCW 19.02.050 must provide the department with 22 the name of the agency's coordinator for the purposes of implementing 23 the requirements of this section.
 - (2) Using a format designated by the department, each agency must provide the department with the following information:
 - (a) A listing of each business license issued by the agency;
- 27 (b) A description of the persons and specific activities for which 28 the license is required;
- 29 (c) The time period for which the license is issued and any 30 issuance, renewal, or reissuance requirements; and
- 31 (d) Other information the department determines necessary to 32 implement this section, including links to the licensing information, 33 application, and instructions on the agency's web site, if available.
- 34 (3) An agency that issues licenses subject to national or federally 35 mandated requirements or standards may alternatively comply with this 36 section by providing the department with a link to its licensing web

site, summary information about the licensing requirements or standards in a format or formats designated by the department, and a designated agency contact.

- (4) Each agency, by November 1st of each year, beginning November 1, 2013, must provide the department with certification on a form designated by the department that all business licensing information submitted by the agency is complete and up to date. If an agency has not submitted all the business licensing information required under this section, the agency must instead submit a progress report and explanation to the department.
- (5) The department must compile the information submitted by each agency, and submit an aggregate report to the governor and the economic development committees of the legislature by January 1st of each year, beginning January 1, 2014.
