1 AN ACT Relating to snowmobile license fees; amending RCW 46.17.350
2 and 46.17.350; creating new sections; providing an effective date; and
3 providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 46.17.350 and 2010 c 161 s 531 are each amended to
6 read as follows:

7 (1) Before accepting an application for a vehicle registration, the
8 department, county auditor or other agent, or subagent appointed by the
9 director shall require the applicant, unless specifically exempt, to
10 pay the following vehicle license fee by vehicle type:

17 NEW SECTION. **Sec. 3.** Section 1 of this act applies to snowmobile
18 registrations that are due on October 1, 2013. Section 1 of this act
19 expires October 1, 2014.

20 NEW SECTION. **Sec. 4.** Section 2 of this act applies to snowmobile
21 registrations that are due on or after October 1, 2014. Section 2 of
22 this act takes effect October 1, 2014.
