# 2021 Individual Market Health Plans

---

In 2019, as part of [Engrossed Substitute Senate Bill \(ESSB\) 5526](#) (Increasing the availability of quality, affordable health coverage in the individual market), the Washington State Legislature directed the Office of the Insurance Commissioner (OIC) to report annually on the number of individual health plans approved for sale in each county, both on and off the Washington State Health Benefit Exchange (RCW 48.43.770). This is the second report fulfilling that directive.

## Availability of coverage

---

For Plan Year 2021, every county has at least two insurers offering health plans for sale in Washington State's individual market. Plans are available in gold, silver, bronze and catastrophic tiers. Two new insurers are joining the market in 2021.

Insurance companies are not required to offer coverage in specific counties or statewide. A company may opt to sell inside the Washington State Health Benefit Exchange (the Exchange), outside the Exchange or both. In addition, if a carrier offers coverage for the Public Employees' Benefits Board (PEBB) or the School Employees' Benefits Board (SEBB), the carrier must also offer plans on the Exchange in the same counties it serves for PEBB or SEBB. All insurers that sell plans on the Exchange are required to offer their health plans off the Exchange if a consumer requests it.

Standardized health plans, called Cascade Care standard plans, and public option plans will be offered on the Exchange for the first time in 2021. A total of 36 standard plans will be offered across all counties. Each county will have between 6 and 27 available. Additionally, at least 15 public option plans will be offered, with at least one option available in 19 counties.
