Introduction

The Special Commitment Center (SCC) is notified of a less restrictive alternative release by court order and provides community notice per RCW 71.09.335. Community notification is provided through the OffenderWatch process. Once SCC Staff complete OffenderWatch notification on releases – it is law enforcement's responsibility to provide additional notice to their community as outlined in RCW 4.24.550.

The Special Commitment Center and the transition treatment teams for persons who have court-ordered conditional releases closely monitor treatment progress and activities. As a result, the persons ordered by the courts to less restrictive alternative settings, including the secure community transition facilities, have not committed a new sex offense or other criminal offense. When early warning signs of potential problems occur, consideration is given to take the person into custody and return him or her to the SCC for evaluation and recommended action to the court of commitment.

During the court process that leads to an order of conditional release, judges and opposing counsels outline conditions that residents should follow. Some of these conditions include but are not limited to: having community chaperones accompany residents when they are moving in the community for a period of time, limiting access to internet and data options on mobile devices and computers, allowing only limited access to do travel in a week for resident needs, etc. Early warning signs are when transition treatment teams and assigned Department of Corrections Community Officers document that residents are not following the conditions of their release. The transition treatment team then works with the resident to try and correct their behavior; and if there is a pattern of minor offenses or more significant concerns they may be remanded back to the total confinement facility for additional treatment.

A resident that has been returned to custody for evaluation and recommended action still receives a final order from the court of commitment. Their return for additional evaluation and recommended action does not automatically revoke them from their original LRA. The judge that oversees the case then either remands the resident to the total confinement facility for a timeframe or permanently; or will re-release them to their original LRA or a differing LRA depending on availability.

This report is submitted in fulfillment of the requirements of RCW 71.09.325(4). The statute directs the Department of Social and Health Services (DSHS) to compile information in writing on all violations of court-ordered conditions of release committed by all civilly committed sex offenders who are living in less restrictive alternative (LRA) settings. In addition, the department is required to report any penalties and actions taken by the department to remove a person from an LRA setting. The report is issued on an annual basis to the Office of Financial Management and the appropriate committees of the legislature.

This report addresses violations that occurred between September 1, 2017 and August 31, 2018. It also provides a status report on any violations that were addressed in a previous annual report but were not resolved before the report was submitted.

Definitions

For the purpose of this report, the following definitions from the SCC policies are used.

Less Restrictive Alternative (LRA). Court-ordered treatment in a setting less restrictive than total confinement that satisfies the conditions set forth in RCW 71.09.092. LRAs include private homes, secure community transition facilities (SCTF), and other court-authorized settings including contracted residential settings with twenty-four hour staffing.

Secure Community Transition Facility (SCTF). A residential facility for persons conditionally released to a less restrictive alternative, including the SCTF in Pierce County on McNeil Island, the SCTF in King County and any community-based facilities established under Chapter 71.09 RCW and operated by or under contract with DSHS.

Private Home. The LRA resident's own home or the home of a family member or other person that the court of commitment has approved as a less restrictive alternative placement.

General Violation. Failure to comply with a condition of release set by the court of commitment, by DSHS, or by the Department of Corrections (DOC). A general violation may include a resident's failure to comply with a treatment plan requirement, posting, written instruction or verbal instruction given by an authorized person. A general violation is distinct from a serious violation.

Serious Violation. A violation by an LRA resident that includes but is not limited to the commission of any criminal offense, any unlawful use or possession of alcohol or a controlled substance, or any violation of a court-ordered conditions, which targets the individual's documented pattern of offense that increases the risk to public safety. For purposes of this SCC policy, an accumulation of failure to comply with treatment plan requirements or with rules, infractions of rules, or any behavior that, in the judgement of the SCC CEO, represents a risk to public safety may be considered a serious violation.

Current Status

During the period of September 2017 to August 2018, there were fifty-four residents in court-ordered LRA settings. Nine of the fifty-four residents that were in LRA settings unconditionally released before August 31, 2018. Two residents passed away. Additionally, two residents had their LRA status revoked. Seven residents have been returned, and remain at the SCC Total Confinement Facility on McNeil due to serious violations of their LRA conditions.

Forty-one residents of the original fifty-four total residents on LRA status during this time had at least one violation.

There were 40 serious violations and 109 general violations from September 2017-August 2018. Some of the violations actually fall under more than one category of violation. Thirteen residents have been returned to total confinement at the SCC during this period. Of the thirteen residents returned to total confinement, eight have been re-released back to an LRA with additional restrictions and conditions imposed by the court of commitment.

Serious Violation Explanation and Updates

RCW 71.09.325 (1) any conditionally released person who commits a serious violation of conditions shall be returned to the special commitment center, unless arrested by a law enforcement officer, and the court shall be notified immediately and shall initiate proceedings under RCW 71.09.098.

The thirteen residents listed below returned to the TCF due to a violation of their court order. If an action occurs and a resident is returned to the TCF, a court hearing is requested to determine if the resident will be revoked or returned to the community.

Some of the residents below have been returned to the TCF more than once from the previous violation report to August 31, 2018.

Resident E

Community Placement: Community LRA Ordered 03/01/2016 **Violations:**

9/29/2017 Having unapproved intentional, regular contact with a community member. 10/5/2017 Failing to comply with treatment rules and expectations by failing to accurately fill out weekly check-in sheets or disclosing his relationship with unapproved contact. 10/5/2017 Failing to comply with Tacoma Housing Group rules by having unapproved contact spend the night at his residence on or about the date provided. Engaging in a physical and romantic relationship with unapproved contact, without the express written approval of the Transition Team since on or about the date identified.

10/6/2017 Accessing the Internet and photo taking feature on his cell phone.

11/10/2017 Failing to comply with GPS conditions by failing to charge the device resulting in a dead battery and the GPS unit going offline.

11/13/2017 Failing to comply with approved itinerary and bus routes resulting in travelling to an approved location.

11/21/2017 Failing to comply with approved itinerary by failing to return home on time.

Status: The resident remains at TCF.

Resident EE

Community Placement: Community LRA Ordered on 10/23/2015 **Violations:**

9/19/2017 Leaving his residence without permission.

Violations Committed by LRA Residents October 1, 2018 Page 3 9/22/2017 Failing to comply with directive of his Sex Offender Treatment Provider (SOTP) by leaving his residence without a chaperone on a non-mandatory outing.

11/27/2017 Owning, installing, and/or using "Slim Cleaner," software that is capable of erasing or "wiping" data from a computer or storage device.

2/15/2018 Completed Forensic Report from the Special Commitment Center's Information Technology Department was sent to DOC and indicated that there were recovered images of minor children leading to resident's return to TCF.

Status: The resident's LRA was revoked by court order in March of 2018.

Resident HH

Community Placement: Community LRA Ordered on 3/22/2017 **Violations:**

10/2/2017 Failing to have his cellular phone on his person while in the community

10/3/2017 Leaving his residence without his GPS XT unit.

11/29/2017 Accessing the internet.

11/30/2017 Failing to notify DOC, Sex Offender Treatment Provider (SOTP) and DSHS of a violation of conditions of supervision.

2/18/2018 Failing to comply with DOC verbal instructions.

2/18/2018 Participating in unapproved employment.

3/3/2018 and 3/4/2018 Possession of an unapproved computer.

3/3/2018 and 3/4/2018 Possession of an unapproved cellular phones.

3/3/2018 and 3/4/2018 Having intentional regular contact with unapproved individuals.

3/3/2018 and 3/4/2018 Failing to keep an accurate phone log.

3/5/2018 Failing to notify the Transition Team of a violation within 24 hours.

5/22/2018 Failing to comply with DOC written and verbal instructions.

5/22/2018 Failing to make himself available for electronic monitoring.

5/22/2018 Failing to follow trip protocol.

8/21/2018 Leaving residence prior to approval.

8/25/2018 Failing to abide by curfew.

Status: The resident was returned to his Community LRA on June 6, 2018 and remains in the community at this time.

Resident I

Community Placement: Community LRA Ordered on May 5, 2016 (revised to different housing on 4/2/2018)

Violations:

10/10/2017 Failing to make point-to-point call as directed.

12/1/2017 Failing to make point-to-point call as directed.

12/16/2017 Having intentional regular contact with an unapproved person.

12/16/2017 Having intentional female contact with unapproved person, on multiple occasions from October 2017 through 12/16/2017.

1/15/2018 Failing to abide by sexual deviancy treatment recommendations, by terminating from Sex Offender Treatment from provider Gianna Leoncavallo.

4/25/2018 Failing to take prescribed medication as directed by his primary physician from June 2017 through January 2018.

Violations Committed by LRA Residents October 1, 2018 **Status:** The resident was returned to TCF on 1/5/2018 due to the violations noted during December and due to the SOTP provider's notice of termination. The court ordered the resident released back onto LRA, but he was moved to another county in April 2018.

Resident II

Community Placement: Community LRA ordered 6/23/2017 **Violations:**

11/16/2017 Failing to comply with his approved travel itinerary.

11/16/2017 Altering his approved travel itinerary without permission.

12/6/2017 Failing to comply with GPS rules.

12/11/2017 Failing to comply with directive of the DOC, his SOTP, and SCC.

2/7/2018 Resident engaged in unsafe behavior with fellow resident and self-involving a weapon.

5/23/2018 Failing to comply with GPS rules/instructions.

6/8/2018 Engaging in unnecessary physical touching of another person.

6/8/2018 Failing to abide by directive of Aacres WA LLC by being within arm's length of another.

5/24/2018 Purchasing, possessing, and playing "M-Rated" video games.

5/24/2018 Purchasing media items that had not been pre-approved by his Transition Team.

7/11/2018 Failing to follow GPS rules as directed.

Status: Resident was returned to total confinement facility for additional care on 2/13/2018 and was released back to his LRA on 4/27/2018 by court order with additional conditions based on DOC recommendations.

Resident MM

Community Placement: SCTF-KC court ordered 05/29/2015 **Violations:**

5/1/2018 Obtaining, possessing and viewing prohibited electronic media items.

5/1/2018 Making efforts to thwart, disable or limit the effectiveness or monitoring tools imposed on him by attempting to use his written directives regarding media to avoid notice of obtaining and using prohibited media.

5/1/2018 Failure to report violation behavior within 24 hours on multiple occasions.

5/8/2018 Making efforts to thwart, disable, or limit the effectiveness of monitoring tools imposed on him by lying to his Transition Team.

5/15/2018 Making efforts to thwart, disable or limit the effectiveness of monitoring tools imposed on him by telling another resident what kind of books he would like from the library, knowing that resident intended to get books for him and withholding information from members of his Transition Team.

Status: Resident returned to TCF on 10/18/2016, the court ordered him rereleased back to the SCTF-KC on 4/13/2017. He was returned to TCF on 5/25/2018 due to continued violations outlined during May 2018. Department of Corrections noted that they recommend the court revoke his LRA in their violation notice.

Resident 00

Violations Committed by LRA Residents October 1, 2018 Page 5

Community Placement: Community LRA court ordered on 11/14/2017 **Violations:**

1/9/2018 Possessing images of children without prior approval.

1/9/2018 Failure to immediately report a violation.

1/22/2018 Housing provider refused to continue providing housing to resident given community outcry.

Status: Resident returned to TCF due to lack of housing. He remains at TCF currently.

Resident QQ

Community Placement: Community LRA court ordered on 7/28/2017 **Violations:**

4/17/2018 Failure to follow the CCO directive by not completing 90% of his treatment homework.

5/7/2018 Failure to comply with Aacres house rules by accepting gifts of a key chain and cigarettes from a resident in the house.

5/7/2018 Failure to participate in sex offender treatment by not adhering to his treatment contract.

5/13/2018 Failure to comply with Aacres house rules by accepting soda and other items from a resident in the house.

5/18/2018 Possessing sexually explicit material.

5/26/2018 Failure to participate in a polygraph as directed by the Transition Team.

5/26/2018 Having contact with an unapproved person.

Status: The resident was returned to TCF on May 25, 2018 due to May violations. He was recently released back to his original Community LRA in early September 2018 by court order.

Resident RR

Community Placement: SCTF-PC by Court Order on 1/4/2018.

Violations:

7/17/2018 Failure to abide by the facility rules by displaying unsafe, aggressive, and intimidating behavior towards another resident.

7/17/2018 Failing to abide by the facility rules by unauthorized permission to enter into another resident's room.

Status: On 7/18/2018, the resident was returned to TCF for additional treatment. The resident was returned to the SCTF-PC on 8/24/2018 with additional conditions added to his less restrictive order.

Resident T

Community Placement: Community LRA as court ordered 9/30/2016 **Violations:**

6/6/2018 Having contact within unapproved person.

6/6/2018 Having a visitor at his apartment without prior approval.

6/6/2018 Failure to keep an accurate visitor log.

6/7/2018 Failure to abide by conditions, directives and boundaries prohibiting contact with minors by initiating contact with unknown adults who were accompanied by a minor.

Violations Committed by LRA Residents

6/7/2018 Possessing prohibited movie DVDs.

06/11/2018 Failure to abide by CCO directive by taking possession of a television without prior approval.

6/13/2018 Possessing alcohol.

6/13/2018 Possessing prohibited TV show DVDs.

6/13/2018 Failure to abide by conditions related to prescription medication by possessing pills in an improperly labeled bottle without a valid current prescription.

6/21/2018 Possessing a pocketknife.

7/12/2018 Failure to maintain an accurate phone log.

7/25/2018 Failure to abide by CCO directive regarding the use of "411 Directory Assistance".

7/25/2018 Having contact with an unapproved person.

Status: The resident was returned to TCF on February 22, 2017 due to multiple violations of his court order. The court re-released the resident on May 16, 2018. The resident was returned on 7/27/2018 to TCF for cognitive testing and continued treatment given recent June and July violations.

Resident TT

Community Placement: Community LRA by court order on February 27, 2018. **Violations:**

5/30/2018 During chaperone training, none of the chaperones had arrived for training. Which violated his LRA conditions that require he have chaperones to transport him to necessary appointments.

7/23/2018 Having unapproved contact with another.

8/7/2018 Failing to follow point-to-point protocol.

Status: The resident was temporarily returned to TCF shortly after releasing on 5/30/2018 due to lack of chaperones. His court order was modified to provide him additional chaperone options and he was re-released on 6/1/2018 to his LRA as ordered on February 27, 2018.

Resident YY

Community Placement: SCTF-KC by court order on March 20, 2015.

Violations:

11/8/2017 Failing to comply with directives while on a trip in the community by attempting to leave his chaperone and subsequently arguing with his chaperone; displaying prolonged aggressive behavior not consistent with the goal of community safety.

5/18/2018 Failing to abide by a directive to use and maintain a media log.

6/5/2018 Failure to abide by prescribed medications/therapy.

6/5/2018 Failure to disclose violation behavior to his Transition Team members within 24 hours.

Status: The resident was returned to the TCF on 11/8/2017; and was re-released back to the community by court order on 3/30/2018.

Resident 7.7.

Community Placement: Community LRA by court order November 6, 2017

Violations Committed by LRA Residents October 1, 2018 Page 7

Violations:

3/1/2018 Failing to make a point-to-point call as directed upon arriving at the Secure Community Transition Facility in Seattle.

6/7/2018 Resident observed by another leaving residence, showing signs of delusional behavior and seemingly confused by circumstances.

Status: The resident was returned to TCF on 6/7/2018 for further care and treatment.

Service Providers

During this reporting period, there were no sanctions issued to service providers.

Violations

Per RCW 71.09 (4) DSHS must document all violations, penalties and actions.

Residents may have multiple violations, which is noted by (-) in the following columns.

*NOTE: Violating court order terms does not always negate the need for SCC to continue paying stipends or for residents rent. Each resident has variations in their court order that allow or limit the Special Commitment Center from refusing to pay expenses while a resident resides on island.

We categorize our violations based on type:

- Failure to follow GPS Guidelines
- Failure to follow directives
- Misuse of phone
- Failure to follow travel itinerary and guidelines
- Failure to follow treatment
- Unapproved contact
- Failure to follow Internet/computer guidelines
- Unapproved relationships
- Other these are categorized as technical violations of the court order that may be beyond a resident's control (i.e. an SOTP provider retiring suddenly or losing housing due to circumstances).


