1 AN ACT Relating to real estate brokers and salespersons; amending  
2 RCW 18.85.010, 18.85.030, 18.85.060, 18.85.085, 18.85.095, 18.85.100,  
3 18.85.110, 18.85.120, 18.85.130, 18.85.140, 18.85.150, 18.85.155,  
4 18.85.165, 18.85.170, 18.85.180, 18.85.210, 18.85.230, 18.85.281,  
5 18.85.317, 18.85.330, 18.85.340, 18.85.343, 18.85.345, 18.85.350, and  
6 18.85.360; and repealing RCW 18.85.290 and 18.85.300.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 **Sec. 1.** RCW 18.85.010 and 1987 c 332 s 1 are each amended to read  
9 as follows:

10 In this chapter words and phrases have the following meanings  
11 unless otherwise apparent from the context:

12 (1) "Real estate broker," or "broker," means a person, while acting  
13 for another for commissions or other compensation or the promise  
14 thereof, or a licensee under this chapter while acting in his or her  
15 own behalf, who:

16 (a) Sells or offers for sale, lists or offers to list, buys or  
17 offers to buy real estate or business opportunities, or any interest  
18 therein, for others;

1 (b) Negotiates or offers to negotiate, either directly or  
2 indirectly, the purchase, sale, exchange, lease, or rental of real  
3 estate or business opportunities, or any interest therein, for others;

4 (c) Negotiates or offers to negotiate, either directly or  
5 indirectly, the purchase, sale, or exchange of a used mobile home in  
6 conjunction with the purchase, sale, exchange, rental, or lease of the  
7 land upon which the used mobile home is located;

8 (d) Advertises or holds himself or herself out to the public by any  
9 oral or printed solicitation or representation that he or she is so  
10 engaged; or

11 (e) Engages, directs, or assists in procuring prospects or in  
12 negotiating or closing any transaction which results or is calculated  
13 to result in any of these acts;

14 (2) "Real estate salesperson" or "salesperson" means any natural  
15 person employed, either directly or indirectly, by a real estate  
16 broker, or any person who represents a real estate broker in the  
17 performance of any of the acts specified in subsection (1) of this  
18 section;

19 (3) An "associate real estate broker" is a person who has qualified  
20 as a "real estate broker" who works with a broker and whose license  
21 states that he or she is associated with a broker;

22 (4) The word "person" as used in this chapter shall be construed to  
23 mean and include a corporation, limited liability company, limited  
24 liability partnership, or (~~copartnership~~) partnership, except where  
25 otherwise restricted;

26 (5) "Business opportunity" shall mean and include business,  
27 business opportunity and good will of an existing business or any one  
28 or combination thereof;

29 (6) "Commission" means the real estate commission of the state of  
30 Washington;

31 (7) "Director" means the director of licensing;

32 (8) "Real estate multiple listing association" means any  
33 association of real estate brokers:

34 (a) Whose members circulate listings of the members among  
35 themselves so that the properties described in the listings may be sold  
36 by any member for an agreed portion of the commission to be paid; and

37 (b) Which require in a real estate listing agreement between the  
38 seller and the broker, that the members of the real estate multiple

1 listing association shall have the same rights as if each had executed  
2 a separate agreement with the seller;

3 (9) "Clock hours of instruction" means actual hours spent in  
4 classroom instruction in any tax supported, public (~~(vocational-~~  
5 ~~technical institution)) technical college, community college, or any  
6 other institution of higher learning or a correspondence course from  
7 any of the aforementioned institutions certified by such institution as  
8 the equivalent of the required number of clock hours, and the real  
9 estate commission may certify courses of instruction other than in the  
10 aforementioned institutions; and~~

11 (10) "Incapacitated" means the physical or mental inability to  
12 perform the duties of broker prescribed by this chapter.

13 **Sec. 2.** RCW 18.85.030 and 1972 ex.s. c 139 s 2 are each amended to  
14 read as follows:

15 The director shall appoint an adequate staff to assist him or her.

16 **Sec. 3.** RCW 18.85.060 and 1972 ex.s. c 139 s 5 are each amended to  
17 read as follows:

18 The director shall adopt a seal with the words real estate  
19 director, state of Washington, and such other device as ((he)) the  
20 director may approve engraved thereon, by which he or she shall  
21 authenticate the proceedings of ((his)) the office. Copies of all  
22 records and papers in the office of the director certified to be a true  
23 copy under the hand and seal of the director shall be received in  
24 evidence in all cases equally and with like effect as the originals.  
25 The director may deputize one or more ((of his)) assistants to certify  
26 records and papers.

27 **Sec. 4.** RCW 18.85.085 and 1977 ex.s. c 24 s 1 are each amended to  
28 read as follows:

29 The commission shall have authority to hold educational conferences  
30 for the benefit of the industry, and shall conduct examinations of  
31 applicants for licenses under this chapter. ((It shall be charged with  
32 the preparation of such examinations and shall administer them at least  
33 once a month, with not less than six examinations per year in each of  
34 the following six areas of the state: Northwest Washington, southwest  
35 Washington, northeast Washington, southeast Washington, north central  
36 Washington, and south central Washington.)) The commission shall

1 ensure that examinations are prepared and administered at examination  
2 centers throughout the state.

3 **Sec. 5.** RCW 18.85.095 and 1994 c 291 s 2 are each amended to read  
4 as follows:

5 (1) The minimum requirements for an individual to receive a  
6 salesperson's license are that the individual:

7 (a) Is eighteen years of age or older;

8 (b) Except as provided in RCW (~~18.85.087~~) 18.85.097, has  
9 furnished proof, as the director may require, that the applicant has  
10 successfully completed a sixty clock-hour course, approved by the  
11 director, in real estate fundamentals. The applicant must pass a  
12 course examination approved by the director. This course must be  
13 completed within five years prior to applying for the salesperson's  
14 license examination; and

15 (c) Has passed a salesperson's license examination.

16 (2) The minimum requirements for a salesperson to be issued the  
17 first renewal of a license are that the salesperson:

18 (a) Has furnished proof, as the director may require, that the  
19 salesperson has successfully completed a thirty clock-hour course, from  
20 a prescribed curriculum approved by the director, in real estate  
21 practices. The salesperson must pass a course examination approved by  
22 the director. This course shall be commenced after issuance of a first  
23 license; and

24 (b) Has furnished proof, as the director may require, that the  
25 salesperson has completed an additional thirty clock hours of  
26 continuing education in compliance with RCW 18.85.165. Courses for  
27 continuing education clock-hour credit shall be commenced after  
28 issuance of a first license.

29 (3) Nothing in this section applies to persons who are licensed as  
30 salespersons under any real estate law in Washington which exists prior  
31 to this law's enactment, but only if their license has not been  
32 subsequently canceled or revoked.

33 **Sec. 6.** RCW 18.85.100 and 1972 ex.s. c 139 s 9 are each amended to  
34 read as follows:

35 It shall be unlawful for any person to act as a real estate broker,  
36 associate real estate broker, or real estate (~~salesman~~) salesperson

1 without first obtaining a license therefor, and otherwise complying  
2 with the provisions of this chapter.

3 No suit or action shall be brought for the collection of  
4 compensation as a real estate broker, associate real estate broker, or  
5 real estate ((~~salesman~~)) salesperson, without alleging and proving that  
6 the plaintiff was a duly licensed real estate broker, associate real  
7 estate broker, or real estate ((~~salesman~~)) salesperson prior to the  
8 time of offering to perform any such act or service or procuring any  
9 promise or contract for the payment of compensation for any such  
10 contemplated act or service.

11 **Sec. 7.** RCW 18.85.110 and 1989 c 161 s 1 are each amended to read  
12 as follows:

13 This chapter shall not apply to (1) any person who purchases  
14 property and/or a business opportunity for his or her own account, or  
15 that of a group of which he or she is a member, or who, as the owner or  
16 part owner of property, and/or a business opportunity, in any way  
17 disposes of the same; nor, (2) any duly authorized attorney in fact  
18 acting without compensation, or an attorney at law in the performance  
19 of his or her duties; nor, (3) any receiver, trustee in bankruptcy,  
20 executor, administrator, guardian, or any person acting under the order  
21 of any court, or selling under a deed of trust; nor, (4) any secretary,  
22 bookkeeper, accountant, or other office personnel who does not engage  
23 in any conduct or activity specified in any of the definitions under  
24 RCW 18.85.010; nor, (5) any owner of rental or lease property, members  
25 of the owner's family whether or not residing on such property, or a  
26 resident manager of a complex of residential dwelling units wherein  
27 such manager resides; nor, (6) any person who manages residential  
28 dwelling units on an incidental basis and not as his or her principal  
29 source of income so long as that person does not advertise or hold  
30 ((~~himself~~)) out to the public by any oral or printed solicitation or  
31 representation that he or she is so engaged; nor, (7) only with respect  
32 to the rental or lease of individual storage space, any person who owns  
33 or manages a self-service storage facility as defined under chapter  
34 19.150 RCW.

35 **Sec. 8.** RCW 18.85.120 and 1987 c 332 s 4 are each amended to read  
36 as follows:

1 Any person desiring to be a real estate broker, associate real  
2 estate broker, or real estate salesperson, must pass an examination as  
3 provided in this chapter. Such person shall make application for an  
4 examination and for a license on a form prescribed by the director.  
5 Concurrently, the applicant shall:

6 (1) Pay an examination fee as prescribed by the director by rule.

7 (2) If the applicant is a corporation, furnish a certified copy of  
8 its articles of incorporation, and a list of its officers and directors  
9 and their addresses. If the applicant is a foreign corporation, the  
10 applicant shall furnish a certified copy of certificate of authority to  
11 conduct business in the state of Washington, a list of its officers and  
12 directors and their addresses, and evidence of current registration  
13 with the secretary of state. If the applicant is a limited liability  
14 company, the applicant shall furnish a list of the members and managers  
15 of the company and their addresses. If the applicant is a  
16 ~~((copartnership))~~ limited liability partnership or partnership, the  
17 applicant shall furnish a list of the ~~((members))~~ partners thereof and  
18 their addresses.

19 (3) Furnish such other proof as the director may require concerning  
20 the honesty, truthfulness, and good reputation, as well as the  
21 identity, which may include fingerprints, of any applicants for a  
22 license, or of the officers of a corporation, or limited liability  
23 company, or the partners of a limited liability partnership or  
24 partnership, making the application.

25 **Sec. 9.** RCW 18.85.130 and 1972 ex.s. c 139 s 11 are each amended  
26 to read as follows:

27 The director shall provide each original applicant for ~~((a~~  
28 ~~license))~~ an examination with a manual containing a sample list of  
29 questions and answers pertaining to real estate law and the operation  
30 of the business and may provide the same at cost to any licensee or to  
31 other members of the public. The director shall ascertain by written  
32 examination, that each applicant, and in case of a corporation, limited  
33 liability company, limited liability partnership, or ~~((copartnership))~~  
34 partnership, that each officer, agent, or ~~((member))~~ partner thereof  
35 whom it proposes to act as licensee, has:

36 (1) Appropriate knowledge of the English language, including  
37 reading, writing, spelling, and arithmetic;

1 (2) An understanding of the principles of real estate conveyancing,  
2 the general purposes and legal effect of deeds, mortgages, land  
3 contracts of sale, exchanges, rental and option agreements, and leases;

4 (3) An understanding of the principles of land economics and  
5 appraisals;

6 (4) An understanding of the obligations between principal and  
7 agent;

8 (5) An understanding of the principles of real estate practice and  
9 the canons of business ethics pertaining thereto; and,

10 (6) An understanding of the provisions of this chapter.

11 The examination for real estate brokers shall be more exacting than  
12 that for real estate ((salesmen)) salespersons.

13 All moneys received for the sale of the manual to licensees and  
14 members of the public shall be placed in the real estate commission  
15 fund to be returned to the current biennium operating budget.

16 **Sec. 10.** RCW 18.85.140 and 1991 c 225 s 2 are each amended to read  
17 as follows:

18 Before receiving his or her license every real estate broker, every  
19 associate real estate broker, and every real estate salesperson must  
20 pay a license fee as prescribed by the director by rule. Every license  
21 issued under the provisions of this chapter expires on the applicant's  
22 second birthday following issuance of the license. Licenses issued to  
23 partnerships, limited liability partnerships, limited liability  
24 companies, and corporations expire on a date prescribed by the director  
25 by rule(~~(. Licenses issued to corporations expire on a date prescribed~~  
26 ~~by the director by rule))), except that if the ((corporation))  
27 registration or certificate of authority filed with the secretary of  
28 state expires, the real estate broker's license issued ((~~to the~~  
29 ~~corporation~~)) shall expire on that date. Licenses must be renewed  
30 every two years on or before the date established under this section  
31 and a biennial renewal license fee as prescribed by the director by  
32 rule must be paid.~~

33 If the application for a renewal license is not received by the  
34 director on or before the renewal date, a penalty fee as prescribed by  
35 the director by rule shall be paid. Acceptance by the director of an  
36 application for renewal after the renewal date shall not be a waiver of  
37 the delinquency.

1 The license of any person whose license renewal fee is not received  
2 within one year from the date of expiration shall be canceled. This  
3 person may obtain a new license by satisfying the procedures and  
4 requirements as prescribed by the director by rule.

5 The director shall issue to each active licensee a license and a  
6 pocket identification card in such form and size as he or she shall  
7 prescribe.

8 **Sec. 11.** RCW 18.85.150 and 1979 c 25 s 3 are each amended to read  
9 as follows:

10 A temporary broker's permit may, in the discretion of the director,  
11 be issued to the legally accredited representative of a deceased or  
12 incapacitated broker, the senior qualified (~~(salesman)~~) salesperson in  
13 that office or other qualified representative of the deceased or  
14 incapacitated broker, which shall be valid for a period not exceeding  
15 four months and in the case of a partnership, a limited liability  
16 partnership, a limited liability company, or a corporation, the same  
17 rule shall prevail in the selection of a person to whom a temporary  
18 broker's permit may be issued.

19 **Sec. 12.** RCW 18.85.155 and 1977 ex.s. c 370 s 6 are each amended  
20 to read as follows:

21 Responsibility for any (~~(salesman)~~) salesperson, associate broker  
22 or branch manager in conduct covered by this chapter shall rest with  
23 the broker to which such licensees shall be licensed.

24 In addition to the broker, a branch manager shall bear  
25 responsibility for (~~(salesmen)~~) salespersons and associate brokers  
26 operating under the branch manager at a branch office.

27 **Sec. 13.** RCW 18.85.165 and 1991 c 225 s 1 are each amended to read  
28 as follows:

29 All real estate brokers, associate brokers, and salespersons shall  
30 furnish proof as the director may require that they have successfully  
31 completed a total of thirty clock hours of instruction every two years  
32 in real estate courses approved by the director in order to renew their  
33 licenses. Up to fifteen clock hours of instruction beyond the thirty  
34 hours in two years may be carried forward for credit in a subsequent  
35 two-year period. To count towards this requirement, a course shall be  
36 commenced within thirty-six months before the proof date for renewal.



1 Examinations shall not be required to fulfill any part of the education  
2 requirement in this section. This section shall apply to renewal dates  
3 after January 1, 1991.

4 **Sec. 14.** RCW 18.85.170 and 1972 ex.s. c 139 s 16 are each amended  
5 to read as follows:

6 No license issued under the provisions of this chapter shall  
7 authorize any person other than the person to whom it is issued to do  
8 any act by virtue thereof nor to operate in any other manner than under  
9 his or her own name except:

10 (1) When a license is issued to a corporation it shall entitle one  
11 officer thereof, to be named by the corporation in its application, who  
12 shall qualify the same as any other (~~(agent)~~) broker, to act as a real  
13 estate broker on behalf of said corporation, without the payment of  
14 additional fees;

15 (2) When a license is issued to a limited liability company it  
16 shall entitle one manager or member of the company, to be named by the  
17 limited liability company in its application, who shall qualify the  
18 same as any broker, to act as a real estate broker on behalf of the  
19 limited liability company, without the payment of additional fees;

20 (3) When a license is issued to a (~~(copartnership)~~) limited  
21 liability company or partnership it shall entitle one (~~(member)~~)  
22 partner thereof to be named in the application, who shall qualify to  
23 act as a real estate broker on behalf of the (~~(copartnership)~~) limited  
24 liability partnership or partnership, without the payment of additional  
25 license fees;

26 (~~((+3))~~) (4) A licensed broker, associate broker, or (~~(salesman)~~)  
27 salesperson may operate and/or advertise under a name other than the  
28 one under which the license is issued by obtaining the written consent  
29 of the director to do so;

30 (~~((+4))~~) (5) A broker may establish one or more branch offices under  
31 a name or names different from that of the main office if the name or  
32 names are approved by the director, so long as each branch office is  
33 clearly identified as a branch or division of the main office. No  
34 broker may establish branch offices under more than three names. Both  
35 the name of the branch office and of the main office must clearly  
36 appear on the sign identifying the office, if any, and in any  
37 advertisement or on any letterhead of any stationery or any forms, or

1 signs used by the real estate firm on which either the name of the main  
2 or branch offices appears.

3 **Sec. 15.** RCW 18.85.180 and 1957 c 52 s 41 are each amended to read  
4 as follows:

5 Every licensed real estate broker must have and maintain an office  
6 in this state accessible to the public which shall serve as ~~((his))~~ the  
7 office for the transaction of business. Any office so established must  
8 comply with the zoning requirements of city or county ordinances and  
9 the broker's license must be prominently displayed therein.

10 **Sec. 16.** RCW 18.85.210 and 1972 ex.s. c 139 s 18 are each amended  
11 to read as follows:

12 The director may publish ~~((annually a list of names and addresses  
13 of brokers and salesmen licensed under the provisions hereof, together  
14 with))~~ a copy of this chapter and such information relative to the  
15 enforcement of ~~((the provisions hereof as he may deem of interest to  
16 the public;))~~ this chapter and ~~((he))~~ may mail ~~((one))~~ a copy  
17 ~~((thereof))~~ of this chapter and the information to each licensed  
18 broker.

19 **Sec. 17.** RCW 18.85.230 and 1996 c 179 s 18 are each amended to  
20 read as follows:

21 The director may, upon his or her own motion, and shall upon  
22 verified complaint in writing by any person, investigate the actions of  
23 any person engaged in the business or acting in the capacity of a real  
24 estate broker, associate real estate broker, or real estate  
25 salesperson, regardless of whether the transaction was for his or her  
26 own account or in his or her capacity as broker, associate real estate  
27 broker, or real estate salesperson, and may impose any one or more of  
28 the following sanctions: Suspend or revoke, levy a fine not to exceed  
29 one thousand dollars for each offense, require the completion of a  
30 course in a selected area of real estate practice relevant to the  
31 section of this chapter or rule violated, or deny the license of any  
32 holder or applicant who is guilty of:

33 (1) Obtaining a license by means of fraud, misrepresentation,  
34 concealment, or through the mistake or inadvertence of the director;

35 (2) Violating any of the provisions of this chapter or any lawful  
36 rules or regulations made by the director pursuant thereto or violating

1 a provision of chapter 64.36, 19.105, or 58.19 RCW or RCW 18.86.030 or  
2 the rules adopted under those chapters or section;

3 (3) Being convicted in a court of competent jurisdiction of this or  
4 any other state, or federal court, of forgery, embezzlement, obtaining  
5 money under false pretenses, bribery, larceny, extortion, conspiracy to  
6 defraud, or any similar offense or offenses: PROVIDED, That for the  
7 purposes of this section being convicted shall include all instances in  
8 which a plea of guilty or nolo contendere is the basis for the  
9 conviction, and all proceedings in which the sentence has been deferred  
10 or suspended;

11 (4) Making, printing, publishing, distributing, or causing,  
12 authorizing, or knowingly permitting the making, printing, publication  
13 or distribution of false statements, descriptions or promises of such  
14 character as to reasonably induce any person to act thereon, if the  
15 statements, descriptions or promises purport to be made or to be  
16 performed by either the licensee or his or her principal and the  
17 licensee then knew or, by the exercise of reasonable care and inquiry,  
18 could have known, of the falsity of the statements, descriptions or  
19 promises;

20 (5) Knowingly committing, or being a party to, any material fraud,  
21 misrepresentation, concealment, conspiracy, collusion, trick, scheme or  
22 device whereby any other person lawfully relies upon the word,  
23 representation or conduct of the licensee;

24 (6) Accepting the services of, or continuing in a representative  
25 capacity, any associate broker or salesperson who has not been granted  
26 a license, or after his or her license has been revoked or during a  
27 suspension thereof;

28 (7) Conversion of any money, contract, deed, note, mortgage, or  
29 abstract or other evidence of title, to his or her own use or to the  
30 use of his or her principal or of any other person, when delivered to  
31 him or her in trust or on condition, in violation of the trust or  
32 before the happening of the condition; and failure to return any money  
33 or contract, deed, note, mortgage, abstract or other evidence of title  
34 within thirty days after the owner thereof is entitled thereto, and  
35 makes demand therefor, shall be prima facie evidence of such  
36 conversion;

37 (8) Failing, upon demand, to disclose any information within his or  
38 her knowledge to, or to produce any document, book or record in his or

1 her possession for inspection of the director or his or her authorized  
2 representatives acting by authority of law;

3 (9) Continuing to sell any real estate, or operating according to  
4 a plan of selling, whereby the interests of the public are endangered,  
5 after the director has, by order in writing, stated objections thereto;

6 (10) Committing any act of fraudulent or dishonest dealing or a  
7 crime involving moral turpitude, and a certified copy of the final  
8 holding of any court of competent jurisdiction in such matter shall be  
9 conclusive evidence in any hearing under this chapter;

10 (11) Advertising in any manner without affixing the broker's name  
11 as licensed, and in the case of a salesperson or associate broker,  
12 without affixing the name of the broker as licensed for whom or under  
13 whom the salesperson or associate broker operates, to the  
14 advertisement; except, that a real estate broker, associate real estate  
15 broker, or real estate salesperson advertising their personally owned  
16 real property must only disclose that they hold a real estate license;

17 (12) Accepting other than cash or its equivalent as earnest money  
18 unless that fact is communicated to the owner prior to his or her  
19 acceptance of the offer to purchase, and such fact is shown in the  
20 earnest money receipt;

21 (13) Charging or accepting compensation from more than one party in  
22 any one transaction without first making full disclosure in writing of  
23 all the facts to all the parties interested in the transaction;

24 (14) Accepting, taking or charging any undisclosed commission,  
25 rebate or direct profit on expenditures made for the principal;

26 (15) Accepting employment or compensation for appraisal of real  
27 property contingent upon reporting a predetermined value;

28 (16) Issuing an appraisal report on any real property in which the  
29 broker, associate broker, or salesperson has an interest unless his or  
30 her interest is clearly stated in the appraisal report;

31 (17) Misrepresentation of his or her membership in any state or  
32 national real estate association;

33 (18) Discrimination against any person in hiring or in sales  
34 activity, on the basis of (~~race, color, creed or national origin, or~~  
35 ~~violating~~)) any of the provisions of any state or federal  
36 antidiscrimination law;

37 (19) Failing to keep an escrow or trustee account of funds  
38 deposited with him or her relating to a real estate transaction, for a  
39 period of three years, showing to whom paid, and such other pertinent

1 information as the director may require, such records to be available  
2 to the director, or his or her representatives, on demand, or upon  
3 written notice given to the bank;

4 (20) Failing to preserve for three years following its consummation  
5 records relating to any real estate transaction;

6 (21) Failing to furnish a copy of any listing, sale, lease or other  
7 contract relevant to a real estate transaction to all signatories  
8 thereof at the time of execution;

9 (22) Acceptance by a branch manager, associate broker, or  
10 salesperson of a commission or any valuable consideration for the  
11 performance of any acts specified in this chapter, from any person,  
12 except the licensed real estate broker with whom he or she is licensed;

13 (23) To direct any transaction involving his or her principal, to  
14 any lending institution for financing or to any escrow company, in  
15 expectation of receiving a kickback or rebate therefrom, without first  
16 disclosing such expectation to his or her principal;

17 (24) Buying, selling, or leasing directly, or through a third  
18 party, any interest in real property without disclosing in writing that  
19 he or she holds a real estate license;

20 (25) In the case of a broker licensee, failing to exercise adequate  
21 supervision over the activities of his or her licensed associate  
22 brokers and salespersons within the scope of this chapter;

23 (26) Any conduct in a real estate transaction which demonstrates  
24 bad faith, dishonesty, untrustworthiness or incompetency;
