1            AN ACT Relating to retailer licenses for the sale of alcoholic  
2 beverages; amending RCW 66.44.310, 66.24.400, 66.08.180, 66.08.220,  
3 66.20.010, 66.20.310, 66.24.410, and 66.24.440; reenacting and amending  
4 RCW 66.04.010 and 66.24.420; adding a new section to chapter 66.24 RCW;  
5 and providing an effective date.

6            BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7            **Sec. 1.** RCW 66.04.010 and 2006 c 225 s 1 and 2006 c 101 s 1 are  
8 each reenacted and amended to read as follows:

9            In this title, unless the context otherwise requires:

10            (1) "Alcohol" is that substance known as ethyl alcohol, hydrated  
11 oxide of ethyl, or spirit of wine, which is commonly produced by the  
12 fermentation or distillation of grain, starch, molasses, or sugar, or  
13 other substances including all dilutions and mixtures of this  
14 substance. The term "alcohol" does not include alcohol in the  
15 possession of a manufacturer or distiller of alcohol fuel, as described  
16 in RCW 66.12.130, which is intended to be denatured and used as a fuel  
17 for use in motor vehicles, farm implements, and machines or implements  
18 of husbandry.

19            (2) "Authorized representative" means a person who:

1 (a) Is required to have a federal basic permit issued pursuant to  
2 the federal alcohol administration act, 27 U.S.C. Sec. 204;

3 (b) Has its business located in the United States outside of the  
4 state of Washington;

5 (c) Acquires ownership of beer or wine for transportation into and  
6 resale in the state of Washington; and which beer or wine is produced  
7 anywhere outside Washington by a brewery or winery which does not hold  
8 a certificate of approval issued by the board; and

9 (d) Is appointed by the brewery or winery referenced in (c) of this  
10 subsection as its exclusive authorized representative for marketing and  
11 selling its products within the United States in accordance with a  
12 written agreement between the authorized representative and such  
13 brewery or winery pursuant to this title. The board may waive the  
14 requirement for the written agreement of exclusivity in situations  
15 consistent with the normal marketing practices of certain products,  
16 such as classified growths.

17 (3) "Beer" means any malt beverage, flavored malt beverage, or malt  
18 liquor as these terms are defined in this chapter.

19 (4) "Beer distributor" means a person who buys beer from a domestic  
20 brewery, microbrewery, beer certificate of approval holder, or beer  
21 importers, or who acquires foreign produced beer from a source outside  
22 of the United States, for the purpose of selling the same pursuant to  
23 this title, or who represents such brewer or brewery as agent.

24 (5) "Beer importer" means a person or business within Washington  
25 who purchases beer from a beer certificate of approval holder or who  
26 acquires foreign produced beer from a source outside of the United  
27 States for the purpose of selling the same pursuant to this title.

28 (6) "Brewer" or "brewery" means any person engaged in the business  
29 of manufacturing beer and malt liquor. Brewer includes a brand owner  
30 of malt beverages who holds a brewer's notice with the federal bureau  
31 of alcohol, tobacco, and firearms at a location outside the state and  
32 whose malt beverage is contract-produced by a licensed in-state  
33 brewery, and who may exercise within the state, under a domestic  
34 brewery license, only the privileges of storing, selling to licensed  
35 beer distributors, and exporting beer from the state.

36 (7) "Board" means the liquor control board, constituted under this  
37 title.

1 (8) "Club" means an organization of persons, incorporated or  
2 unincorporated, operated solely for fraternal, benevolent, educational,  
3 athletic or social purposes, and not for pecuniary gain.

4 (9) "Consume" includes the putting of liquor to any use, whether by  
5 drinking or otherwise.

6 (10) "Contract liquor store" means a business that sells liquor on  
7 behalf of the board through a contract with a contract liquor store  
8 manager.

9 (11) "Dentist" means a practitioner of dentistry duly and regularly  
10 licensed and engaged in the practice of his profession within the state  
11 pursuant to chapter 18.32 RCW.

12 (12) "Distiller" means a person engaged in the business of  
13 distilling spirits.

14 (13) "Domestic brewery" means a place where beer and malt liquor  
15 are manufactured or produced by a brewer within the state.

16 (14) "Domestic winery" means a place where wines are manufactured  
17 or produced within the state of Washington.

18 (15) "Druggist" means any person who holds a valid certificate and  
19 is a registered pharmacist and is duly and regularly engaged in  
20 carrying on the business of pharmaceutical chemistry pursuant to  
21 chapter 18.64 RCW.

22 (16) "Drug store" means a place whose principal business is, the  
23 sale of drugs, medicines and pharmaceutical preparations and maintains  
24 a regular prescription department and employs a registered pharmacist  
25 during all hours the drug store is open.

26 (17) "Employee" means any person employed by the board.

27 (18) "Flavored malt beverage" means:

28 (a) A malt beverage containing six percent or less alcohol by  
29 volume to which flavoring or other added nonbeverage ingredients are  
30 added that contain distilled spirits of not more than forty-nine  
31 percent of the beverage's overall alcohol content; or

32 (b) A malt beverage containing more than six percent alcohol by  
33 volume to which flavoring or other added nonbeverage ingredients are  
34 added that contain distilled spirits of not more than one and one-half  
35 percent of the beverage's overall alcohol content.

36 (19) "Fund" means 'liquor revolving fund.'

37 (20) "Hotel" means every building (~~or other~~), structure, and  
38 amenities as may be offered that are kept, used, maintained,

1 advertised, or held out to the public to be a place where food is  
2 served and sleeping accommodations are offered for pay to transient  
3 guests, in which twenty or more rooms are used for the sleeping  
4 accommodation of such transient guests and (~~having one or more dining~~  
5 ~~rooms where meals are served to such transient guests, such sleeping~~  
6 ~~accommodations and dining rooms being conducted in the same building~~  
7 ~~and buildings, in connection therewith, and such structure or~~  
8 ~~structures being provided, in the judgment of the board, with adequate~~  
9 ~~and sanitary kitchen and dining room equipment and capacity, for~~  
10 ~~preparing, cooking and serving suitable food for its guests: PROVIDED~~  
11 ~~FURTHER, That in cities and towns of less than five thousand~~  
12 ~~population, the board shall have authority to waive the provisions~~  
13 ~~requiring twenty or more rooms)) shall include all grounds and other  
14 buildings or structures as may exist thereon and any amenities whether  
15 exterior or within a structure or building as may be offered, and  
16 having facilities for preparing, cooking, and serving food.~~

17 (21) "Importer" means a person who buys distilled spirits from a  
18 distillery outside the state of Washington and imports such spirituous  
19 liquor into the state for sale to the board or for export.

20 (22) "Imprisonment" means confinement in the county jail.

21 (23) "Liquor" includes the four varieties of liquor herein defined  
22 (alcohol, spirits, wine and beer), and all fermented, spirituous,  
23 vinous, or malt liquor, or combinations thereof, and mixed liquor, a  
24 part of which is fermented, spirituous, vinous or malt liquor, or  
25 otherwise intoxicating; and every liquid or solid or semisolid or other  
26 substance, patented or not, containing alcohol, spirits, wine or beer,  
27 and all drinks or drinkable liquids and all preparations or mixtures  
28 capable of human consumption, and any liquid, semisolid, solid, or  
29 other substance, which contains more than one percent of alcohol by  
30 weight shall be conclusively deemed to be intoxicating. Liquor does  
31 not include confections or food products that contain one percent or  
32 less of alcohol by weight.

33 (24) "Manufacturer" means a person engaged in the preparation of  
34 liquor for sale, in any form whatsoever.

35 (25) "Malt beverage" or "malt liquor" means any beverage such as  
36 beer, ale, lager beer, stout, and porter obtained by the alcoholic  
37 fermentation of an infusion or decoction of pure hops, or pure extract  
38 of hops and pure barley malt or other wholesome grain or cereal in pure

1 water containing not more than eight percent of alcohol by weight, and  
2 not less than one-half of one percent of alcohol by volume. For the  
3 purposes of this title, any such beverage containing more than eight  
4 percent of alcohol by weight shall be referred to as "strong beer."

5 (26) "Package" means any container or receptacle used for holding  
6 liquor.

7 (27) "Passenger vessel" means any boat, ship, vessel, barge, or  
8 other floating craft of any kind carrying passengers for compensation.

9 (28) "Permit" means a permit for the purchase of liquor under this  
10 title.

11 (29) "Person" means an individual, copartnership, association, or  
12 corporation.

13 (30) "Physician" means a medical practitioner duly and regularly  
14 licensed and engaged in the practice of his profession within the state  
15 pursuant to chapter 18.71 RCW.

16 (31) "Prescription" means a memorandum signed by a physician and  
17 given by him to a patient for the obtaining of liquor pursuant to this  
18 title for medicinal purposes.

19 (32) "Public place" includes streets and alleys of incorporated  
20 cities and towns; state or county or township highways or roads;  
21 buildings and grounds used for school purposes; public dance halls and  
22 grounds adjacent thereto; those parts of establishments where beer may  
23 be sold under this title, soft drink establishments, public buildings,  
24 public meeting halls, lobbies, halls and dining rooms of hotels,  
25 restaurants, theatres, stores, garages and filling stations which are  
26 open to and are generally used by the public and to which the public is  
27 permitted to have unrestricted access; railroad trains, stages, and  
28 other public conveyances of all kinds and character, and the depots and  
29 waiting rooms used in conjunction therewith which are open to  
30 unrestricted use and access by the public; publicly owned bathing  
31 beaches, parks, and/or playgrounds; and all other places of like or  
32 similar nature to which the general public has unrestricted right of  
33 access, and which are generally used by the public.

34 (33) "Regulations" means regulations made by the board under the  
35 powers conferred by this title.

36 (34) "Restaurant" means any establishment provided with special  
37 space and accommodations where, in consideration of payment, food,

1 without lodgings, is habitually furnished to the public, not including  
2 drug stores and soda fountains.

3 (35) "Sale" and "sell" include exchange, barter, and traffic; and  
4 also include the selling or supplying or distributing, by any means  
5 whatsoever, of liquor, or of any liquid known or described as beer or  
6 by any name whatever commonly used to describe malt or brewed liquor or  
7 of wine, by any person to any person; and also include a sale or  
8 selling within the state to a foreign consignee or his agent in the  
9 state. "Sale" and "sell" shall not include the giving, at no charge,  
10 of a reasonable amount of liquor by a person not licensed by the board  
11 to a person not licensed by the board, for personal use only. "Sale"  
12 and "sell" also does not include a raffle authorized under RCW  
13 9.46.0315: PROVIDED, That the nonprofit organization conducting the  
14 raffle has obtained the appropriate permit from the board.

15 (36) "Soda fountain" means a place especially equipped with  
16 apparatus for the purpose of dispensing soft drinks, whether mixed or  
17 otherwise.

18 (37) "Spirits" means any beverage which contains alcohol obtained  
19 by distillation, except flavored malt beverages, but including wines  
20 exceeding twenty-four percent of alcohol by volume.

21 (38) "Store" means a state liquor store established under this  
22 title.

23 (39) "Tavern" means any establishment with special space and  
24 accommodation for sale by the glass and for consumption on the  
25 premises, of beer, as herein defined.

26 (40) "Winery" means a business conducted by any person for the  
27 manufacture of wine for sale, other than a domestic winery.

28 (41)(a) "Wine" means any alcoholic beverage obtained by  
29 fermentation of fruits (grapes, berries, apples, et cetera) or other  
30 agricultural product containing sugar, to which any saccharine  
31 substances may have been added before, during or after fermentation,  
32 and containing not more than twenty-four percent of alcohol by volume,  
33 including sweet wines fortified with wine spirits, such as port,  
34 sherry, muscatel and angelica, not exceeding twenty-four percent of  
35 alcohol by volume and not less than one-half of one percent of alcohol  
36 by volume. For purposes of this title, any beverage containing no more  
37 than fourteen percent of alcohol by volume when bottled or packaged by  
38 the manufacturer shall be referred to as "table wine," and any beverage

1 containing alcohol in an amount more than fourteen percent by volume  
2 when bottled or packaged by the manufacturer shall be referred to as  
3 "fortified wine." However, "fortified wine" shall not include: (i)  
4 Wines that are both sealed or capped by cork closure and aged two years  
5 or more; and (ii) wines that contain more than fourteen percent alcohol  
6 by volume solely as a result of the natural fermentation process and  
7 that have not been produced with the addition of wine spirits, brandy,  
8 or alcohol.

9 (b) This subsection shall not be interpreted to require that any  
10 wine be labeled with the designation "table wine" or "fortified wine."

11 (42) "Wine distributor" means a person who buys wine from a  
12 domestic winery, wine certificate of approval holder, or wine importer,  
13 or who acquires foreign produced wine from a source outside of the  
14 United States, for the purpose of selling the same not in violation of  
15 this title, or who represents such vintner or winery as agent.

16 (43) "Wine importer" means a person or business within Washington  
17 who purchases wine from a wine certificate of approval holder or who  
18 acquires foreign produced wine from a source outside of the United  
19 States for the purpose of selling the same pursuant to this title.

20 NEW SECTION. **Sec. 2.** A new section is added to chapter 66.24 RCW  
21 to read as follows:

22 (1) There shall be a retailer's license to be designated as a hotel  
23 license. The hotel license may be issued to an applicant regardless of  
24 whether the applicant holds any other class of retail license under  
25 this title. No license may be issued to a hotel offering rooms to its  
26 guests on an hourly basis. If all or any facilities for alcoholic  
27 beverage service and the preparation, cooking, and serving of food are  
28 operated under contract or joint venture agreement, the operator may  
29 hold a license separate from the license held by the operator of the  
30 hotel. Food and beverage inventory used in separate licensed  
31 operations at the hotel may not be shared and shall be separately owned  
32 and stored by the separate licensees. Food service provided for room  
33 service, banquets or conferences, or restaurant operation under this  
34 license shall meet the requirements of rules adopted by the board.

35 (2) The hotel license authorizes the licensee to:

36 (a) Sell, at retail, from locked honor bars, in individual units,  
37 spirits not to exceed fifty milliliters, beer in individual units not

1 to exceed twelve ounces, and wine in individual bottles not to exceed  
2 three hundred eighty-five milliliters, to registered guests of the  
3 hotel for consumption in guest rooms.

4 (i) All spirits to be sold under the license must be purchased from  
5 the board.

6 (ii) The licensee shall require proof of age from the guest renting  
7 a guest room and requesting the use of an honor bar. The guest shall  
8 also execute an affidavit verifying that no one under twenty-one years  
9 of age shall have access to the spirits, beer, and wine in the honor  
10 bar;

11 (b) Provide without additional charge, to overnight guests,  
12 spirits, beer, and wine, including wine by the bottle, by the  
13 individual serving for on-premises consumption at a specified regular  
14 date, time, and place as may be fixed by the board. Self-service by  
15 attendees is prohibited. All alcoholic beverage service must be done  
16 by an alcohol server as defined in RCW 66.20.300 and comply with RCW  
17 66.20.310;

18 (c) Sell beer, including strong beer, wine, or spirits, in the  
19 manufacturer's sealed container or by the individual drink to guests  
20 through room service, or through service to occupants of private  
21 residential units managed by the hotel;

22 (d) Sell beer, including strong beer, or wine, in the  
23 manufacturer's sealed container at retail sales locations within the  
24 hotel premises;

25 (e) Sell for on or off-premises consumption, including through room  
26 service and service to occupants of private residential units managed  
27 by the hotel, wine carrying a label exclusive to the hotel license  
28 holder;

29 (f) Place in guest rooms at check-in, a complimentary bottle of  
30 beer, including strong beer, or wine, including wine carrying a label  
31 exclusive to the hotel license holder, in a manufacturer-sealed  
32 container, and make a reference to this service in promotional  
33 material.

34 (3)(a) The facilities may be owned or leased, and operated by the  
35 hotel or another party under a contract or joint venture agreement with  
36 the licensee, or may be owned or leased, and operated by another party  
37 holding a contract or joint venture agreement with the licensee. Food



1 and alcohol beverage service for banquets and conferences at the hotel  
2 and for guest rooms shall be provided by the hotel or through another  
3 party operating the food and beverage services at the hotel's location.

4 (b) The license issued to a hotel shall be valid only upon the  
5 contiguous property of the hotel, and where all facilities and grounds  
6 at the hotel are owned or leased by the same person or persons.

7 (4)(a) The hotel license allows the licensee to remove from the  
8 liquor stocks at the licensed premises, liquor for sale and service at  
9 event locations at a specified date and place not currently licensed by  
10 the board. If the event is open to the public, it must be sponsored by  
11 a society or organization as defined by RCW 66.24.375. If attendance  
12 at the event is limited to members or invited guests of the sponsoring  
13 individual, society, or organization, the requirement that the sponsor  
14 must be a society or organization as defined by RCW 66.24.375 is  
15 waived.

16 (b) The holder of this license shall, if requested by the board,  
17 notify the board or its designee of the date, time, place, and location  
18 of any event. Upon request, the licensee shall provide to the board  
19 all necessary or requested information concerning the society or  
20 organization that will be holding the function at which the endorsed  
21 license will be utilized.

22 (c) Licensees may cater events on a domestic winery premises.

23 (5) The holder of this license or its manager may furnish beer or  
24 wine to the licensee's employees who are twenty-one years of age or  
25 older free of charge as may be required for use in connection with  
26 instruction on beer and wine. The instruction may include the history,  
27 nature, values, and characteristics of beer or wine, the use of wine  
28 lists, and the methods of presenting, serving, storing, and handling  
29 beer or wine. The licensee must use the beer or wine it obtains under  
30 its license for the sampling as part of the instruction. The  
31 instruction must be given on the premises of the licensee.

32 (6) Minors may be allowed in all areas of the hotel where alcohol  
33 may be consumed; however, the consumption must be incidental to the  
34 primary use of the area. These areas include, but are not limited to,  
35 tennis courts, hotel lobbies, and swimming pool areas. If an area is  
36 not a mixed use area, and is primarily used for alcohol service, the  
37 area must be designated and restricted to access by minors.

1 (7) Minors may be allowed for special dining occasions in an area,  
2 such as a lounge that is normally off-limits to minors, if no seating  
3 or beverage consumption is allowed at a bar, which may be used as a  
4 service bar for the special dining occasion, if dining will predominate  
5 over the consumption of alcoholic beverages during the special use, and  
6 if the license holder has provided advance written notice to the board  
7 of the occasion, date, and hours of the special use. Once advance  
8 written notice has been received for an event, the licensee will not be  
9 required to provide such notice again for any similar event for that  
10 calendar year.

11 (8) The annual fee for this license is two thousand dollars. The  
12 fee shall be prorated according to the calendar quarters, or portion  
13 thereof, during which the licensee is open for business, except in case  
14 of suspension or revocation of the license.

15 (9) As used in this section, "hotel," "spirits," "beer," and "wine"  
16 have the meanings defined in RCW 66.24.410 and 66.04.010.

17 **Sec. 3.** RCW 66.44.310 and 1998 c 126 s 14 are each amended to read  
18 as follows:

19 (1) Except as otherwise provided by RCW 66.44.316 (~~and~~),  
20 66.44.350, and section 2 of this act, it shall be a misdemeanor:

21 (a) To serve or allow to remain in any area classified by the board  
22 as off-limits to any person under the age of twenty-one years;

23 (b) For any person under the age of twenty-one years to enter or  
24 remain in any area classified as off-limits to such a person, but  
25 persons under twenty-one years of age may pass through a restricted  
26 area in a facility holding a spirits, beer, and wine private club  
27 license;

28 (c) For any person under the age of twenty-one years to represent  
29 his or her age as being twenty-one or more years for the purpose of  
30 purchasing liquor or securing admission to, or remaining in any area  
31 classified by the board as off-limits to such a person.

32 (2) The Washington state liquor control board shall have the power  
33 and it shall be its duty to classify licensed premises or portions of  
34 licensed premises as off-limits to persons under the age of twenty-one  
35 years of age.

1       **Sec. 4.** RCW 66.24.400 and 2005 c 152 s 2 are each amended to read  
2 as follows:

3       (1) There shall be a retailer's license, to be known and designated  
4 as a spirits, beer, and wine restaurant license, to sell spirituous  
5 liquor by the individual glass, beer, and wine, at retail, for  
6 consumption on the premises, including mixed drinks and cocktails  
7 compounded or mixed on the premises only(~~(:—PROVIDED, That a hotel,~~  
8 ~~or)~~). A club licensed under chapter 70.62 RCW with overnight sleeping  
9 accommodations, that is licensed under this section may sell liquor by  
10 the bottle to registered guests of the (~~hotel—or~~) club for  
11 consumption in guest rooms, hospitality rooms, or at banquets in the  
12 (~~hotel—or~~) club(~~(:—PROVIDED FURTHER, That)~~). A patron of a bona  
13 fide (~~hotel,~~) restaurant(~~(,)~~) or club licensed under this section may  
14 remove from the premises recorked or recapped in its original container  
15 any portion of wine which was purchased for consumption with a meal,  
16 and registered guests who have purchased liquor from the (~~hotel—or~~)  
17 club by the bottle may remove from the premises any unused portion of  
18 such liquor in its original container. Such license may be issued only  
19 to bona fide restaurants(~~(, hotels)~~) and clubs, and to dining, club and  
20 buffet cars on passenger trains, and to dining places on passenger  
21 boats and airplanes, and to dining places at civic centers with  
22 facilities for sports, entertainment, and conventions, and to such  
23 other establishments operated and maintained primarily for the benefit  
24 of tourists, vacationers and travelers as the board shall determine are  
25 qualified to have, and in the discretion of the board should have, a  
26 spirits, beer, and wine restaurant license under the provisions and  
27 limitations of this title.

28       (2) The board may issue an endorsement to the spirits, beer, and  
29 wine restaurant license that allows the holder of a spirits, beer, and  
30 wine restaurant license to sell for off-premises consumption wine  
31 vinted and bottled in the state of Washington and carrying a label  
32 exclusive to the license holder selling the wine. Spirits and beer may  
33 not be sold for off-premises consumption under this section. The  
34 annual fee for the endorsement under this subsection is one hundred  
35 twenty dollars.

36       (3) The holder of a spirits, beer, and wine license or its manager  
37 may furnish beer, wine, or spirituous liquor to the licensee's  
38 employees free of charge as may be required for use in connection with

1 instruction on beer, wine, or spirituous liquor. The instruction may  
2 include the history, nature, values, and characteristics of beer, wine,  
3 or spirituous liquor, the use of wine lists, and the methods of  
4 presenting, serving, storing, and handling beer, wine, and spirituous  
5 liquor. The spirits, beer, and wine restaurant licensee must use the  
6 beer, wine, or spirituous liquor it obtains under its license for the  
7 sampling as part of the instruction. The instruction must be given on  
8 the premises of the spirits, beer, and wine restaurant licensee.

9 **Sec. 5.** RCW 66.08.180 and 2000 c 192 s 1 are each amended to read  
10 as follows:

11 Except as provided in RCW 66.24.290(1), moneys in the liquor  
12 revolving fund shall be distributed by the board at least once every  
13 three months in accordance with RCW 66.08.190, 66.08.200 and 66.08.210:  
14 PROVIDED, That the board shall reserve from distribution such amount  
15 not exceeding five hundred thousand dollars as may be necessary for the  
16 proper administration of this title.

17 (1) All license fees, penalties and forfeitures derived under  
18 chapter 13, Laws of 1935 from spirits, beer, and wine restaurant;  
19 spirits, beer, and wine private club; hotel; and sports entertainment  
20 facility licenses or spirits, beer, and wine restaurant; spirits, beer,  
21 and wine private club; and sports entertainment facility licensees  
22 shall every three months be disbursed by the board as follows:

23 (a) Three hundred thousand dollars per biennium, to the death  
24 investigations account for the state toxicology program pursuant to RCW  
25 68.50.107; and

26 (b) Of the remaining funds:

27 (i) 6.06 percent to the University of Washington and 4.04 percent  
28 to Washington State University for alcoholism and drug abuse research  
29 and for the dissemination of such research; and

30 (ii) 89.9 percent to the general fund to be used by the department  
31 of social and health services solely to carry out the purposes of RCW  
32 70.96A.050;

33 (2) The first fifty-five dollars per license fee provided in RCW  
34 66.24.320 and 66.24.330 up to a maximum of one hundred fifty thousand  
35 dollars annually shall be disbursed every three months by the board to  
36 the general fund to be used for juvenile alcohol and drug prevention

1 programs for kindergarten through third grade to be administered by the
