1 AN ACT Relating to extending the date when counties east of the
2 crest of the Cascade mountains that pledged lodging tax revenue for
3 payment of bonds prior to June 26, 1975, must allow a credit for city
4 lodging taxes; and amending RCW 67.28.180.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 67.28.180 and 2002 c 178 s 2 are each amended to read
7 as follows:

8 (1) Subject to the conditions set forth in subsections (2) and (3)
9 of this section, the legislative body of any county or any city, is
10 authorized to levy and collect a special excise tax of not to exceed
11 two percent on the sale of or charge made for the furnishing of lodging
12 that is subject to tax under chapter 82.08 RCW.

13 (2) Any levy authorized by this section shall be subject to the
14 following:

15 (a) Any county ordinance or resolution adopted pursuant to this
16 section shall contain, in addition to all other provisions required to
17 conform to this chapter, a provision allowing a credit against the
18 county tax for the full amount of any city tax imposed pursuant to this
19 section upon the same taxable event.

1 (b) In the event that any county has levied the tax authorized by
2 this section and has, prior to June 26, 1975, either pledged the tax
3 revenues for payment of principal and interest on city revenue or
4 general obligation bonds authorized and issued pursuant to RCW
5 67.28.150 through 67.28.160 or has authorized and issued revenue or
6 general obligation bonds pursuant to the provisions of RCW 67.28.150
7 through 67.28.160, such county shall be exempt from the provisions of
8 (a) of this subsection, to the extent that the tax revenues are pledged
9 for payment of principal and interest on bonds issued at any time
10 pursuant to the provisions of RCW 67.28.150 through 67.28.160:
11 PROVIDED, That so much of such pledged tax revenues, together with any
12 investment earnings thereon, not immediately necessary for actual
13 payment of principal and interest on such bonds may be used: (i) In
14 any county with a population of one million or more, for repayment
15 either of limited tax levy general obligation bonds or of any county
16 fund or account from which a loan was made, the proceeds from the bonds
17 or loan being used to pay for constructing, installing, improving, and
18 equipping stadium capital improvement projects, and to pay for any
19 engineering, planning, financial, legal and professional services
20 incident to the development of such stadium capital improvement
21 projects, regardless of the date the debt for such capital improvement
22 projects was or may be incurred; (ii) in any county with a population
23 of one million or more, for repayment or refinancing of bonded
24 indebtedness incurred prior to January 1, 1997, for any purpose
25 authorized by this section or relating to stadium repairs or
26 rehabilitation, including but not limited to the cost of settling legal
27 claims, reimbursing operating funds, interest payments on short-term
28 loans, and any other purpose for which such debt has been incurred if
29 the county has created a public stadium authority to develop a stadium
30 and exhibition center under RCW 36.102.030; or (iii) in other counties,
31 for county-owned facilities for agricultural promotion until January 1,
32 2009, and thereafter for any purpose authorized in this chapter.

33 A county is exempt under this subsection (~~in~~) with respect to
34 city revenue or general obligation bonds issued after April 1, 1991,
35 only if such bonds mature before January 1, 2013. If any county
36 located east of the crest of the Cascade mountains has levied the tax
37 authorized by this section and has, prior to June 26, 1975, pledged the
38 tax revenue for payment of principal and interest on city revenue or

1 general obligation bonds, the county is exempt under this subsection
2 with respect to revenue or general obligation bonds issued after
3 January 1, 2007, only if the bonds mature before January 1, 2021. Such
4 a county may only use funds under this subsection (2)(b) for
5 constructing or improving facilities authorized under this chapter,
6 including county-owned facilities for agricultural promotion, and must
7 perform an annual financial audit of organizations receiving funding on
8 the use of the funds.

9 As used in this subsection (2)(b), "capital improvement projects"
10 may include, but not be limited to a stadium restaurant facility,
11 restroom facilities, artificial turf system, seating facilities,
12 parking facilities and scoreboard and information system adjacent to or
13 within a county owned stadium, together with equipment, utilities,
14 accessories and appurtenances necessary thereto. The stadium
15 restaurant authorized by this subsection (2)(b) shall be operated by a
16 private concessionaire under a contract with the county.

17 (c)(i) No city within a county exempt under subsection (2)(b) of
18 this section may levy the tax authorized by this section so long as
19 said county is so exempt.

20 (ii) If bonds have been issued under RCW 43.99N.020 and any
21 necessary property transfers have been made under RCW 36.102.100, no
22 city within a county with a population of one million or more may levy
23 the tax authorized by this section before January 1, 2021.

24 (iii) However, in the event that any city in a county described in
25 (i) or (ii) of this subsection (2)(c) has levied the tax authorized by
26 this section and has, prior to June 26, 1975, authorized and issued
27 revenue or general obligation bonds pursuant to the provisions of RCW
28 67.28.150 through 67.28.160, such city may levy the tax so long as the
29 tax revenues are pledged for payment of principal and interest on bonds
30 issued at any time pursuant to the provisions of RCW 67.28.150 through
31 67.28.160.

32 (3) Any levy authorized by this section by a county that has levied
33 the tax authorized by this section and has, prior to June 26, 1975,
34 either pledged the tax revenues for payment of principal and interest
35 on city revenue or general obligation bonds authorized and issued
36 pursuant to RCW 67.28.150 through 67.28.160 or has authorized and
37 issued revenue or general obligation bonds pursuant to the provisions
38 of RCW 67.28.150 through 67.28.160 shall be subject to the following:

1 (a) Taxes collected under this section in any calendar year before
2 2013 in excess of five million three hundred thousand dollars shall
3 only be used as follows:

4 (i) Seventy-five percent from January 1, 1992, through December 31,
5 2000, and seventy percent from January 1, 2001, through December 31,
6 2012, for art museums, cultural museums, heritage museums, the arts,
7 and the performing arts. Moneys spent under this subsection (3)(a)(i)
8 shall be used for the purposes of this subsection (3)(a)(i) in all
9 parts of the county.

10 (ii) Twenty-five percent from January 1, 1992, through December 31,
11 2000, and thirty percent from January 1, 2001, through December 31,
12 2012, for the following purposes and in a manner reflecting the
13 following order of priority: Stadium purposes as authorized under
14 subsection (2)(b) of this section; acquisition of open space lands;
15 youth sports activities; and tourism promotion. If all or part of the
16 debt on the stadium is refinanced, all revenues under this subsection
17 (3)(a)(ii) shall be used to retire the debt.

18 (b) From January 1, 2013, through December 31, 2015, in a county
19 with a population of one million or more, all revenues under this
20 section shall be used to retire the debt on the stadium, or deposited
21 in the stadium and exhibition center account under RCW 43.99N.060 after
22 the debt on the stadium is retired.

23 (c) From January 1, 2016, through December 31, 2020, in a county
24 with a population of one million or more, all revenues under this
25 section shall be deposited in the stadium and exhibition center account
26 under RCW 43.99N.060.

27 (d) At least seventy percent of moneys spent under (a)(i) of this
28 subsection for the period January 1, 1992, through December 31, 2000,
29 shall be used only for the purchase, design, construction, and
30 remodeling of performing arts, visual arts, heritage, and cultural
31 facilities, and for the purchase of fixed assets that will benefit art,
32 heritage, and cultural organizations. For purposes of this subsection,
33 fixed assets are tangible objects such as machinery and other equipment
34 intended to be held or used for ten years or more. Moneys received
35 under this subsection (3)(d) may be used for payment of principal and
36 interest on bonds issued for capital projects. Qualifying
37 organizations receiving moneys under this subsection (3)(d) must be
38 financially stable and have at least the following:

1 (i) A legally constituted and working board of directors;
2 (ii) A record of artistic, heritage, or cultural accomplishments;
3 (iii) Been in existence and operating for at least two years;
4 (iv) Demonstrated ability to maintain net current liabilities at
5 less than thirty percent of general operating expenses;
6 (v) Demonstrated ability to sustain operational capacity subsequent
7 to completion of projects or purchase of machinery and equipment; and
8 (vi) Evidence that there has been independent financial review of
9 the organization.

10 (e) At least forty percent of the revenues distributed pursuant to
11 (a)(i) of this subsection for the period January 1, 2001, through
12 December 31, 2012, shall be deposited in an account and shall be used
13 to establish an endowment. Principal in the account shall remain
14 permanent and irreducible. The earnings from investments of balances
15 in the account may only be used for the purposes of (a)(i) of this
16 subsection.

17 (f) School districts and schools shall not receive revenues
18 distributed pursuant to (a)(i) of this subsection.

19 (g) Moneys distributed to art museums, cultural museums, heritage
20 museums, the arts, and the performing arts, and moneys distributed for
21 tourism promotion shall be in addition to and may not be used to
22 replace or supplant any other funding by the legislative body of the
23 county.

24 (h) As used in this section, "tourism promotion" includes
25 activities intended to attract visitors for overnight stays, arts,
26 heritage, and cultural events, and recreational, professional, and
27 amateur sports events. Moneys allocated to tourism promotion in a
28 class AA county shall be allocated to nonprofit organizations formed
29 for the express purpose of tourism promotion in the county. Such
30 organizations shall use moneys from the taxes to promote events in all
31 parts of the class AA county.

32 (i) No taxes collected under this section may be used for the
33 operation or maintenance of a public stadium that is financed directly
34 or indirectly by bonds to which the tax is pledged. Expenditures for
35 operation or maintenance include all expenditures other than
36 expenditures that directly result in new fixed assets or that directly
37 increase the capacity, life span, or operating economy of existing
38 fixed assets.

1 (j) No ad valorem property taxes may be used for debt service on
2 bonds issued for a public stadium that is financed by bonds to which
3 the tax is pledged, unless the taxes collected under this section are
4 or are projected to be insufficient to meet debt service requirements
5 on such bonds.

6 (k) If a substantial part of the operation and management of a
7 public stadium that is financed directly or indirectly by bonds to
8 which the tax is pledged is performed by a nonpublic entity or if a
9 public stadium is sold that is financed directly or indirectly by bonds
10 to which the tax is pledged, any bonds to which the tax is pledged
11 shall be retired. This subsection (3)(k) does not apply in respect to
12 a public stadium under chapter 36.102 RCW transferred to, owned by, or
13 constructed by a public facilities district under chapter 36.100 RCW or
14 a stadium and exhibition center.

15 (l) The county shall not lease a public stadium that is financed
16 directly or indirectly by bonds to which the tax is pledged to, or
17 authorize the use of the public stadium by, a professional major league
18 sports franchise unless the sports franchise gives the right of first
19 refusal to purchase the sports franchise, upon its sale, to local
20 government. This subsection (3)(l) does not apply to contracts in
21 existence on April 1, 1986.

22 If a court of competent jurisdiction declares any provision of this
23 subsection (3) invalid, then that invalid provision shall be null and
24 void and the remainder of this section is not affected.
