3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 42.17.2401 and 2006 c 265 s 113 are each amended to
5 read as follows:

6 For the purposes of RCW 42.17.240, the term "executive state
7 officer" includes:

8 (1) The chief administrative law judge, the director of
