1            AN ACT Relating to retail liquor licenses; amending RCW 66.24.375,  
2 66.08.150, 66.24.244, 66.24.240, 66.44.310, 66.24.400, 66.08.180,  
3 66.08.220, 66.20.010, 66.20.310, 66.24.410, and 66.24.440; reenacting  
4 and amending RCW 66.28.010, 66.24.244, 66.24.240, 66.24.420, 66.24.320,  
5 66.04.010, and 66.24.420; adding a new section to chapter 66.24 RCW;  
6 providing effective dates; and providing an expiration date.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8            **Sec. 1.** RCW 66.24.375 and 1997 c 321 s 61 are each amended to read  
9 as follows:

10            "Society or organization" as used in RCW 66.24.380 means a not-for-  
11 profit group organized and operated (1) solely for charitable,  
12 religious, social, political, educational, civic, fraternal, athletic,  
13 or benevolent purposes, or (2) as a local wine industry association  
14 registered under section 501(c)(6) of the internal revenue code as it  
15 exists on the effective date of this section. No portion of the  
16 profits from events sponsored by a not-for-profit group may be paid  
17 directly or indirectly to members, officers, directors, or trustees  
18 except for services performed for the organization. Any compensation  
19 paid to its officers and executives must be only for actual services

1 and at levels comparable to the compensation for like positions within  
2 the state. A society or organization which is registered with the  
3 secretary of state or the federal internal revenue service as a  
4 nonprofit organization (~~may~~) shall submit such registration, upon  
5 request, as proof that it is a not-for-profit group.

6 **Sec. 2.** RCW 66.28.010 and 2006 c 330 s 28, 2006 c 92 s 1, and 2006  
7 c 43 s 1 are each reenacted and amended to read as follows:

8 (1)(a) No manufacturer, importer, distributor, or authorized  
9 representative, or person financially interested, directly or  
10 indirectly, in such business; whether resident or nonresident, shall  
11 have any financial interest, direct or indirect, in any licensed retail  
12 business, unless the retail business is owned by a corporation in which  
13 a manufacturer or importer has no direct stock ownership and there are  
14 no interlocking officers and directors, the retail license is held by  
15 a corporation that is not owned directly or indirectly by a  
16 manufacturer or importer, the sales of liquor are incidental to the  
17 primary activity of operating the property as a hotel, alcoholic  
18 beverages produced by the manufacturer or importer or their  
19 subsidiaries are not sold at the licensed premises, and the board  
20 reviews the ownership and proposed method of operation of all involved  
21 entities and determines that there will not be an unacceptable level of  
22 control or undue influence over the operation or the retail licensee;  
23 nor shall any manufacturer, importer, distributor, or authorized  
24 representative own any of the property upon which such licensed persons  
25 conduct their business; nor shall any such licensed person, under any  
26 arrangement whatsoever, conduct his or her business upon property in  
27 which any manufacturer, importer, distributor, or authorized  
28 representative has any interest unless title to that property is owned  
29 by a corporation in which a manufacturer has no direct stock ownership  
30 and there are no interlocking officers or directors, the retail license  
31 is held by a corporation that is not owned directly or indirectly by  
32 the manufacturer, the sales of liquor are incidental to the primary  
33 activity of operating the property either as a hotel or as an  
34 amphitheater offering live musical and similar live entertainment  
35 activities to the public, alcoholic beverages produced by the  
36 manufacturer or any of its subsidiaries are not sold at the licensed  
37 premises, and the board reviews the ownership and proposed method of

1 operation of all involved entities and determines that there will not  
2 be an unacceptable level of control or undue influence over the  
3 operation of the retail licensee. Except as provided in subsection (3)  
4 of this section, no manufacturer, importer, distributor, or authorized  
5 representative shall advance moneys or moneys' worth to a licensed  
6 person under an arrangement, nor shall such licensed person receive,  
7 under an arrangement, an advance of moneys or moneys' worth. "Person"  
8 as used in this section only shall not include those state or federally  
9 chartered banks, state or federally chartered savings and loan  
10 associations, state or federally chartered mutual savings banks, or  
11 institutional investors which are not controlled directly or indirectly  
12 by a manufacturer, importer, distributor, or authorized representative  
13 as long as the bank, savings and loan association, or institutional  
14 investor does not influence or attempt to influence the purchasing  
15 practices of the retailer with respect to alcoholic beverages. Except  
16 as otherwise provided in this section, no manufacturer, importer,  
17 distributor, or authorized representative shall be eligible to receive  
18 or hold a retail license under this title, nor shall such manufacturer,  
19 importer, distributor, or authorized representative sell at retail any  
20 liquor as herein defined. A corporation granted an exemption under  
21 this subsection may use debt instruments issued in connection with  
22 financing construction or operations of its facilities.

23 (b) Nothing in this section shall prohibit a licensed domestic  
24 brewery or microbrewery from being licensed as a retailer pursuant to  
25 chapter 66.24 RCW for the purpose of selling beer or wine at retail on  
26 the brewery premises and at one additional off-site retail only  
27 location and nothing in this section shall prohibit a domestic winery  
28 from being licensed as a retailer pursuant to chapter 66.24 RCW for the  
29 purpose of selling beer or wine at retail on the winery premises. Such  
30 beer and wine so sold at retail shall be subject to the taxes imposed  
31 by RCW 66.24.290 and 66.24.210 and to reporting and bonding  
32 requirements as prescribed by regulations adopted by the board pursuant  
33 to chapter 34.05 RCW, and beer and wine that is not produced by the  
34 brewery or winery shall be purchased from a licensed beer or wine  
35 distributor.

36 (c) Nothing in this section shall prohibit a licensed distiller,  
37 domestic brewery, microbrewery, domestic winery, or a lessee of a  
38 licensed domestic brewer, microbrewery, or domestic winery, from being

1 licensed as a spirits, beer, and wine restaurant pursuant to chapter  
2 66.24 RCW for the purpose of selling liquor at a spirits, beer, and  
3 wine restaurant premises on the property on which the primary  
4 manufacturing facility of the licensed distiller, domestic brewer,  
5 microbrewery, or domestic winery is located or on contiguous property  
6 owned or leased by the licensed distiller, domestic brewer,  
7 microbrewery, or domestic winery as prescribed by rules adopted by the  
8 board pursuant to chapter 34.05 RCW. This section does not prohibit a  
9 brewery or microbrewery holding a spirits, beer, and wine restaurant  
10 license or a beer and/or wine license under chapter 66.24 RCW operated  
11 on the premises of the brewery or microbrewery from holding a second  
12 retail only license at a location separate from the premises of the  
13 brewery or microbrewery.

14 (d) Nothing in this section prohibits retail licensees with a  
15 caterer's endorsement issued under RCW 66.24.320 or 66.24.420 from  
16 operating on a domestic winery premises.

17 (e) Nothing in this section prohibits an organization qualifying  
18 under RCW 66.24.375 formed for the purpose of constructing and  
19 operating a facility to promote Washington wines from holding retail  
20 licenses on the facility property or leasing all or any portion of such  
21 facility property to a retail licensee on the facility property if the  
22 members of the board of directors or officers of the board for the  
23 organization include officers, directors, owners, or employees of a  
24 licensed domestic winery. Financing for the construction of the  
25 facility must include both public and private money.

26 (f) Nothing in this section prohibits a bona fide charitable  
27 nonprofit society or association registered (~~as a~~) under section  
28 501(c)(3) (~~under~~) of the internal revenue code, or a local wine  
29 industry association registered under section 501(c)(6) of the internal  
30 revenue code as it exists on the effective date of this section, and  
31 having an officer, director, owner, or employee of a licensed domestic  
32 winery or a wine certificate of approval holder on its board of  
33 directors from holding a special occasion license under RCW 66.24.380.

34 (g) Nothing in this section prohibits domestic wineries and  
35 retailers licensed under chapter 66.24 RCW from jointly producing  
36 brochures and materials promoting tourism in Washington state which  
37 contain information regarding retail licensees, domestic wineries, and  
38 their products.

1 (h) Nothing in this section prohibits domestic wineries and retail  
2 licensees from identifying the wineries on private labels authorized  
3 under RCW 66.24.400, 66.24.425, and 66.24.450.

4 (i) Until July 1, 2007, nothing in this section prohibits a  
5 nonprofit statewide organization of microbreweries formed for the  
6 purpose of promoting Washington's craft beer industry as a trade  
7 association registered as a 501(c) with the internal revenue service  
8 from holding a special occasion license to conduct up to six beer  
9 festivals.

10 (2) Financial interest, direct or indirect, as used in this  
11 section, shall include any interest, whether by stock ownership,  
12 mortgage, lien, or through interlocking directors, or otherwise.  
13 Pursuant to rules promulgated by the board in accordance with chapter  
14 34.05 RCW manufacturers, distributors, and importers may perform, and  
15 retailers may accept the service of building, rotating and restocking  
16 case displays and stock room inventories; rotating and rearranging can  
17 and bottle displays of their own products; provide point of sale  
18 material and brand signs; price case goods of their own brands; and  
19 perform such similar normal business services as the board may by  
20 regulation prescribe.

21 (3)(a) This section does not prohibit a manufacturer, importer, or  
22 distributor from providing services to a special occasion licensee for:  
23 (i) Installation of draft beer dispensing equipment or advertising,  
24 (ii) advertising, pouring, or dispensing of beer or wine at a beer or  
25 wine tasting exhibition or judging event, or (iii) a special occasion  
26 licensee from receiving any such services as may be provided by a  
27 manufacturer, importer, or distributor. Nothing in this section shall  
28 prohibit a retail licensee, or any person financially interested,  
29 directly or indirectly, in such a retail licensee from having a  
30 financial interest, direct or indirect, in a business which provides,  
31 for a compensation commensurate in value to the services provided,  
32 bottling, canning or other services to a manufacturer, so long as the  
33 retail licensee or person interested therein has no direct financial  
34 interest in or control of said manufacturer.

35 (b) A person holding contractual rights to payment from selling a  
36 liquor distributor's business and transferring the license shall not be  
37 deemed to have a financial interest under this section if the person  
38 (i) lacks any ownership in or control of the distributor, (ii) is not

1 employed by the distributor, and (iii) does not influence or attempt to  
2 influence liquor purchases by retail liquor licensees from the  
3 distributor.

4 (c) The board shall adopt such rules as are deemed necessary to  
5 carry out the purposes and provisions of subsection (3)(a) of this  
6 section in accordance with the administrative procedure act, chapter  
7 34.05 RCW.

8 (4) A license issued under RCW 66.24.395 does not constitute a  
9 retail license for the purposes of this section.

10 (5) A public house license issued under RCW 66.24.580 does not  
11 violate the provisions of this section as to a retailer having an  
12 interest directly or indirectly in a liquor-licensed manufacturer.

13 **Sec. 3.** RCW 66.08.150 and 2003 c 320 s 1 are each amended to read  
14 as follows:

15 The action, order, or decision of the board as to any denial of an  
16 application for the reissuance of a permit or license or as to any  
17 revocation, suspension, or modification of any permit or license shall  
18 be an adjudicative proceeding and subject to the applicable provisions  
19 of chapter 34.05 RCW.

20 (1) An opportunity for a hearing may be provided an applicant for  
21 the reissuance of a permit or license prior to the disposition of the  
22 application, and if no such opportunity for a prior hearing is provided  
23 then an opportunity for a hearing to reconsider the application must be  
24 provided the applicant.

25 (2) An opportunity for a hearing must be provided a permittee or  
26 licensee prior to a revocation or modification of any permit or license  
27 and, except as provided in subsection (4) of this section, prior to the  
28 suspension of any permit or license.

29 (3) No hearing shall be required until demanded by the applicant,  
30 permittee, or licensee.

31 (4) The board may summarily suspend a license or permit for a  
32 period of up to one hundred eighty days without a prior hearing if it  
33 finds that public health, safety, or welfare imperatively require  
34 emergency action, and it incorporates a finding to that effect in its  
35 order(~~(; and)~~). Proceedings for revocation or other action must be  
36 promptly instituted and determined. An administrative law judge may  
37 extend the summary suspension period for up to one calendar year in the

1 event the proceedings for revocation or other action cannot be  
2 completed during the initial one hundred eighty day period due to  
3 actions by the licensee or permittee. The board's enforcement division  
4 shall complete a preliminary staff investigation of the violation  
5 before requesting an emergency suspension by the board.

6 **Sec. 4.** RCW 66.24.244 and 2006 c 302 s 3 and 2006 c 44 s 2 are  
7 each reenacted and amended to read as follows:

8 (1) There shall be a license for microbreweries; fee to be one  
9 hundred dollars for production of less than sixty thousand barrels of  
10 malt liquor, including strong beer, per year.

11 (2) Any microbrewery license under this section may also act as a  
12 distributor and/or retailer for beer and strong beer of its own  
13 production. Any microbrewery licensed under this section may act as a  
14 distributor for beer of its own production. Strong beer may not be  
15 sold at a farmers market or under any endorsement which may authorize  
16 microbreweries to sell beer at farmers markets. Any microbrewery  
17 operating as a distributor and/or retailer under this subsection shall  
18 comply with the applicable laws and rules relating to distributors  
19 and/or retailers. A microbrewery holding a spirits, beer, and wine  
20 restaurant license may sell beer of its own production for off-premises  
21 consumption from its restaurant premises in kegs or in a sanitary  
22 container brought to the premises by the purchaser or furnished by the  
23 licensee and filled at the tap by the licensee at the time of sale.

24 (3) The board may issue a license allowing a microbrewery to  
25 operate a spirits, beer, and wine restaurant under RCW 66.24.420.

26 (4) The board may issue ~~((an endorsement to this))~~ a license  
27 allowing for on-premises consumption of beer, including strong beer,  
28 wine, or both of other manufacture if purchased from a Washington  
29 state-licensed distributor. ~~((Each endorsement shall cost two hundred~~  
30 ~~dollars per year, or four hundred dollars per year allowing the sale~~  
31 ~~and service of both beer and wine.~~

32 ~~(4))~~ The microbrewer ~~((obtaining such endorsement))~~ must  
33 determine, at the time the ~~((endorsement))~~ license is issued, whether  
34 the licensed premises will be operated ~~((either))~~ as a tavern with  
35 persons under twenty-one years of age not allowed as provided for in  
36 RCW 66.24.330, or as a beer and/or wine restaurant as described in RCW  
37 66.24.320.



1       (5) If the microbrewery licensee holds a separate license for a  
2 spirits, beer, and wine restaurant or a beer and/or wine restaurant,  
3 operated on the brewery premises, the licensee may hold a second retail  
4 license for a spirits, beer, and wine restaurant or a beer and/or wine  
5 restaurant, at a location separate from the licensed brewery premises.

6       (6)(a) A microbrewery licensed under this section may apply to the  
7 board for an endorsement to sell bottled beer of its own production at  
8 retail for off-premises consumption at a qualifying farmers market.  
9 The annual fee for this endorsement is seventy-five dollars.

10       (b) For each month during which a microbrewery will sell beer at a  
11 qualifying farmers market, the microbrewery must provide the board or  
12 its designee a list of the dates, times, and locations at which bottled  
13 beer may be offered for sale. This list must be received by the board

29 that he or she has personally prepared on land he or she owns or leases  
30 in this state or in another state's county that borders this state.

31 (iv) "Reseller" means a natural person who buys agricultural  
32 products from a farmer and resells the products directly to the  
33 consumer.

34 **Sec. 5.** RCW 66.24.244 and 2006 c 44 s 2 are each amended to read  
35 as follows:

36 (1) There shall be a license for microbreweries; fee to be one

1 hundred dollars for production of less than sixty thousand barrels of  
2 malt liquor, including strong beer, per year.

3 (2) Any microbrewery license under this section may also act as a  
4 distributor and/or retailer for beer and strong beer of its own  
5 production. Strong beer may not be sold at a farmers market or under  
6 any endorsement which may authorize microbreweries to sell beer at  
7 farmers markets. Any microbrewery operating as a distributor and/or  
8 retailer under this subsection shall comply with the applicable laws  
9 and rules relating to distributors and/or retailers. A microbrewery  
10 holding a spirits, beer, and wine restaurant license may sell beer of  
11 its own production for off-premises consumption from its restaurant  
12 premises in kegs or in a sanitary container brought to the premises by

22 brewery license, only the privileges of storing, selling to licensed  
23 beer distributors, and exporting beer from the state.

24 (7) "Board" means the liquor control board, constituted under this  
25 title.

26 (8) "Club" means an organization of persons, incorporated or  
27 unincorporated, operated solely for fraternal, benevolent, educational,  
28 athletic or social purposes, and not for pecuniary gain.

29 (9) "Consume" includes the putting of liquor to any use, whether by  
30 drinking or otherwise.

31 (10) "Contract liquor store" means a business that sells liquor on  
32 behalf of the board through a contract with a contract liquor store  
33 manager.

34 (11) "Dentist" means a practitioner of dentistry duly and regularly  
35 licensed and engaged in the practice of his profession within the state  
36 pursuant to chapter 18.32 RCW.

37 (12) "Distiller" means a person engaged in the business of  
38 distilling spirits.

1 (13) "Domestic brewery" means a place where beer and malt liquor  
2 are manufactured or produced by a brewer within the state.

3 (14) "Domestic winery" means a place where wines are manufactured  
4 or produced within the state of Washington.

5 (15) "Druggist" means any person who holds a valid certificate and  
6 is a registered pharmacist and is duly and regularly engaged in  
7 carrying on the business of pharmaceutical chemistry pursuant to  
8 chapter 18.64 RCW.

9 (16) "Drug store" means a place whose principal business is, the  
10 sale of drugs, medicines and pharmaceutical preparations and maintains  
11 a regular prescription department and employs a registered pharmacist  
12 during all hours the drug store is open.

13 (17) "Employee" means any person employed by the board.

14 (18) "Flavored malt beverage" means:

15 (a) A malt beverage containing six percent or less alcohol by  
16 volume to which flavoring or other added nonbeverage ingredients are  
17 added that contain distilled spirits of not more than forty-nine  
18 percent of the beverage's overall alcohol content; or

19 (b) A malt beverage containing more than six percent alcohol by  
20 volume to which flavoring or other added nonbeverage ingredients are  
21 added that contain distilled spirits of not more than one and one-half  
22 percent of the beverage's overall alcohol content.

23 (19) "Fund" means 'liquor revolving fund.'

24 (20) "Hotel" means (~~every building or other structure~~) buildings,  
25 structures, and grounds, having facilities for preparing, cooking, and  
26 serving food, that are kept, used, maintained, advertised, or held out  
27 to the public to be a place where food is served and sleeping  
28 accommodations are offered for pay to transient guests, in which twenty  
29 or more rooms are used for the sleeping accommodation of such transient  
30 guests (~~and having one or more dining rooms where meals are served to~~  
31 ~~such transient guests, such sleeping accommodations and dining rooms~~  
32 ~~being conducted in the same building and buildings, in connection~~  
33 ~~therewith, and such structure or structures being provided, in the~~  
34 ~~judgment of the board, with adequate and sanitary kitchen and dining~~  
35 ~~room equipment and capacity, for preparing, cooking and serving~~  
36 ~~suitable food for its guests: PROVIDED FURTHER, That in cities and~~

2 The buildings, structures, and grounds must be located on adjacent  
3 property either owned or leased by the same person or persons.

4 (21) "Importer" means a person who buys distilled spirits from a  
5 distillery outside the state of Washington and imports such spirituous  
6 liquor into the state for sale to the board or for export.

7 (22) "Imprisonment" means confinement in the county jail.

8 (23) "Liquor" includes the four varieties of liquor herein defined  
9 (alcohol, spirits, wine and beer), and all fermented, spirituous,  
10 vinous, or malt liquor, or combinations thereof, and mixed liquor, a  
11 part of which is fermented, spirituous, vinous or malt liquor, or  
12 otherwise intoxicating; and every liquid or solid or semisolid or other  
13 substance, patented or not, containing alcohol, spirits, wine or beer,  
14 and all drinks or drinkable liquids and all preparations or mixtures  
15 capable of human consumption, and any liquid, semisolid, solid, or  
16 other substance, which contains more than one percent of alcohol by  
17 weight shall be conclusively deemed to be intoxicating. Liquor does  
18 not include confections or food products that contain one percent or  
19 less of alcohol by weight.

20 (24) "Manufacturer" means a person engaged in the preparation of  
21 liquor for sale, in any form whatsoever.

22 (25) "Malt beverage" or "malt liquor" means any beverage such as  
23 beer, ale, lager beer, stout, and porter obtained by the alcoholic  
24 fermentation of an infusion or decoction of pure hops, or pure extract  
25 of hops and pure barley malt or other wholesome grain or cereal in pure  
26 water containing not more than eight percent of alcohol by weight, and  
27 not less than one-half of one percent of alcohol by volume. For the  
28 purposes of this title, any such beverage containing more than eight  
29 percent of alcohol by weight shall be referred to as "strong beer."

30 (26) "Package" means any container or receptacle used for holding  
31 liquor.

32 (27) "Passenger vessel" means any boat, ship, vessel, barge, or  
33 other floating craft of any kind carrying passengers for compensation.

34 (28) "Permit" means a permit for the purchase of liquor under this  
35 title.

36 (29) "Person" means an individual, copartnership, association, or  
37 corporation.

1 (30) "Physician" means a medical practitioner duly and regularly  
2 licensed and engaged in the practice of his profession within the state  
3 pursuant to chapter 18.71 RCW.

4 (31) "Prescription" means a memorandum signed by a physician and  
5 given by him to a patient for the obtaining of liquor pursuant to this  
6 title for medicinal purposes.

7 (32) "Public place" includes streets and alleys of incorporated  
8 cities and towns; state or county or township highways or roads;  
9 buildings and grounds used for school purposes; public dance halls and  
10 grounds adjacent thereto; those parts of establishments where beer may  
11 be sold under this title, soft drink establishments, public buildings,  
12 public meeting halls, lobbies, halls and dining rooms of hotels,  
13 restaurants, theatres, stores, garages and filling stations which are  
14 open to and are generally used by the public and to which the public is  
15 permitted to have unrestricted access; railroad trains, stages, and  
16 other public conveyances of all kinds and character, and the depots and  
17 waiting rooms used in conjunction therewith which are open to  
18 unrestricted use and access by the public; publicly owned bathing

27 drug stores and soda fountains.

28 (35) "Sale" and "sell" include exchange, barter, and traffic; and  
29 also include the selling or supplying or distributing, by any means  
30 whatsoever, of liquor, or of any liquid known or described as beer or  
31 by any name whatever commonly used to describe malt or brewed liquor or  
32 of wine, by any person to any person; and also include a sale or  
33 selling within the state to a foreign consignee or his agent in the

7 by distillation, except flavored malt beverages, but including wines  
8 exceeding twenty-four percent of alcohol by volume.

9 (38) "Store" means a state liquor store established under this  
10 title.

11 (39) "Tavern" means any establishment with special space and  
12 accommodation for sale by the glass and for consumption on the  
13 premises, of beer, as herein defined.

14 (40) "Winery" means a business conducted by any person for the  
15 manufacture of wine for sale, other than a domestic winery.

16 (41)(a) "Wine" means any alcoholic beverage obtained by  
17 fermentation of fruits (grapes, berries, apples, et cetera) or other  
18 agricultural product containing sugar, to which any saccharine  
19 substances may have been added before, during or after fermentation,  
20 and containing not more than twenty-four percent of alcohol by volume,  
21 including sweet wines fortified with wine spirits, such as port,  
22 sherry, muscatel and angelica, not exceeding twenty-four percent of  
23 alcohol by volume and not less than one-half of one percent of alcohol  
24 by volume. For purposes of this title, any beverage containing no more  
25 than fourteen percent of alcohol by volume when bottled or packaged by

4 (43) "Wine importer" means a person or business within Washington

24 hotel for consumption in guest rooms. The licensee shall require proof

27 one under twenty-one years of age shall have access to the spirits,  
28 beer, and wine in the honor bar;

29 (c) Provide without additional charge, to overnight guests,  
30 spirits, beer, and wine by the individual serving for on-premises  
31 consumption at a specified regular date, time, and place as may be  
32 fixed by the board. Self-service by attendees is prohibited;

33 (d) Sell beer, including strong beer, wine, or spirits, in the  
34 manufacturer's sealed container or by the individual drink to guests  
35 through room service, or through service to occupants of private  
36 residential units;

1 (e) Sell beer, including strong beer, or wine, in the  
2 manufacturer's sealed container at retail sales locations within the  
3 hotel premises;

4 (f) Sell for on or off-premises consumption, including through room  
5 service and service to occupants of private residential units managed  
6 by the hotel, wine carrying a label exclusive to the hotel license  
7 holder;

8 (g) Place in guest rooms at check-in, a complimentary bottle of  
9 beer, including strong beer, or wine in a manufacturer-sealed  
10 container, and make a reference to this service in promotional  
11 material.

12 (3) If all or any facilities for alcoholic beverage service and the  
13 preparation, cooking, and serving of food are operated under contract  
14 or joint venture agreement, the operator may hold a license separate  
15 from the license held by the operator of the hotel. Food and beverage  
16 inventory used in separate licensed operations at the hotel may not be  
17 shared and shall be separately owned and stored by the separate  
18 licensees.

19 (4) All spirits to be sold under this license must be purchased  
20 from the board.

21 (5) All on-premise alcoholic beverage service must be done by an  
22 alcohol server as defined in RCW 66.20.300 and must comply with RCW  
23 66.20.310.

24 (6)(a) The hotel license allows the licensee to remove from the  
25 liquor stocks at the licensed premises, liquor for sale and service at  
26 event locations at a specified date and place not currently licensed by  
27 the board. If the event is open to the public, it must be sponsored by  
28 a society or organization as defined by RCW 66.24.375. If attendance  
29 at the event is limited to members or invited guests of the sponsoring  
30 individual, society, or organization, the requirement that the sponsor  
31 must be a society or organization as defined by RCW 66.24.375 is  
32 waived.

33 (b) The holder of this license shall, if requested by the board,  
34 notify the board or its designee of the date, time, place, and location  
35 of any event. Upon request, the licensee shall provide to the board  
36 all necessary or requested information concerning the society or  
37 organization that will be holding the function at which the endorsed  
38 license will be utilized.

1 (c) Licensees may cater events on a domestic winery premises.

2 (7) The holder of this license or its manager may furnish spirits,  
3 beer, or wine to the licensee's employees who are twenty-one years of  
4 age or older free of charge as may be required for use in connection  
5 with instruction on spirits, beer, and wine. The instruction may  
6 include the history, nature, values, and characteristics of spirits,  
7 beer, or wine, the use of wine lists, and the methods of presenting,  
8 serving, storing, and handling spirits, beer, or wine. The licensee  
9 must use the beer or wine it obtains under its license for the sampling  
10 as part of the instruction. The instruction must be given on the  
11 premises of the licensee.

12 (8) Minors may be allowed in all areas of the hotel where alcohol  
13 may be consumed; however, the consumption must be incidental to the  
14 primary use of the area. These areas include, but are not limited to,  
15 tennis courts, hotel lobbies, and swimming pool areas. If an area is  
16 not a mixed use area, and is primarily used for alcohol service, the  
17 area must be designated and restricted to access by minors.

18 (9) The annual fee for this license is two thousand dollars.

19 (10) As used in this section, "hotel," "spirits," "beer," and  
20 "wine" have the meanings defined in RCW 66.24.410 and 66.04.010.

21 **Sec. 12.** RCW 66.44.310 and 1998 c 126 s 14 are each amended to  
22 read as follows:

23 (1) Except as otherwise provided by RCW 66.44.316 (~~and~~),  
24 66.44.350, and section 11 of this act, it shall be a misdemeanor:

25 (a) To serve or allow to remain in any area classified by the board  
26 as off-limits to any person under the age of twenty-one years;

27 (b) For any person under the age of twenty-one years to enter or
