

HB 3162 - DIGEST

Creates the state bank of Washington with the intent that all state funds and funds of state institutions will be deposited at the state bank and will be guaranteed by the state.

Takes effect upon approval of the voters of the proposed amendments to Articles VIII and XII of the state Constitution which allows the state legislature to create a state bank that may make decisions to lend, borrow, and invest state moneys.
