- 1 AN ACT Relating to delegation of inspection duties for factory
- 2 built housing and commercial structures; and amending RCW 43.22.470
- 3 and 43.22.450.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 43.22.470 and 1970 ex.s. c 44 s 5 are each amended to read as follows:
- 7 The department shall have the authority to delegate all or part 8 of its duties of inspection to a local enforcement agency or a
- 9 qualified inspection agency.
- 10 Qualified inspection agencies shall be objective, competent, and
- 11 <u>independent from the companies responsible for the work being</u>
- 12 inspected. The qualified inspection agency will disclose to the
- 13 <u>department any conflict of interest so that objectivity may be</u>
- 14 confirmed. Qualified inspection agencies shall have adequate
- 15 equipment to perform the required inspections and shall employ
- 16 <u>experienced personnel with appropriate certifications and knowledge</u>
- 17 for the inspections being performed. Certification by the
- 18 international code council will be recognized as meeting this last
- 19 <u>requirement</u>.

- (1) "Department" means the Washington state department of labor and industries;
 - (2) "Approved" means approved by the department;
- (3) "Factory built housing" means any structure designed primarily for human occupancy other than a manufactured or mobile home the structure or any room of which is either entirely or substantially prefabricated or assembled at a place other than a building site;
- 12 (4) "Install" means the assembly of factory built housing or 13 factory built commercial structures at a building site;
 - (5) "Building site" means any tract, parcel or subdivision of land upon which factory built housing or a factory built commercial structure is installed or is to be installed;
 - (6) "Local enforcement agency" means any agency of the governing body of any city $((\Theta r))_L$ county, or state which enforces laws or ordinances governing the construction of buildings;
 - (7) "Commercial structure" means a structure designed or used for human habitation, or human occupancy for industrial, educational, assembly, professional or commercial purposes;
- 23 (8) "Qualified inspection agency" means a nongovernmental entity
 24 approved to perform inspections under contract for the department.
