1 AN ACT Relating to peace officer certification; and amending RCW
2 43.101.095.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 43.101.095 and 2018 c 32 s 5 are each amended to
5 read as follows:

6 (1) As a condition of continuing employment as peace officers,
7 all Washington peace officers: (a) Shall timely obtain certification
8 as peace officers, or timely obtain certification or exemption
9 therefrom, by meeting all requirements of RCW 43.101.200, as that
10 section is administered under the rules of the commission, as well by
11 meeting any additional requirements under this chapter; and (b) shall
12 maintain the basic certification as peace officers under this
13 chapter.

14 (2)(a) As a condition of continuing employment for any applicant
15 who has been offered a conditional offer of employment as a fully
16 commissioned peace officer or a reserve officer after July 24, 2005,
17 including any person whose certification has lapsed as a result of a
18 break of more than twenty-four consecutive months in the officer's
19 service as a fully commissioned peace officer or reserve officer, the
20 applicant shall submit to a background investigation including a
21 check of criminal history, verification of immigrant or citizenship

1 status as either a citizen of the United States of America or a
2 lawful permanent resident, and a psychological examination, (~~and a~~
3 ~~polygraph or similar assessment as administered by the county, city,~~
4 ~~or state law enforcement agency,~~) the results of which shall be used
5 to determine the applicant's suitability for employment as a fully
6 commissioned peace officer or a reserve officer.

7 (i) The background investigation including a check of criminal
8 history shall be administered by the county, city, or state law
9 enforcement agency that made the conditional offer of employment in
10 compliance with standards established in the rules of the commission.

11 (ii) The psychological examination shall be administered by a
12 psychiatrist licensed in the state of Washington pursuant to chapter
13 18.71 RCW or a psychologist licensed in the state of Washington
14 pursuant to chapter 18.83 RCW, in compliance with standards
15 established in rules of the commission.

16 (iii) (~~The polygraph test shall be administered by an~~
17 ~~experienced polygrapher who is a graduate of a polygraph school~~
18 ~~accredited by the American polygraph association and in compliance~~
19 ~~with standards established in rules of the commission.~~

20 ~~(iv))~~ Any other test or assessment to be administered as part of
21 the background investigation shall be administered in compliance with
22 standards established in rules of the commission.

23 (b) The employing county, city, or state law enforcement agency
24 may require that each peace officer or reserve officer who is
25 required to take a psychological examination (~~and a polygraph or~~
26 ~~similar test~~) pay a portion of the testing fee based on the actual
27 cost of the test or four hundred dollars, whichever is less. County,
28 city, and state law enforcement agencies may establish a payment plan
29 if they determine that the peace officer or reserve officer does not
30 readily have the means to pay for his or her portion of the testing
31 fee.

32 (3) The commission shall certify peace officers who have
33 satisfied, or have been exempted by statute or by rule from, the
34 basic training requirements of RCW 43.101.200 on or before January 1,
35 2002. Thereafter, the commission may revoke certification pursuant to
36 this chapter.

37 (4) The commission shall allow a peace officer to retain status
38 as a certified peace officer as long as the officer: (a) Timely meets
39 the basic law enforcement training requirements, or is exempted
40 therefrom, in whole or in part, under RCW 43.101.200 or under rule of

1 the commission; (b) meets or is exempted from any other requirements
2 under this chapter as administered under the rules adopted by the
3 commission; (c) is not denied certification by the commission under
4 this chapter; and (d) has not had certification revoked by the
5 commission.

6 (5) As a prerequisite to certification, as well as a prerequisite
7 to pursuit of a hearing under RCW 43.101.155, a peace officer must,
8 on a form devised or adopted by the commission, authorize the release
9 to the commission of his or her personnel files, termination papers,
10 criminal investigation files, or other files, papers, or information
11 that are directly related to a certification matter or
12 decertification matter before the commission.

13 (6) The commission is authorized to receive criminal history
14 record information that includes nonconviction data for any purpose
15 associated with employment by the commission or peace officer
16 certification under this chapter. Dissemination or use of
17 nonconviction data for purposes other than that authorized in this
18 section is prohibited.

19 (7) For a national criminal history records check, the commission
20 shall require fingerprints be submitted and searched through the
21 Washington state patrol identification and criminal history section.
22 The Washington state patrol shall forward the fingerprints to the
23 federal bureau of investigation.
