WASHINGTON ATTORNEY GENERAL

The Washington attorney general issues formal published opinions in response to requests by the heads of state agencies, state legislators, and county prosecuting attorneys. When it appears that individuals outside the attorney general's office have information or expertise that will assist in the preparation of a particular opinion, a summary of that opinion request will be published in the state register. If you are interested in commenting on a request listed in this volume of the register, you should notify the attorney general's office of your interest by May 28, 2008. This is not the due date by which comments must be received. However, if you do not notify the attorney general's office of your interest in commenting on an opinion request by this date, the opinion may be issued before your comments have been received. You may notify the attorney general's office of your intention to comment by calling (360) 664-3027, or by writing to the Office of the Attorney General, Solicitor General Division, Attention James Pharris, Deputy Solicitor General, P.O. Box 40100, Olympia, WA 98504-0100. When you notify the office of your intention to comment, you may be provided with a copy of the opinion request in which you are interested; information about the attorney general's opinion process; information on how to submit your comments; and a due date by which your comments must be received to ensure that they are fully considered. 1. RCW 36.12.010, .020, and case law thereunder, appear to indicate that it is the responsibility of the Board of County Commissioners to determine if the petitions contain the requisite number of valid signatures. Can that Board request that the County Auditor, who ordinarily makes this type of determination under other circumstances and who is trained and equipped to do so, make this determination on behalf of the Board?

2. Is the person submitting the petitions entitled to observe the canvassing of the signatures?

3. Is there any limit to how old a signature reflected on a petition may be and still be valid?

4. After petitions have been submitted under RCW 36.12.010, can signatures be withdrawn or additional petitions/signatures be submitted prior to the completion of the canvassing of the signatures?

5. If petitions are submitted immediately prior to a general election (e.g., prior to the November 2008 general election) and the signatures cannot be canvassed prior to such general election, is it the number of votes cast in the last general election before the petitions are filed (e.g. the November 2006 general election) or the last general election before the signatures are canvassed (e.g., the November 2008 general election) that should be used to determine the number of signatures required under RCW 36.12.020?

6. If it is determined that an insufficient number of valid signatures have been submitted, must the county retain the original petitions or return them to the person that submitted them?

7. If it is determined that a sufficient number of valid signatures have been submitted and an election is held, does RCW 36.12.050 require that the Board of County Commissioners canvass the election or can it request that the Canvassing Board, comprised of the persons set forth under RCW 29A.60.140, canvass the election? For reference, you may want to refer to State v. Whitney, 12 Wash. 420, 41 P. 189 (1895).

**Announcing the Draft Washington State
Department of Transportation Municipal Stormwater
General Permit**

The Draft Washington State Department of Transportation Municipal Stormwater General Permit: The department of ecology (ecology) proposes to issue a general permit to the Washington state department of transportation (WSDOT) to cover discharges from its municipal separate storm sewer system (MS4). MS4s are conveyances or a system of conveyances including roads with drainage systems, streets, catch basins, ditches, man-made channels, and storm drains. Upon issuance, this permit will replace WSDOT's existing coverage under the Phase I Municipal general permits (WASM10001, WASM20001, and WASM30001) for the activities that WSDOT uses to manage stormwater runoff to surface waters of the state. The revocation and replacement is effective beginning on the effective date of this permit.

State and federal regulations require WSDOT to have national pollutant discharge elimination system (NPDES) permit coverage in areas covered by Phase I and Phase II of the municipal stormwater permit program. Seeking coverage under a statewide permit is consistent with WSDOT's objective of implementing a highway stormwater management program that promotes sound stormwater management on all state highways. This general permit will cover stormwater runoff from state highways, rest areas, weigh stations, park and ride lots, ferry terminals, and maintenance facilities. The proposed permit addresses these legal requirements and regulates the discharge of pollutants to protect surface water quality in Washington state. Ecology is requesting public comment on the draft permit and fact sheet. Concurrently, an interagency agreement (IA) regarding the statewide application of the 2008 updated Highway Runoff Manual (HRM) and WSDOT's stormwater management program will also be available on ecology's web site for review and comment.

If you submit written comments, you must ensure that they are postmarked no later than **5 p.m., June 24, 2008**. You must send e-mail comments before **5 p.m., June 24, 2008**. You may provide oral comments by testifying at the public hearing in Lacey.

Issuing the WSDOT Municipal Stormwater General Permit: After ecology receives and considers all public comments it will make necessary changes and issue the permit. If public comments cause a substantial change in the permit conditions from the original draft permit, another public notice of draft and comment period may ensue.

Ecology expects to issue the permit on or about July 31, 2008, if there is no substantial change to the draft. The permit will be effective thirty days later. When issued, ecology will send a copy of the notice of issuance and ecology's responses to the comments to all persons who submitted written comment or gave public testimony.
