Notice of Metropolitan Park Commission Dollar Threshold
Adjustment

Compensation limits for metropolitan park commissioners are set in statute. RCW 35.61.150 provides that payment of compensation for each commissioner may be at a rate up to ninety dollars (\$90) per day, with compensation for each commissioner not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 35.61.150 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). The new dollar threshold takes effect July 5, 2008.

This new threshold was calculated as follows. Over the five-year period from April 2003 to April 2008, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bremerton, Washington area as reported by the Bureau of Labor Statistics, United States Department of Labor, increased by 16.1%. Increasing the daily rate of compensation of ninety dollars (\$90) per day and the annual compensation limit of eight thousand six hundred and forty dollars (\$8,640) [(\$8,640)] in RCW 35.61.150 by the rate of increase for the consumer price index results in an updated threshold of one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984).

Notice of Fire District Board
Member Dollar Threshold Adjustment

Compensation limits for fire district board members are set in statute. RCW 52.14.010 provides that payment of compensation for each board member shall be at a rate of ninety dollars (\$90) per day, with compensation for each board member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 52.14.010 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington

state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). The new dollar threshold takes effect July 5, 2008.

This new threshold was calculated as follows. Over the five-year period from April 2003 to April 2008, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bremerton, Washington area as reported by the Bureau of Labor Statistics, United States Department of Labor, increased by 16.1%. Notice of Port District Commission
Dollar Threshold Adjustment

Compensation limits for port district commissioners are set in statute. RCW 53.12.260 provides that payment of compensation for each commissioner may be at a rate of ninety dollars (\$90) per day, with compensation for each commissioner not to exceed eight thousand six hundred and forty dollars (\$8,640) per year ten thousand eight hundred dollars (\$10,800) per year for districts with a gross operating income of twenty-five million or more in the preceding calendar year. RCW 53.12.260 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984) and twelve thousand five hundred and thirty-five dollars (\$12,535) per year with a gross operating income of twenty-five million or more in the preceding calendar year. The new dollar threshold takes effect July 5, 2008.

This new threshold was calculated as follows. Over the five-year period from April 2003 to April 2008, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bremerton, Washington area as reported by the Bureau of Labor Statistics, United States Department of Labor, increased by 16.1%. Increasing the daily rate of compensation of ninety dollars (\$90) per day

Notice of Public Utility District
Commission Dollar Threshold Adjustment

Compensation limits for public utility district commissioners are set in statute. RCW 54.12.080 provides that payment of compensation for each commissioner may be at a rate not exceeding ninety dollars (\$90) per day, with compensation for each commissioner not to exceed twelve thousand six hundred dollars (\$12,600) per year. RCW 54.12.080 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is one hundred and four dollars (\$104) per day with a new annual compensation limit of fourteen thousand five hundred and sixty-four dollars (\$14,560) [(\$14,564)]. The new dollar threshold takes effect July 5, 2008.

Notice of Water-Sewer District Board
Member Dollar Threshold Adjustment

Compensation limits for water-sewer district board members are set in statute. RCW 57.12.010 provides that payment of compensation for each board member shall be at a rate of ninety dollars (\$90) per day, with compensation for each board member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 57.12.010 also pro-

vides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. RCW 68.52.220 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. RCW 70.44.050 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

RCW 85.05.410 also provides for the office of financial management to adjust this

dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

RCW 85.06.380 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

RCW 85.08.320 provides that payment of compensation for each member may be at a rate up to ninety dollars (\$90) per day, with compensation for each member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 85.08.320 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. RCW 85.24.080 provides that payment of compensation for each member may be at a rate up to ninety dollars (\$90) per day, with compensation for each member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year.

RCW 85.24.080 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is up to one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). RCW 86.09.283 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is up to one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). RCW 87.03.460 provides that payment of compensation for each director may be at a rate up to ninety dollars (\$90) per day, with compensation for each director not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 87.03.460 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is up to one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). RCW 36.75A.050 provides that payment of compensation for each member may be at a rate up to ninety dollars (\$90) per day, with compensation for each member not to exceed seventy-five days, except the chair who may be paid for not more than one hundred days per year, which equals eight thousand six hundred

and forty dollars (\$8,640) per year. RCW 35.75A.050 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). Compensation limits for special district governing body members are set in statute. RCW 85.38.075 provides that payment of compensation for each member may be at a rate up to ninety dollars (\$90) per day, with compensation for each member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 85.38.075 also provides for the office of financial management to adjust this dollar threshold for inflation every five years, beginning July 1, 2008. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, United States Department of Labor during that five-year period. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington state register at least one month before the new threshold takes effect.

In accordance with the requirements set forth above, the office of financial management submits for publication the new dollar threshold. The new dollar threshold is up to one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984). The new dollar threshold takes effect July 5, 2008.

This new threshold was calculated as follows. Over the five-year period from April 2003 to April 2008, the Con-

sumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bremerton, Washington area as reported by the Bureau of Labor Statistics, United States Department of Labor, increased by 16.1%. Increasing the daily rate of compensation of up to ninety dollars (\$90) per day and the annual compensation limit of eight thousand six hundred and forty dollars (\$8,604) [(\$8,640)] in RCW 85.38.075 by the rate of increase for the consumer price index results in an updated threshold of up to one hundred and four dollars (\$104) per day with a new annual compensation limit of nine thousand nine hundred and eighty-four dollars (\$9,984).

PROCLAMATION BY THE GOVERNOR

WHEREAS, higher than average temperatures caused the melting of above-normal snowpack levels in the mountains on May 16 through May 19, 2008, threatening citizens and property of Washington State, and resulting in rising water levels in rivers and streams on May 17, 2008, causing extensive damage to roadways in Spokane, Kittitas, King, Skagit, Chelan, and Okanogan Counties;

The estimated cost to correct the damage is \$1,000,000 and growing, requiring the approval of the Secretary of Washington's Department of Transportation to commence work to repair, remove and replace the affected roadways; emergency conditions may warrant closure of affected roadways and implementation of emergency procurement procedures;

The Washington State Department of Transportation is continuing to assess the magnitude of this event, and coordinating resources to repair, remove and replace the affected roadways to alleviate the immediate impacts upon the infrastructure;

The Washington State Military Department continues to monitor the situation through the State Emergency Operations Center in support of the Washington State Department of Transportation, in addition to implementing appropriate response procedures, coordinating resources to support local officials in alleviating the immediate social and economic impacts to people, property, and infrastructure, and assessing the magnitude of the event.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, as a result of the above-noted situation and under Chapters 38.52 and 43.06 RCW, do hereby proclaim that a State of Emergency exists in Spokane, Kittitas, King, Skagit, Chelan, and Okanogan Counties, and direct the plans and procedures of the *Washington State Comprehensive Emergency Management Plan* be implemented. State agencies and departments are directed to utilize state resources and do everything reasonably possible to assist the affected state agencies and political subdivisions in an effort to respond to and recover from the event. Additionally, the Washington State Military Department, Emergency Management Division is instructed to coordinate all event-related assistance to the affected areas.

Properly licensed pesticide applicators who have obtained coverage under the WSDA national pollutant discharge elimination system waste discharge general permit may apply glyphosate or imazapyr to control the noxious weed *Spartina* on the saltwater tideflats of Grays Harbor, Hood Canal, Willapa Bay, Puget Sound, and the north and west sides of the Olympic Peninsula.

Use of herbicides is one of the options used to control *Spartina*. These infestations may also be treated, but not eradicated, by mowing, digging, crushing, or covering.
