PUBLIC NOTICE FOR SPARTINA TREATMENT IN WESTERN WASHINGTON

LEGAL NOTICE: The Washington state department of agriculture (WSDA) plant protection division is hereby notifying the affected public that the herbicides glyphosate (e.g. Aquamaster®, Aquaneat®, or Rodeo®) and imazapyr (e.g. Habitat® or Polaris AQ®), surfactants (e.g. Agri-Dex™, Class Act Next Generation™, Competitor™, Dyne-Amic™, Kinetic™, or LI-700™) and marker dyes may be used to control invasive *Spartina* grass species between June 1, 2008, and October 31, 2008. Properly licensed pesticide applicators who have obtained coverage under the WSDA national pollutant discharge elimination system waste discharge general permit may apply glyphosate or imazapyr to control the noxious weed *Spartina* on the saltwater tidelands of Grays Harbor, Hood Canal, Willapa Bay, Puget Sound, and the north and west sides of the Olympic Peninsula.

Use of herbicides is one of the options used to control *Spartina*. These infestations may also be treated, but not eradicated, by mowing, digging, crushing, or covering.

ETA 2043.04.190

Occupational Medicine Services and the Preferential B&O Rate Under RCW 82.04.263

RCW 82.04.263 provides a preferential business and occupation (B&O) tax rate for persons engaged in the business of cleaning up radioactive waste and other byproducts of weapons production and nuclear research and development for the United States or its instrumentalities. For the purposes of the preferential rate, "cleaning up radioactive waste and other byproducts of weapons production and nuclear research and development" means the activities of handling, storing, treating, immobilizing, stabilizing, or disposing of radioactive waste, radioactive tank waste and capsules, non-radioactive hazardous solid and liquid wastes, or spent nuclear fuel; spent nuclear fuel conditioning; removal of contamination in soils and ground water; decontamination and decommissioning of facilities; and activities integral and necessary to the direct performance of cleanup.

This excise tax advisory (ETA) discusses how this preferential B&O tax rate applies to occupational medicine services.

AMENDING PROCLAMATION OF EMERGENCY 08-03

WHEREAS, higher than average temperatures caused the melting of above-normal snowpack levels in the mountains from May 16 through May 19, 2008, threatening citizens and property of Washington State, and resulting in rising water levels in rivers and streams on May 17, 2008, causing extensive damage to roadways in Ferry County.

Gregoire, Governor of the state of Washington, as a result of the above-noted situation and under Chapters 38.52 and 43.06 RCW, do hereby amend the emergency proclamation issued on May 21, 2008, to include and further proclaim that a State of Emergency exists in Ferry County.

PUBLIC NOTICE**The Industrial Stormwater General Permit is Reissued**

Reissuing the Industrial Stormwater General Permit: The Washington state department of ecology (ecology) reissued the expired industrial stormwater general permit, on October 15, 2008, without changes, with an effective date of November 15, 2008. The expiration date is April 30, 2009.

The draft industrial stormwater general permit and fact sheet were available for review and public comment from **August 6, 2008 until 5 p.m., Friday, September 12, 2008.** This proposal was the subject of a public workshop and hearing on September 11, 2008, at the department of ecology in

Lacey, Washington. Ecology received written comments during the public comment period and responded to these comments in the fact sheet. The comments and the fact sheet may be reviewed at ecology's web site at <http://www.ecy.wa.gov/programs/wq/stormwater/industrial/index.html>.

The industrial stormwater NPDES and state waste discharge general permit was issued by ecology on August 21, 2002, was reissued on August 15, 2007, and expired on May 31, 2008. Ecology has initiated a collaborative external advisory committee process to develop a simpler and more effective general permit. The committee will also address a broad range of related issues, including stormwater research and development, education and outreach, compliance inspections and enforcement. More information on the external advisory committee process is available at ecology's web site at <http://www.ecy.wa.gov/programs/wq/stormwater/industrial/index.html>.

Purpose of the Industrial Stormwater General Permit: The general permit provides coverage for industries located in Washington state that discharge stormwater associated with industrial activities. Under federal and state water quality law (Federal Clean Water Act and State Water Pollution Control Act) a permit is required for the discharge of wastewater. A discharge of stormwater associated with industrial activities is a discharge of wastewater.

Most industrial activities that discharge stormwater either directly or indirectly to surface water are required to obtain permit authorization for their discharge unless they apply for and receive a "No Exposure" certificate. Specifically, facilities listed in the Code of Federal Regulations (CFR) at 40 C.F.R. Subpart 122.26 (b)(14)(i)-(xi), excluding (x), stormwater discharges, are included for coverage under the modified permit. A more complete listing of facilities and applicable standard industrial codes (SIC) can be found in the draft permit in Appendix #1-Section C, categories 1-9 and 11.

Applying for Coverage under the Industrial Stormwater General Permit: Facilities covered under the existing industrial stormwater general permit will be automatically covered under the reissued permit. New or unpermitted facilities may obtain coverage under the reissued general permit by submitting a complete permit application to ecology and satisfying all applicable public notice and State Environmental Policy Act (SEPA) requirements (WAC 173-226-200). The application is available online at <http://www.ecy.wa.gov/biblio/ecy02084.html>.
