The department of revenue has issued the following excise tax advisory (ETA):

ETA 3133.2019 - Withdrawal of Published Determinations

This ETA announces the withdrawal of certain published determinations, or Washington tax decisions (WTD), that should no longer be followed. The following WTDs have been withdrawn:

- Det. 14-0219, 35 WTD 372 (2016), which incorrectly concluded that an in-kind payment of lost and unaccounted for gas is included in a Washington customer's brokered natural gas use tax base.
- Det. 91-309, 11 WTD 497 (1992), which concluded that the Employee Retirement Income Security Act (ERISA) preempted the B&O tax on any contributions to, distributions from, and investment income generated by ERISA qualified plans.

ETA 3216.2019 *The Real Estate Excise Tax Controlling Interest Transfer 36-Month Lookback Period*

This ETA addresses how real estate excise tax (REET) applies to transfers of controlling interests in real property-holding entities after changes resulting from 2019 legislation, ESSB 5998. This legislation extended the twelve-month period in RCW 82.45.010(2) for considering controlling interest transfers to thirty-six months.

Reissuance of the Industrial Stormwater General Permit

On November 20, 2019, the department of ecology (ecology) will reissue the industrial stormwater national pollutant discharge elimination system and state waste discharge general permit (permit). The permit becomes effective on January 1, 2020, and expires on December 31, 2024.

Purpose of the Permit: The permit addresses various legal requirements and responsibilities, and regulates the discharge of pollutants to protect water quality in Washington state. State and federal water quality statutes and regulations do not allow the discharge of pollutants to waters of the state without permit coverage. Stormwater may become contaminated by industrial activities as a result of contact with materials stored outside, spills and leaks from equipment or materials used onsite, contact with materials during loading, unloading or transfer from one location to another, and from airborne contaminants and therefore require a discharge permit. When the permitted activities conducted by a specific class of industries are similar, ecology issues a general permit to cover all of them rather than issuing a series of individual permits.

Public Notice Process and Comments: Ecology accepted public comments on the draft permit and fact sheet from May 1, 2019, through June 29, 2019. Ecology held public workshops and hearings during this time and via an online statewide webinar on June 19, 2019. Ecology received oral and written comments during the public comment period. The comments and ecology's responses are included in Appendix D of the fact sheet.

New or unpermitted facilities may obtain coverage under the permit by submitting a complete permit application to ecology and satisfying all applicable public notice and State Environmental Policy Act requirements (WAC 173-226-200).
