Currently, WAC 246-915-120 (1)(c)(iii) requires applicants to achieve minimum scores for each category of the ibTOEFL examination during the same sitting. The petitioner stated multiple sittings for the ibTOEFL would help reduce barriers for foreign educated applicants trying to earn a license in Washington while still providing evidence of proficiency. On October 5, 2020, the board decided to accept the petition and initiate rule making consistent with RCW 34.05.330 (1)(b).

Statutes Authorizing the Agency to Adopt Rules on this Subject: RCW 43.70.780 Fruit and vegetable incentives program.

Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: RCW 43.70.780 requires the department to adopt rules to implement a fruit and vegetable incentives program. The program includes farmers' market basic food incentives, grocery store basic food incentives, and fruit and vegetable vouchers. These incentives allow eligible participants to receive extra benefits or cash-value vouchers to purchase fruit and vegetables from farmers' markets and food retailers. The department will consider establishing criteria used to determine whether a grocer may become an approved grocery store for the purposes of participating in the fruit and vegetable incentives program.

Other Federal and State Agencies that Regulate this Subject and the Process Coordinating the Rule with These Agencies: Farmers market basic food incentives and grocery store basic food incentives are regulated by the United States Department of Agriculture's Food and Nutrition Services (USDA). The department will ensure that state rules will align with federal rules for these incentives. No further coordination between the department and USDA is necessary. The Washington state department of social and health services (DSHS) administers the supplemental nutrition assistance program, known in Washington state as basic food. The department will coordinate with DSHS via email, phone, [and] online meetings to ensure the fruit and vegetable incentives program rules are compliant with the basic food rules adopted by DSHS.

Subject of Possible Rule Making: Medical aid rules updates regarding rate setting for most professional health care services for injured workers. These updates may also impact rates for health care services provided to crime victims. WAC 296-20-135 Conversion factors, 296-23-220 Physical therapy rules, and 296-23-230 Occupational therapy rules.

Statutes Authorizing the Agency to Adopt Rules on this Subject: RCW 51.04.020 and 51.04.030.

Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: The affected rules describe elements used in the process of updating the maximum allowable payments for most professional health care services. These elements are set in rule in order to follow the established methodologies of the department of labor and industries (L&I) and maintain consistency with the health care authority and medicaid purchasing administration. Specifically, the proposed rule changes will do the following:

1. WAC 296-20-135: Update the conversion factors used by L&I for calculating reimbursement rates for most professional health care and anesthesia services. The conversion factors will be updated to correspond to changes in the medical procedure codes, the relative value units, and anesthesia base units. These changes will enable L&I to continue a reimbursement methodology consistent with other state agencies. Cost-of-living adjustments may be incorporated into the changes in the conversion factors.

2. WAC 296-23-220 and 296-23-230: Update the maximum daily reimbursement level for physical and occupational therapy services so L&I may, if necessary, give cost-of-living adjustments to affected providers.

Process for Developing New Rule: L&I notifies external stakeholders through the GovDelivery system on updates to conversion factors and to the physical and occupational therapy maximum daily reimbursement level. L&I coordinates these updates with the health care authority, the medicaid purchasing administration and the Centers for Medicare and Medicaid Services to insure [ensure] consistent health care purchasing policies when possible.
